The proposed site is located at Khasra No.-503, Village-Rabadiya, Tehsil-Tonk Khurd, District-Dewas (MP)in 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. . Concerned Mining Officer vides letter no. 974 dated: 16/6/15, has reported that there is 03 more mines operating or proposed within 500 meters around the said mine and Total Area-7.90 ha.

After deliberations committee observed that this is an existing mine and same facts are not shown in the surface plan hence the case cannot be appraised in the absence of above fact. PP was asked to get the revised surface plan duly approved by the mining department within 30 days.

This is a case of mining of Stone Quarry . The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-205, Village- Dhalput, Tehsil-Suvasara, District-Mandsaur (MP) in 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no. 907 dated: 15/6/15, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

Dates of issue of Tehsildar certificate as submitted by PP are not clear. Thus PP should submit fresh Tehdildar certificate.

After deliberations committee observed that this is an existing mine and same facts are not shown in the surface plan hence the case cannot be appraised in the absence of above fact. PP was asked to get the revised surface plan duly approved by the mining department within 30 days.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite

information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 1151 dated: 03/7/15, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and Total Area-7.00 ha.

After deliberations committee observed that this is an existing mine and same facts are not shown in the surface plan. PP was asked to get the revised surface plan duly approved by the mining department within 30 days.

18. <u>Case No. 3361/15 Shri Malkhan Singh Rajput S/o Shri Sangram Singh Rajput,</u> Ward No. 1, Khedipura, Town & Tehsil-Khirkiya, District-Harda (MP). Prior Environment Clearance for approval of Stone Quarry in an area of 3.954 ha. (20,580 cum/year) at Khasra No.-507/1, Village-Choukdi, Tehsil-Khirkiya, District-Harda (MP).

This is a case of mining of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-507/1, Village-Choukdi, Tehsil-Khirkiya, District-Harda (MP) in 3.954 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. Q dated:29/5/15, has reported that there is 04 more mines operating or proposed within 500 meters around the said mine and Total Area-14.997 ha.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure $\frac{2}{2}A\alpha$

1. Production of stone boulder shall be as per the approved mining plan not exceeding 20,850 cum / Year.

After deliberations committee observed that co-ordinates are not mentioned either in mine plan or in other documents such as EMP/PFR. and thus location specific appraisal for EC is not possible in this case. Hence PP was asked to submit co-ordinates duly approved by the competent authority for appraisal within 15 days.

The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. .

Concerned Mining Officer vide letter no. 1261, dated:03/8/15, has reported that there is 03 more mines operating or proposed within 1000 meters around the said mine and Total Area-12.00 ha.

After deliberations committee observed that name of the river on which mining lease is sanctioned is not mentioned in mining plan. PP was asked to get the same amended and duly authenticated by the mining department within 15 days.

21. <u>Case No.-3312/2015 Shri Babu Lal Bijapari S/o Shri Munna Lal Bijapari,</u> <u>Malwa Vanaspati, Bhageerath Pura, Town & District-Agar Malwa (MP)-</u> <u>465230. Prior Environment Clearance for approval of Stone Quarry in an area</u> <u>of 2.00 ha. (5,880 cum/year) at Khasra No.-283, Village-Nanyakhedi, Tehsil-</u> <u>Agar, District-Agar (MP).</u>

This is a case of mining of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-283, Village-Nanyakhedi, Tehsil-Agar, District-Agar (MP) in 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no. 152 dated: 13/5/15, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and total Area-5.00 ha. including this mine.

After deliberations committee observed that surface plan needs to be resubmitted as ites an existing mine and the features such as already mined pits etc are not mentioned in surface plan. PP was asked to get the same amended and duly authenticated by the mining department within 30 days.

Capacity-</u> <u>Cum/Year.</u> This is a case of mining of Basalt Stone Quarry . The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.- 91/1/1/KA, at Vill.-Badavda, Th.--Jawra, Dist-Ratlam (M.P.) Capacity- Cum/Year. in **2**.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the DFO. Concerned Mining Officer vides letter no. 550 dated: 25/9/15, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and Total Area-6.00ha.

After deliberations committee observed it was observed that the certificate issued by Tehsildar was not clear. The PP is therefore required to submit fresh certificate within 15 days.

23. <u>Case No.- 2860/2015 Shri Harbhajan Singh Bhatiya S/o Shri Darshan Singh</u> <u>Bhatiya, Paharsinghpura, Distt. - Khargone (MP)-451001. Khedikhanpur</u> <u>Stone Quarry Lease Area- 1.00 ha., Capacity - 5,820 cum/year, at Khasra</u> <u>No.- 90, Village-Khedikhanpur, Tehsil-Goganwa, District-Khargone (MP).</u>

This is a case of mining of Khedikhanpur Stone Quarry . The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.- 90, Village-Khedikhanpur, Tehsil-Goganwa, District-Khargone (MP) in 1.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 1363 dated: 16/2/15 has reported that there is 02 more mines operating or proposed within 500 meters around the said mine and Total Area-3.817ha.

After deliberations committee observed that the shape of mining lease area does not allows environmentally safe and sustainable mining. Hence the case is not recommended for EC.

24. <u>Case No. – 3155/2015 Shri Subhas Chandra Jain, 100, Subhash Nagar,</u> <u>Ratlam (M.P.)-457001. Stone Quarry Lease Area – 1.50 Capacity - 6,840</u> <u>cum/year) at Khasra No.-136/1/1/1, Village-Banjal, Tehsil-Ratlam, Dist-</u> <u>Ratlam (M.P.).</u>

This is a case of mining of Stone Quarry . The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-136/1/1/1, Village-Banjal, Tehsil-Ratlam, Dist-Ratlam (M.P.) in 1.50 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. . Concerned Mining Officer vide letter no. 495 dated: 30/06/15 has reported that there is 17 more mines operating or proposed within 500 meters around the said mine and Total Area-16.30ha.

After deliberations committee observed that:-

- 1. This is an existing mine and same facts are not shown in the surface plan.
- 2. 7.5 meter safety buffer zone is not left in the approved mine plan.
- 3. Presence of schedule animal in the approved mine plan.

With the above discrepancies, appraisal is not possible hence case may be sent back to SEIAA for delisted.

25. <u>Case No. 3362/15 Shri Komal Singh S/o Shri Bheem Singh, 445, D-Kalpana Nagar, Raisen Road, Bhopal (MP)-462036. Prior Environment Clearance for approval of Stone Quarry in an area of 0.750 ha. (8,320 cum/year) at Khasra No.-802, Village-Jhirniya, Tehsil-Huzur, District-Bhopal (MP).</u>

This is a case of mining of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-802, Village-Jhirniya, Tehsil-Huzur, District-Bhopal (MP)in 0.750 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. . Concerned Mining Officer vide letter no. 1526 dated: 30/06/15 has reported that there is 02 more mines operating or proposed within 500 meters around the said mine and Total Area-4.808ha.

After deliberations, it was observed that there are human settlements nearby. In addition a ware house like construction could be seen in close vicinity of project site. It was therefore decided to carryout site visit.

Following standard conditions shall be applicable for the mining projects of minor mineral in addition to the specific conditions:

Standard conditions applicable to Stone/Murrum and Soil quarries:

- 1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- 2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
- 3. Transportation of material shall be done in covered vehicles.
- 4. Necessary consents shall be obtained from MPPCB and the air/water pollution control measures have to be installed as per the recommendation of MPPCB.
- 5. Curtaining of site shall be done using appropriate media.
- 6. The proposed plantation should be carried out along with the mining @45 trees per hectare and PP would maintain the plants for five years including casualty replacement.
- 7. Transportation shall not be carried out through forest area.
- 8. Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.
- 9. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
- 10. The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product mix in proposed mining unit shall require a fresh Environment Clearance.

Standard conditions applicable for the sand Mine Quarries*

- 1. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- 2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
- 3. Plantation shall be carried out on the banks for stabilization of the banks.
- 4. The mining activity shall be done manually.
- 5. Heavy vehicles shall not be allowed on the banks for loading of sand.
- 6. The sand shall be transported by small trolleys up to the main transport vehicle.
- 7. Transport vehicles will be covered with taurpoline to minimize dust/sand particle emissions.
- 8. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
- 9. No Mining shall be carried out during Monsoon season.
- 10. The depth of mining shall be restricted to 3m or water level, whichever is less.
- 11. No in-stream mining shall be allowed.
- 12. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
- 13. Established water conveyance channels should not be relocated, straightened, or modified.
- 14. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
- 15. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
- 16. PP shall take Socio-economic activities in the region through the 'Gram Panchayat'.
- 17. EC will be valid for mine lease period subject to a ceiling of 5 years.
