

The 226<sup>th</sup> meeting of the State Expert Appraisal Committee (SEAC) was held on 18/09/2015 under the Chairmanship of Dr R.B. Lal for discussion on the query responses submitted by the PP and the projects / issues received from SEIAA. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

1. **Case No. 3577/15 Shri Maherwan Singh S/o Shri Shiv Singh, Village-Ganeshpura, Tehsil & District-Rajgarh (MP)-465693 Prior Environment Clearance for approval of Sand Quarry in an area of 18.774 ha. (15,000 cum/year) at Khasra No.-01, 158, Village-Ganeshpura, Tehsil-Rajgarh, District-Rajgarh (MP).**

This is a case of mining of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-01, 158, Village-Ganeshpura, Tehsil-Rajgarh, and District-Rajgarh (MP) in 18.774 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-293, dated:17/4/15, has reported that there is no more mines operating or proposed within 1000 meters around the said mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Bø

1. Production of Sand shall be as per the approved mining plan not exceeding 15,000 cum / Year.
2. There is a stop dam in ML area. Hence no mining is to be carryout up to a distance of 100 meters from the stop dam both upstream and downstream.

This is a case of mining of Murram Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-675/min2, Village-Bhesai, Tehsil-Vijaypur, District-Sheopur (MP) in 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. . Concerned Mining Officer vides letter no.-4871, dated: 30/7/15, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

Prior Environment Clearance for approval of Stone Quarry in an area of 1.619 ha. (16,800 cum/year) at Khasra No.-349, Village-Bartola, Tehsil-Pushprajgarh, District-Anuppur (MP)**

This is a case of mining of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-349, Village-Bartola, Tehsil- Pushprajgarh, District-Anuppur (MP) in 1.619 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1051, dated: 17/7/15, has reported that there is 01 more mine operating or proposed within 500 meters around the said mine and total Area is 2.428 ha. including this mine.

After deliberations it was observed that shape of khasra map attached with the mine plan is different than the surface plan and other plans attached with the approved mine plan. During presentation, PP informed that by mistake these papers are attached with the mine plan and they have got the revised mine plan approved with the competent authority. In the above context, the case is differed till the revised mine plan is received from the SEIAA.

**4. Case No. 3591/15 Shri Pawan Jain S/o Shri Nandan Jain R/o Village-Laxmipur, Tehsil-Sagar, District-Sagar (MP)-470002. Prior Environment Clearance for approval of Stone Quarry in an area of 2.00 ha. (8,820 cum/year) at Khasra No.-07, Village-Khejarabaag, Tehsil-Sagar, District-Sagar (MP)**

This is a case of mining of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-07, Village-Khejarabaag, Tehsil-Sagar, District-Sagar (MP) in 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. . Concerned Mining Officer vide letter no.838, dated:7/7/15, has reported that there is 11 more mines operating or proposed within 500 meters around the said mine and Total Area-20.80 ha. including this mine.

After deliberations committee observed that the location of crusher is in close proximity of the road thus PP should erect wind breaking wall of 3 meters height towards the road side.

It was also observed that it is an existing mine and same facts are not shown in surface plan. Thus PP was asked to submit revised surface plan duly approved by the mining department showing existing features of the site within 30 days.

This is a case of mining of Metal Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-22/1, at Village-Magarai, Tehsil-Buxwaha, District-Chhatarpur (M.P.) in 1.60 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-222 dated : 3/3/15, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and Total Area-3.860 ha. including this mine.

After deliberation and presentation it was also observed that it is an existing mine and same facts are not shown in surface plan. Thus PP was asked to submit revised surface plan showing existing features of the site within 30 days.

**6. Case No. – 2643/2015 Mr. Arun Agrawal, B-62, Paraspar Colony, Chuna Bhatti, Bhopal-462017 (M.P.). Prior Environment Clearance for proposed Residential Group Housing Project "Padam Heights" at Village-Raslakhedi, Tehsil-Huzur, District-Bhopal (MP). Building Project.**

This is a for proposed Residential Group Housing Project "Padam Heights" at Village-Raslakhedi, Tehsil-Huzur, District-Bhopal (MP).

The case was presented in 217<sup>th</sup>. SEAC meeting dated 23/08/15 where in it was observed that the project site is approx. 8.5 Km from the Van Vihar National Park (a Notified PA) Clearance from NBWL is therefore needed. A copy of the application made to the competent authority has to be submitted by the PP to SEAC for considering the case. It was decided to defer the case till receipt of the same. The PP has submitted the copy of application made for wild life clearance to the competent authority.

The project pertains to proposed Residential Group Housing Project "Padam Heights" at Village-Raslakhedi, Tehsil-Huzur, District-Bhopal (MP) under Category B-2, item 8 (a) of the schedule of the EIA Notification hence requires prior EC from SEIAA. Application for grant of EC was forwarded by SEIAA to SEAC for appraisal. The case was presented by the PP and their consultant in this meeting.

After deliberations, PP was asked to submit following information for appraisal:-

1. Copy of Joint Venture / Agreement made between the land owner and developer be submitted.
2. Revised water balance be submitted w.r.t. to reuse and recycled water details.
3. Commitment of PP for installation of Filter press machine for dewatering of sludge.
4. Commitment of PP for disposal of MSW and ETP sludge in MSW trenching ground.
5. MSW quantification be reassessed and submitted.
6. MSW storage area for 48 hours be marked on layout map and re submitted.
7. Provisions made for car parking needs enhancement. PP should submit revised car parking plan.
8. Green belt development plan along with detailed plantation scheme be re submitted clearly stating area reserved for green belt.
9. Area kept for EWS, STP and MSW storage duly marked on layout map should be re submitted.
10. It was also observed that documents sent to members are lacking many essential annexure such as Annexure No. 01,05,11,13 & 16. PP & the

consultant advised to take a note of this and in future complete set of documents should be provided to the members.

This is a case of mining of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-3697/3/2, Village-Mabaikhas, Tehsil-Tikamgarh, District-Tikamgarh (MP) in 2.937 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. . Concerned Mining Officer vide letter no.31 dated: 15/1/15, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and Total Area-5.937 ha. including this mine.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

**8. Case No. 3527/15 Shri O.G. Goyal, Executive Director & Nominated Owner, M/s Hira Power & Steels Ltd., 101-C, Parwani Complex, Civil Line, Raipur (CG)-492001. Prior Environment Clearance for approval of Sangam Dolomite Mine in an area of 4.98 ha. (1.84 Lakh TPA) at Khasra No.-82 & Part of 13, Village-Sangam, Tehsil-Sousar, District-Chhindwara (MP).**

It's a case of Dolomite Mine in an area of 4.98 ha. (1.84 Lakh TPA) at Khasra No.-82 & Part of 13, Village-Sangam, Tehsil-Sousar, District-Chhindwara (MP).

After deliberation and presentation it was also observed that it is an existing mine in which consent from the M. P. Pollution Control Board has been obtained and thus it was decided that:-

1. Compliance of consent condition duly verified by the competent authority obtained from the M. P. Pollution Control Board.
2. From the Google image as per the co-ordinates submitted by the PP, it was noticed that site is in very close proximity with two rivers Jam (approx. 80 meters) and Kanhan (approx. 400 meters) and confluence point of this rivers is approx 600 meters. Looking to the sensitivity of the area, it was decided to carryout site visit.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-A

1. Production of Stone shall be as per the approved mining plan not exceeding 14,550 cum / Year.

(Modernisation in production capacity from 20000 TOA to 1,57,500 TPA) at Khasra No.-161/7 (Part of 161/1), Village-Simariya, Tehsil-Kareli, District-Narsinghpur (MP).**

This is a case of mining of Limestone Mine. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-161/7 (Part of 161/1), Village-Simariya, Tehsil-Kareli, District-Narsinghpur (MP) in 3.19 ha. The project requires prior EC before commencement of any activity at site.

No crusher is proposed within ML area.

After presentation and deliberations it was observed from the Google image as per the co-ordinates provided by the PP Benisagar Lake is in close proximity of ML

areas and this issue is not addressed in the EMP. Thus PP was asked to submit revised EMP within 30 days time.

This is a case of mining of Murum Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-378/1, Village-Basahari, Tehsil-Khurai, District-Sagar (MP) in 1.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. . Concerned Mining Officer vide letter no.870, dated:10/7/15, has reported that there is 06 more mines operating or proposed within 500 meters around the said mine and Total Area-16.50 ha.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

1. Production of Murram not exceeding 8,910 m<sup>3</sup>/Year as per mine plan.

Prior Environment Clearance for approval of Stone Quarry in an area of 1.840 ha. (11,010 cum/year) at Khasra No -488/1, Village-Atari Khejda, Tehsil-Gulabganj, District-Vidisha (MP)**

This is a case of mining of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No -488/1,

Village-Atari Khejda, Tehsil-Gulabganj, District-Vidisha (MP) in 1.840 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the DFO. Concerned Mining Officer vide letter no.-1064, dated: 28/5/15, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

PP could not attend the meeting and his place another person came for the presentation without proper authorization. PP has either to be present himself or send a person with due authorization in subsequent meeting for appraisal with prior request to SEAC.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. . Concerned Mining Officer vide letter no.-928, dated:18/6/15, has reported that there is 04 more mines operating or proposed within 500 meters around the said mine and Total Area-9.759 ha. including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production of Stone not exceeding 17,140 m<sup>3</sup>/Year as per mine plan.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-Aø

1. Production of Stone not exceeding 11,760 m<sup>3</sup>/Year as per mine plan.

25. **Case No. 3446/15 Shri Tejindarpal Singh, Leasee, M/s Digiyana Industries Pvt. Ltd., G-1, Sapna Chamber, South Tukoganj, Indore (MP)-452001 . Prior Environment Clearance for Sand Quarry in an area of 6.00 ha. (1,10,000 cum/year) at Khasra No.-01, Village-Veera, Tehsil-Ajaygarh, Dist-Panna (MP)**

This is a case of mining of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-01, Village-Veera, Tehsil-Ajaygarh, Dist-Panna (MP) in 6.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. . Concerned Mining Officer vide letter no.1150, dated:26/6/15, has reported that there is no more mines operating or proposed within 1000 meters around the said mine .

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

Prior Environment Clearance for Sand Quarry in an area of 7.00 ha. (1,20,000 cum/year) at Khasra No.-01, Village-Veera, Tehsil-Ajaygarh, Dist-Panna (MP)**

This is a case of mining of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-01, Village-Veera, Tehsil-Ajaygarh, Dist-Panna (MP) in 7.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. . Concerned Mining Officer vide letter no.-1152, dated:26/6/15, has reported that there is no more mines operating or proposed within 500 meters around the said mine .

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

Following standard conditions shall be applicable for the mining projects of minor mineral in addition to the specific conditions:

**Annexure- 'A'**

**Standard conditions applicable to Stone/Murrum and Soil quarries:**

1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
3. Transportation of material shall be done in covered vehicles.
4. Necessary consents shall be obtained from MPPCB and the air/water pollution control measures have to be installed as per the recommendation of MPPCB.
5. Curtaining of site shall be done using appropriate media.
6. The proposed plantation should be carried out along with the mining @45 trees per hectare and PP would maintain the plants for five years including casualty replacement.
7. Transportation shall not be carried out through forest area.
8. Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.
9. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
10. The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product - mix in proposed mining unit shall require a fresh Environment Clearance.

**Annexure- 'B'**

**Standard conditions applicable for the sand Mine Quarries\***

1. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
3. Plantation shall be carried out on the banks for stabilization of the banks.
4. The mining activity shall be done manually.
5. Heavy vehicles shall not be allowed on the banks for loading of sand.
6. The sand shall be transported by small trolleys up to the main transport vehicle.
7. Transport vehicles will be covered with tarpauline to minimize dust/sand particle emissions.
8. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
9. No Mining shall be carried out during Monsoon season.
10. The depth of mining shall be restricted to 3m or water level, whichever is less.
11. No in-stream mining shall be allowed.
12. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
13. Established water conveyance channels should not be relocated, straightened, or modified.
14. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
15. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
16. PP shall take Socio-economic activities in the region through the 'Gram Panchayat'.
17. EC will be valid for mine lease period subject to a ceiling of 5 years.
