

The 233<sup>rd</sup> meeting of the State Expert Appraisal Committee (SEAC) was held on 29<sup>th</sup> October, 2015 under the Chairmanship of Dr. R. B. Lal for discussion on the projects / issues received from SEIAA. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

This is case of **Sand Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-01, Vill.-Veera, Teh.-Ajaygarh, Dist-Panna (MP) 6.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-1150, dated: 25/06/2015, has reported that there is no more mines operating or proposed within 1000 meters around the said mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -B

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.836, dated: 02/05/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine .

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-A

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.838, dated: 02/05/2015, has reported that

there is 01 more mine operating or proposed within 500 meters around the said mine and total area-4.980ha including this mine.

The case was presented by the PP and their consultant and during deliberations it was observed that the forest area reported to be only 47 meters away from the ML area for which concerned DFO vide letter no. 1470 dated 13/04/15 has not recommended the case. PP was asked to get the approval from the committee constituted under the chairmanship of Divisional Commissioner.

Concerned Mining Officer vides letter no.-1154, dated: 25/05/2015, has reported that there is no more mines operating or proposed within 1000 meters around the said mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Bø

- Production of Sand not exceeding 1, 20,000 cum/year as per mine plan.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-A

- Production of Stone not exceeding 10,120 cum/year as per mine plan.
- Being the site is in close proximity of FCI Warehouse (about 400 meters) and Village road (about 370 meters) the installation of crusher is not recommended in the ML area.

Concerned Mining Officer vides letter no.-460, dated: 22/05/2015, has reported that there is 08 more mines operating or proposed within 500 meters around the said mine and Total Area-18.80 ha.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-A

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.716, dated: 23/06/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine .

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -B

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1017, dated: 03/08/2015, has reported that there is 04 more mines operating or proposed within 500 meters around the said mine and Total Area-16.25 ha.

The case was presented by the PP and their consultant and during deliberations it was observed that the forest area reported to be 250 meters away from the ML area for which concerned DFO vide letter no. 1465 dated 13/04/15 has not recommended the case. PP was asked to get the approval from the committee constituted under the chairmanship of Divisional Commissioner.

The case was presented by the PP and after deliberation it was decided that since site visit is proposed in the cases of all the mines falling in Billaua Cluster. This case may also be taken after the recommendations of site visit.

- Depth restriction of 09 meters as the shape of ML area is awkward.
- Nagod - Kalingar road is about 150 meter from then project site thus thick belt of plantation be carryout towards road side.

After presentation by the PP and deliberations, it was observed that submitted surface plan is not approved by the mining department and existing features are also not mentioned in surface plan. Even the co-ordinates are mismatching when compared with mine plan and DFO certificate. In view of so many discrepancies the case is not recommended for grant of EC.
