The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-901/1, 901/2, Vill.-Bathiya, Teh.-Maihar, District-Satna (MP) 2.00Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. All the mines of above cluster after their individual valid application in SEIAA & presentation in SEAC for TOR can conduct regional EIA but their EMP should be site specific and will be considered on case to case basis.
