

The 235<sup>th</sup> meeting of the State Expert Appraisal Committee (SEAC) was held on 31<sup>th</sup> October, 2015 under the Chairmanship of Dr. R. B. Lal for discussion on the projects / issues received from SEIAA. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

**1. Case No. 3603/15 Mr. Tarun Chowksey S/o Shri Uttamchand Chowksey R/o Lalbag, Burhanpur, District-Burhanpur (MP)-450331. Prior Environment Clearance for approval of Crusher Stone Deposit in an area of 2.00 ha. (19,950 cum/year) at Khasra No.-12, Vill.-Dongargawan, Teh.-Burhanpur, District-Burhanpur (MP)**

This is case of **Crusher Stone Deposit**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-12, Vill.-Dongargawan, Teh.-Burhanpur, District-Burhanpur (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-4416, dated-02/07/2015, has reported that there is 04 more mines operating or proposed within 500 meters around the said mine and total area-8.68 ha including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-A

- Production of Stone not exceeding 19,950 cum/year as per mine plan.
- Being the site is in close proximity of State highway (about 125 meters) thus wind breaking wall of 03 meter height of suitable material be erected towards the village site.

The proposed site is located at Khasra No.-33/1, 33 at Vill.-Ghodadungari, Th.- Ghodadungari,Distt-Betul(M.P.) 1.50 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-584, dated: 07/05/2015, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and Total Area-1.90 ha including this mine. Crusher is out side of the ML area.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-A

- Production of **Stone & Murram** not exceeding Stone-30,000cum/year & Murram-2550 cum/year as per mine plan.
- A Natural drain is in vicinity (approx. 1000 meters) of ML area thus garland drains with settling tank of suitable capacity be provided.
- Thick plantation should also be carried out towards water body.

Concerned Mining Officer vide letter no.-2196, dated: 17/09/2014, has reported that there is 04 more mines operating or proposed within 500 meters around the said mine and total area-15.292 ha including this mine.

Case was presented by PP and their consultant. During presentation, based on the Google image, it was observed that the site is within 10 Km radius of Van Vihar National Park (a Notified PA) Clearance from NBWL is therefore needed. However, DFO in his certificate has not indicated it. Thus it was decided to write by SEAC to Chief Conservator of Forest, Bhopal for confirmation of NOC issued by the DFO by SEAC.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-434, dated 15/07/2015, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and total area-4.00 ha including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A
