

The 237<sup>th</sup> meeting of the State Expert Appraisal Committee (SEAC) was held on 02<sup>th</sup> November, 2015 under the Chairmanship of Dr. R. B. Lal for discussion on the the projects / issues received from SEIAA. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

**1. Case No. 3642/15 Smt. Pushpa Jain W/o Shri Pankaj Jain, Prop., M/s Shri Ganesh Stone Crusher R/o Jawahar Marg, Nagda, Tehsil-Nagda, District-Ujjain. Prior Environment Clearance for approval of Stone Quarry in an area of 1.00 ha. (3,325 cum/year) at Khasra No.-518/3, Village-Jhanjhakhedi, Tehsil-Nagda, District-Ujjain (MP)**

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-518/3, Village-Jhanjhakhedi, Tehsil-Nagda, District-Ujjain (MP) 1.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.1847, dated: 10/07/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

Thus it was decided to defer the case till receipt of the same.

Concerned Mining Officer vides letter no.-232, dated: 17/06/2015, has reported that there are 02 more mines operating or proposed within 500 meters around the said mine and total area-23.139 ha including this mine.

The case was presented by the PP and their consultant. During deliberations it was observed that a natural drain and village namely öSumerpadaö are in close vicinity of ML area. As the quantity is very high and cumulative area is off 23.139 ha, committee decided to issue standard TOR as prescribed by the MoEF&CC along with the evacuation plan which should be discussed in the EIA. As requested by the PP and their consultant, the data already collected can be used in the EIA report.
