

The 238th meeting of the State Expert Appraisal Committee (SEAC) was held on 03th November, 2015 under the Chairmanship of DR. R. B. Lal for discussion on the query responses submitted by the PP and the projects / issues received from SEIAA. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

1. Case No. 3665/15 Shri S.K. Singh, Director, M/s Chandrika Mines & Minerals, Windsor Hills, Quarter No. C-3/22, Sirod Road City Centre-1, Gwalior (MP). Prior Environment Clearance for approval of Metal Stone Quarry in an area of 3.820 ha. (1,19,700 cum/year) at Khasra No. 1255, 1258, Village-Badaura Kalan, Tehsil-Gaurihar, District-Chhatarpur (MP).

This is case of **Metal Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 1255, 1258, Village-Badaura Kalan, Tehsil-Gaurihar, District-Chhatarpur (MP) 3.820 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-824, dated: 16/07/2015, has reported that there is 03 more mines operating or proposed within 500 meters around the said mine and total area-9.851 ha including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-A

1. Production of **Metal Stone** not exceeding 1, 19,700 cum/year as per mine plan.

2. A Natural drain is in vicinity (approx. 300 meters) of ML area thus Garland drains with settling tank of suitable capacity be provided.
3. Thick plantation should also be carried out towards water body.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production of **Stone** not exceeding 8,550 cum/year as per mine plan.
2. A warehouse is in close vicinity of ML area, thus PP should erect a barrier wall of 03 meter height of suitable material.
3. Thick plantation should also be carried out towards NH 79 which is about 480 meters away.

Concerned Mining Officer vides letter no.-1071, dated: 09/07/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine .

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production of **Stone** not exceeding 8,672 cum/year as per mine plan.
2. A village road is approx at a distance of 40 meters. Thus PP should erect a barrier wall of 03 meter height of suitable material.

4. Case No. 3670/15 Smt. The proposed site is located at Khasra No. 471 at Village-Bilantri, Tehsil-Mandsaur, District-Mandsaur (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-1156, dated: 29/06/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine .

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production of **Basalt Stone & Murram** not exceeding Murram-2565 & Basalt Stone-27,360 cum/year as per mine plan.
2. A village road is approx at a distance of 70 meters. Thus PP should erect a barrier wall of 03 meter height of suitable material.
3. Thick plantation should also be carried out towards state Highway which is about 300 meters away.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1990, dated: 24/07/2015, has reported that there is 07 more mines operating or proposed within 500 meters around the said mine and total area-22.9 ha including this mine.

After deliberation and scrutiny of documents, it was observed that post mining land use area is mentioned as 0.00 ha and thus EMP needs correction. Thus PP was asked to submit revised EMP within 15 days time.

The proposed site is located at Khasra No. 5/2, 85/438 at Village-Pipliyapanth, Tehsil-Malhargarh, District-Mandsaur (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1040, dated: 07/07/2015, has reported that there is 05 more mines operating or proposed within 500 meters around the said mine and total area-12.00 ha including this mine.

During scrutiny of documents it was observed that presence of scheduled animals is mentioned in the mine plan submitted by the PP. However, PP vides DFO's letter no. 2617 dated 09/06/2015 has submitted the clarification.

The case was presented by the PP and their consultant and during deliberations; it was observed that the safety barrier of 7.5 meters has not been left in the plan submitted with the application. Thus as above, PP was asked to submit revised plans duly authenticated by the mining department.

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 271 at Village-Karnali Jagir, Tehsil-Sitamau, District-Mandsaur (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer

vides letter no.-1070, dated: 09/07/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine. No crusher is proposed in ML area.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

1. Production of **Stone** not exceeding 29,712 cum/year as per mine plan.
2. A Natural drain is in vicinity (approx. 200 meters) of ML area thus Garland drains with settling tank of suitable capacity be provided.

This is case of **Sand Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 403 at Village-Bhagori, Tehsil-Jirapur, District-Rajgarh (MP) 18.163 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.480, dated: 06/06/2015, has reported that there is no more mines operating or proposed within 1000 meters around the said mine.

The case was presented by the PP. During the scrutiny of document, it was reviled that the submitted revised mine plan is not in the name of PP. Thus PP was asked to submit the revised mine plan through SEIAA in his name.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1029, dated: 29/06/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A.

1. Production of **Stone** not exceeding 10,773 cum/year as per mine plan.

Concerned Mining Officer vide letter no.-1741, dated: 17/07/2015, has reported that there is 05 more mines operating or proposed within 500 meters around the said mine and total area-9.45 ha including this mine.

Case was presented by PP and their consultant. During presentation and deliberations, it was observed that the site is within 10 Km radius of Van Vihar National Park (a Notified

PA). Clearance from NBWL is therefore needed. However, there is no mention of any PA within 10 kms distance as per the certificate issued by the DFO. Thus it was decided to write by SEAC to Chief Conservator of Forest, Bhopal for confirmation of NOC issued by the DFO.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-615, dated: 10/06/2015, has reported that there is 04 more mines operating or proposed within 500 meters around the said mine and total area-4.73 ha including this mine.

The case was presented by the PP and their consultant. During presentation it was observed that co-ordinates mentioned in mine plan are not matching the exact location of mine site. PP informed during presentation that co-ordinates are wrongly mentioned in the mine plan and needs revision. Thus the case is deferred till the submission of revised mine plan through SEIAA.
