

The 239th meeting of the State Expert Appraisal Committee (SEAC) was held on 04th November, 2015 under the Chairmanship of DR. R. B. Lal for discussion on the query responses submitted by the PP and the projects / issues received from SEIAA. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

1. Case No. 3692/15 Shri Rajesh Kedia R/o Amarkantak Road, Ward No. 14, Anuppur, District-Anuppur (MP)-484334. Prior Environment Clearance for approval of Stone Quarry in an area of 2.00 ha. (15,067 cum/year) at Khasra No. 2635 at Village-Chhilpa, Tehsil-Anuppur, District-Anuppur (MP).

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 2635 at Village-Chhilpa, Tehsil-Anuppur, District-Anuppur (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-478, dated: 08/04/2015, has reported that there is no more mine operating or proposed within 500 meters around the said mine.

The case was presented by the PP and their consultant and during presentation it was onserved that a natural darin is approx 300 meters away from the site for which garland drain with settling pit of suitable capacity should be provided by the PP.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable but during presentation it was observed that surface plan/other plans attached with the mine plan are not approved by the mining department. Thus PP was asked to submit surface plan duly appotved by the mining officer.

2. Case No. 3693/15 Shri NiteshGoyanka R/o Village & Post-Bijuri, Tehsil-Kotma, District-Anuppur (MP)-484440. Prior Environment Clearance for approval of Stone Quarry in an area of 2.023 ha. (15,064 cum/year) at Khasra No. 973 at Village-Deogawan, Tehsil-Kotma, District-Anuppur (MP).

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 973 at Village-Deogawan, Tehsil-Kotma, District-Anuppur (MP) 2.023 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-476, dated: 08/04/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

The case was presented by the PP and their consultant and during presentation it was observed that a natural drain a water body are approx 120 and 750 meters away respectively from the site for which garland drain with settling pit of suitable capacity should be provided by the PP.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable but during presentation it was observed that surface plan/other plans attached with the mine plan are not approved by the mining department. Thus PP was asked to submit surface plan duly approved by the mining officer.

3. Case No. 3694/15 Shri Nand Kishore Malviya, S/o Shri SakharamMalviya, Dedtalai Tehsil – KhaknarDistt. Burhandpur. Prior Environment Clearance for approval of Stone Quarry in an area of 2.0 ha. (14,250 cum/year) at Khasra No. 116 at Village-Dedtalai, Tehsil-Khaknar, District-Burhanpur (MP).

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 116 at Village-Dedtalai, Tehsil-

Khaknar, District-Burhanpur (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-4481, dated: 03/07/2015, has reported that there is 02 more mines operating or proposed within 500 meters around the said mine and total area-4.70 ha including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

1. Production of **Stonenot** exceeding 14,250 cum/year as per mine plan.
2. A Natural drain is in vicinity (approx. 90 meters) of ML area thus Garland drains with settling tank of suitable capacity be provided.
3. Thick plantation should also be carried out towards water body.

4. Case No. 3696/15 Shri Rahul Bhargava S/o Shri Rajendra Bhargava R/o Bhagat Singh Ward, Garhakota, District-Sagar (MP)-470226. Prior Environment Clearance for approval of Stone Quarry in an area of 3.80 ha. (8,000 cum/year) at Khasra No. 69 at Village-Markhera, Tehsil-Deori, District-Sagar (MP).

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 69 at Village-Markhera, Tehsil-Deori, District-Sagar (MP) 3.80 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-981, dated: 30/09/2015, has reported that there is no more mine operating or proposed within 500 meters around the said mine.

The case was presented by the PP and their consultant and during presentation it was onserved that a natural drain and a river (approx 115 and 400 meters respectively) are in

close proximity of ML area but these issues are not addressed properly in the EMP. Thus PP was asked to submit revised EMP addressing above issues with their protection plan.

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 319/2 at Village-Ramgarhi, Tehsil-Chhindwara, District-Chhindwara (MP) 1.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1715, dated: 30/07/2015, has reported that there is 01 more mine operating or proposed within 500 meters around the said mine and total area-3.00 ha including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

1. Production of **Stone** not exceeding 5,700 cum/year as per mine plan.
2. State Highway 626 (Chhindwara-Seoni) is about 400 meters from the ML area, thus additional row of plantation be carried out towards State Highway.

6. Case No. 3700/15 Shri Deepak Gurjar S/o Shri Kaalu Singh Gurjar R/o Village-Sejwani, Tehsil-Depalpur, District-Indore (MP)-452007. PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-899, dated: 23/07/2015, has reported that there are 03 more mines operating or proposed within 500 meters around the said mine and total area-8.734 ha including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production not exceeding for Murram-3,976 cum/year & Basalt Stone-11,000 cum/year as per mine plan.

7. Case No. 3701/15 Shri ShyamDubey S/o Late Shri Ramesh Dubey R/o A-28, Sukhliya Indore, District-Indore (MP)-452006. The proposed site is located at Khasra No. 62/1/2 at Village-Rangwasa, Tehsil-Depalpur, District-Indore (MP) 1.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-506, dated: 29/04/2015, has reported that there are 05 more mines operating or proposed within 500 meters around the said mine and total area-19.1 ha including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production not exceeding for Murram-5,673 cum/year & Basalt Stone-11,347 cum/year as per mine plan.

8. Case No. 3702/15 Shri Rajesh Malviya S/o Shri Tilokchand Malviya R/o Gram-Dedtalai, Tehsil-Khaknar, District-Burhanpur (MP)-450331. PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-4404, dated: 01/07/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure A

1. Production of **Stone** not exceeding 8550 cum/year as per mine plan.
2. No mining be carried out towards North-East side and this area should exclusively be used for plantation only.

The proposed site is located at Khasra No. 263/1/2 at Village-Sejwani, Tehsil-Depalpur, District-Indore (MP) 1.214 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-901, dated: 23/07/2015, has reported that there is 02 more mines operating or proposed within 500 meters around the said mine and total area-5.064 ha including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production not exceeding for Murram-1,640 cum/year & Basalt Stone-8,199 cum/year as per mine plan.

10. Case No. 3705/15 Shri Govind Singh Yadav S/o Shri Sohan Singh Yadav, Resi-C-55, Padamnabh Nagar, Raisen Road, Bhopal, District-Bhopal (MP)-466001. This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra no.-192, 193, Village-Chhapri, Tehsil-Huzur, District-Bhopal (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1543, dated: 02/07/2015, has reported that there are 02 more mines operating or proposed within 500 meters around the said mine and total area-7.214 ha including this mine.

Case was presented by PP and their consultant. During presentation and deliberations, it was observed that the site is within 10 Km radius of Van Vihar National Park (a Notified PA). Clearance from NBWL is therefore needed. However, there is no mention of any PA within 10 kms distance as per the certificate issued by the DFO. Thus it was decided to

write by SEAC to Chief Conservator of Forest, Bhopal for confirmation of NOC issued by the DFO.

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.- Part of 21/3, Village-Tipakhedi, Tehsil-Ashta, District-Sehore (MP) 1.50 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-2319, dated: 13/07/2015, has reported that there are 06 more mines operating or proposed within 500 meters around the said mine and total area-10.50 ha including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production of **Stone** not exceeding 5,292 cum/year as per mine plan.

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.- Part of 270, Village-Malikhedi, Tehsil-Huzur, District-Bhopal (MP) 4.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1796, dated: 24/07/2015, has reported that there are 04 more mines operating or proposed within 500 meters around the said mine and total area-17.30 ha including this mine.

Case was presented by PP and their consultant. During presentation and deliberations, it was observed that the site is within 10 Km radius of Van Vihar National Park (a Notified PA). Clearance from NBWL is therefore needed. However, there is no mention of any PA within 10 kms distance as per the certificate issued by the DFO. Thus it was decided to write by SEAC to Chief Conservator of Forest, Bhopal for confirmation of NOC issued by the DFO.

This is case of **Sand Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-01, Village-Chakrod, Tehsil-Pachore, District-Rajgarh (MP) 17.743 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-300, dated-17/04/2015, has reported that there is no more mines operating or proposed within 1000 meters around the said mine.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

This is case of **Flag Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 51, at at Village-Bachon, Tehsil-Pawai, District-Panna (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1083, dated: 16/06/2015, has reported that there are 03 more mines operating or proposed within 500 meters around the said mine and total area-6.50 ha including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production of **Flag Stone** not exceeding 12,000 cum/year as per mine plan.
2. A village road is about 300 meters from the ML area, thus additional row of plantation be carried out towards road side.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

3. A water body is in vicinity (approx. 300 meters) of ML area thus additional row of plantation be carried out towards that side.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1210, dated: 31/07/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

It was also found that surface plan/other plans attached with the mine plan are not approved by the mining department. Thus PP was asked to submit surface plan duly approved by the mining officer.

20. Case No. 3719/15 Shri Sanjeev Agarwal, Partner, M/s Balaji Developers, 205, City Centre, MG Road, District-Indore (MP)-452003. Prior Environment Clearance for approval of Sand Quarry in an area of 22.50 ha. (5,62,500 cum/year) at Village-Maroda, Tehsil-Itarsi, District-Hoshangabad (MP).

This is case of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra no.-01, at Village-Maroda, Tehsil-Itarsi, District-Hoshangabad (MP) 22.50 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-2769, dated: 11/07/2015, has reported that there are 02 more mines operating or proposed within 1000 meters around the said mine and total area is 45.00 ha including this mine.

As stated above, this was part of cluster but Executive Director, M.P. State Mining Corporation Ltd., Bhopal vide letter No.Rait/2015-16/1187 Bhopal dated 03/11/2015 which was forwarded by SEIAA vide letter no 7166/SEIAA/15, Bhopal dated 03/11/15 has informed that earlier there were two mines forming cluster of 45.00 ha (cluster no. 4 of Itarsi code-2) but one mine namely Maroda-2, khasra No. 1, measuring 22.500ha is not an operational cluster at present as this mine is not approved on tender also. PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1412, dated: 30/07/2015, has reported that there is 03 more mines operating or proposed within 500 meters around the said mine and total area is 5.94 ha including this mine.

During scrutiny of documents it was observed that surface plan/other plans attached with the mine plan are not approved by the mining department. Thus PP was asked to submit surface plan duly approved by the mining officer. PP was also asked to submit revised EMP with plantation scheme.

22. Case No. 3722/15 Shri Damodar Chourasiya, Village-Khamra, Tehsil-Bichua, District-Chhatarpur (MP). Prior Environment Clearance for approval of Stone Quarry in an area of 1.00 ha. (7,056 cum/year) at Village-Dongargan, Tehsil-Bichua, District-Chhindwara (MP).

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 128/1, 2, Village-Dongargan, Tehsil-Bichua, District-Chhindwara (MP) 1.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-1426, dated: 02/06/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

During scrutiny of documents it was observed that land use pattern after mining is mentioned as 1.995 ha in EMP while the lease area is of 1.00 ha only. Thus PP was asked to submit revised EMP.

23. Case No. 3723/15 Shri Ajmuddin R/o Village-Balsamand, Tehsil-Kasrawad, District-Khargone (MP)-451228. Prior Environment Clearance for approval of Stone Quarry in an area of 2.00 ha. (7,959 cum/year) at Village-Jaalanpur, Tehsil-Kasrawad, District-Khargone (MP).

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra no.-17, Village-Jaalanpur, Tehsil-Kasrawad, District-Khargone (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-23, dated: 08/07/2015, has reported that there are no more mines operating or proposed within 500 meters around the said mine.

The case was presented by the PP and their consultant. During presentation, it was observed that as per the Google image of April, 2014, based on the co-ordinates provided by the PP, the entire mining lease area is approx.100 meters away from the River Narmada and in rainy season (flood time) the ML area possibly be submerged with water and thus environmentally safe and sustainable mining is not possible at this location. Considering above facts, the EC is not recommended.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-388, dated: 22/06/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

It was also found that surface plan/other plans attached with the mine plan are not approved by the mining department. Thus PP was asked to submit surface plan duly approved by the mining officer.

25. Case No. 3725/15 Shri Keshav Prasad Awasthi, Village-Mohantola-Klhra, Tehsil-Vijraghvarh, District-Katni (MP)-483775. Prior Environment Clearance for approval of Metal Stone Quarry in an area of 3.39 ha. (Expansion in production

capacity from 60,000 to 75,387 cum/year) at Village-Bichpura, Tehsil-Barhi, District-Katni (MP).

This is case of **Metal Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 1032, at Village-Bichpura, Tehsil-Barhi, District-Katni (MP) 3.39 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-2484, dated: 07/07/2015, has reported that there is 07 more mines operating or proposed within 500 meters around the said mine and total area-18.20 ha.

The case was presented by the PP and their consultant. During presentation it was observed that this is an old mine and there is another mine adjacent to this mine (which is also scheduled for presentation today as case no. 3727/15). From the Google image as per the co-ordinates provided by the PP, it appears that sufficient measures for plantation and environmental conservation etc were not taken by the PP during the previous years operations. Thus PP was asked to submit cumulative EMP for both the leases (case no. 3725/15 & 3727/15) addressing above issue through QCI/NABET **accredited** consultant.

This is case of **Stone Boulder Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-21/2, at Village-Pipariya, Tehsil-Niwas, District-Mandla (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and SDO (forest). Concerned Mining Officer vides letter no.-855, dated: 19/8/2015, has reported that there is 01 more mines

operating or proposed within 500 meters around the said mine. However the total area is not mentioned in the certificate. However, the certificate issued by the Tehsildar dated 08/12/2014 states that the area of other mine in 500 meters is 1.00 ha and thus the cumulative area is 3.00 ha including this mine.

The case was presented by the PP and their consultant. During presentation, it was noticed that forest NOC is issued by the SDO (forest) while it should be issued by the DFO. PP was asked to get the requisite certificate from the DFO and certificate from the mining officer giving the total area of the mines situated in the 500 meters radius.

The proposed site is located at Khasra No. 1002, 1003, 1019, 1020, 1023, Village-Bichpura, Tehsil-Barhi, District-Katni (MP) 4.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-2485, dated: 07/07/2015, has reported that there is 08 more mines operating or proposed within 500 meters around the said mine and Total Area-21.20 ha.

The case was presented by the PP and their consultant. During presentation it was observed that this is an old mine and there is another mine adjacent to this mine (which is also scheduled for presentation today as case no. 3725/15). From the Google image as per the co-ordinates provided by the PP, it appears that sufficient measures for plantation and other environmental conservation etc were not taken by the PP during the previous years operations. Thus PP was asked to submit cumulative EMP for both the leases (case no. 3725/15 & 3727/15) addressing above issue through QCI/NABET **accredited** consultant.

The TOR was approved in the 109th SEAC meeting dated 06/11/2012 and the same was issued to the PP vide letter no. 35 dated 10/01/2013. The validity of TOR expired on 09/01/2015. PP vide their letter dated 03.09.15 has requested for TOR extention. After

deliberations, the committee recommends the case for extension in TOR for one year with validity up to 09/01/16.

The TOR was approved in the 126th SEAC meeting dated 10/04/2013 and the same was issued to the PP on dated 12/06/2013. The validity of TOR expired on 11/06/2015. PP vide their letter dated 05.10.15 has requested for TOR extension. After deliberations, the committee recommends the case for extension in TOR for one year with validity up to 11/06/16.

The cumulative lease area of all the mines including the proposed mine is 16.9 Ha (less than 25 Ha). PP has reported that the pit formed after mining shall be developed into a water body.

The case was discussed in 151st SEAC meeting dated 27/09/15 wherein after deliberations PP was asked to furnish a letter from Mining department verifying the facts on presence of other mines within 500 meters from the periphery of the proposed MLA. PP has submitted the desired information vide inward dated 30.07.15 enclosing the copy of mining officer letter dated 01/09/2014 stating cumulative lease area of 17.90 ha including this mine.

Response to the above queries was submitted by the PP and the same was placed before the committee. The submissions made by the PP were found to be satisfactory and acceptable. Thus committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-Aø

1. Production of Stone not exceeding 1,500 cum/year as per mine plan.

Response to the above queries was submitted by the PP and the same was placed before the committee. The submissions made by the PP were found to be satisfactory and acceptable.

Thus committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure ÷Aø.

After deliberations committee observed following discrepancies in the submissions:

- Mining Plan is lacking the provision of 7.5 meter mandatory buffer zone all around the periphery.
- Certificate from DFO in the prescribed format regarding distances of nearest forest boundary and the details of notified protected areas with in 10 km from the project site has not been furnished.

Hence it was decided to return the case to SEIAA for delisting till submission of the above information / documents.

Response to the above queries was submitted by the PP through SEIAA and the same was placed before the committee. The committee decided to call the PP for presentation in any of the forthcoming meetings of SEAC.

38. Case No. – 2735/2015 Shri Raghvendra Singh S/o Shri Meghraj Singh, C-28, Hanuman Nagar, Khatepura, Jaipur (RJ)-302012 Sand Quarry in an area of 8.00 ha. (2,35,000 cum/year) at Khasra No. – 01, Village-Chandoura, Tehsil-Ajaygarh, District-Panna (M.P.)

This is a case of mining of *Sand Quarry*. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 01, *Village-Chandoura, Tehsil-Ajaygarh, District-Panna* 8.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is not proposed in the lease area. Concerned Mining Officer vide letter no. 988, dated 27/05/15 has reported that there is no more mines operating or proposed within 500 meters around the said mine.

The case was discussed in the 211th SEAC meeting dated 06/08/2015 wherein after deliberations committee observed that from the Google image of the site it appears to very close to the M.P. & U.P. inter-state boundary. The distance of inter-state boundary is not clear from the Tehsildar certification. Hence the exact aerial distance of project boundary from the inter-state boundary to be furnished after due validation from competent authority.

Response to the above queries was submitted by the PP and the same was placed before the committee in which tehsildar's certificate is produced by the PP stating that the distance from the interstate boundary is 6.00 kms. The submissions made by the PP were found to be satisfactory and acceptable. Thus committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -B

1. Production of Sand not exceeding 2,35,000 cum/year as per mine plan.

39. Case No. – 2744/2015 Shri Raghvendra Singh S/o Shri Meghraj Singh, C-28, Hanuman Nagar, Khetpura, Jaipur (RJ)-302012 Sand Quarry Lease Area - 7.50 ha., Capacity -2,20,000 cum/year, at Khasra No. – 01, Village-Sunhara, Tehsil-Ajaygarh, District-Panna (MP)

This is a case of mining of *Sand Quarry*. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra No.-01, Village-Sunhara, Tehsil-Ajaygarh, District-Pannain 7.50 ha*. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is not proposed in the lease area. Concerned Mining Officer vide letter no. 985 dated 27/5/2015 has reported that there is no more mines operating or proposed within 1000 meters around the said mine.

The case was discussed in the 211th SEAC meeting dated 06/08/2015 wherein after deliberations committee observed that the targeted production of 220000 m³/Year may not be possible with the annual replenishment mentioned in the mining plan; the same requires review of the Mining Plan by the concerned authority and site-specific EMP has to be re-submitted, appropriately addressing ó Bank erosion consequences and prevention / repair plans, evacuation plan, protection of fauna/flora, protection/safety of habitation on the transport route etc.

Hence it was decided to return the case to SEIAA for delisting till submission of the above information / documents.

Response to the above queries was submitted by the PP through SEIAA and the same was placed before the committee. The committee decided to call the PP for presentation in any of the forthcoming meetings of SEAC.

40. Case No. – 2156/2014 Shri Jai Singh Parte, Owner, Khomai, Bhesdehi, Betul (MP)
Basalt Stone Quarry Lease Area – 1.00 ha. atKhasra No. -49. Capacity - 5700
Cum/Year, Village-Nimbhoura, Tehsil-Bhesdehi, District-Betul (MP)

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Earlier also PP was absent when the case was placed in the 170th meeting. However, committee scrutinized the application and documents submitted by the PP in the meeting. Based on the scrutiny of the application it was decided to ask the PP to submit below mentioned information within a month's time,

failure to which the case shall returned to SEIAA for delisting / rejection assuming that PP is not interested to continue with the project.

- The project is located in border district (Betul) hence a letter certifying the distance of the inter-state boundary to be furnished from revenue officer.
- Information from DFO and Tehsildar in prescribed format to be submitted.
- Letter from Mining Officer certifying the no. of mines and total lease area within 500 meters around the project site to be furnished.
- EMP activity-wise budget is not clear.

Since PP has submitted the desired information thus committee decided to call PP for presentation in forthcoming meetings of SEAC.

41. **Case No. – 2157/2014 Shri Raghvendra Singh Kiledar, Owner, BajarChowk, Bhesdehi, Betul (MP)-460220 Basalt Stone Quarry Lease Area – 0.70 ha., atKhasra No.-76/3. Capacity - 8550 Cum/Year, Village-Pipariya, Tehsil-Bhesdehi, District-Betul (MP)**

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Earlier also PP was absent when the case was placed in the 170th meeting. However, committee scrutinized the application and documents submitted by the PP in the meeting. Based on the scrutiny of the application it was decided to ask the PP to submit below mentioned information within a month's time, failure to which the case shall returned to SEIAA for delisting / rejection assuming that PP is not interested to continue with the project.

- The project is located in border district (Betul) hence a letter certifying the distance of the inter-state boundary to be furnished from revenue officer.

42. **Case No. – 2347/2014 Shri Ramanand Singh S/o Shri Mahendra Singh, DevriBakhar, Sagar (MP)-470001 (M-9418093347) Basalt Stone Quarry Lease Area – 1.60 Ha., at Khasra No. 202, Lease Period Ten Yearat Village-Singhpur, Tehsil-Kesli, District-Sagar (MP)Capacity – 22,500 Cubic meter/Year. Application forwarded by SEAC by SEIAA vide letter no. 2980/SEIAA/15 dated: 08/01/2015**

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra No. 202 at Village-Singhpur, Tehsil-Kesli, District-Sagar (MP)*, in 1.60 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 175 dated 16/03/15, that no mine is operating / proposed within 500 meter radius around the said mine. PP has reported that the pit formed after mining shall be developed into a water body.

The case was discussed in the 179th SEAC meeting dated 25/03/15 wherein after scrutiny of the project it was decided to return the case to SEIAA for revised & complete submission of the proposal as most of the essential documents are missing in the proposal. (Certificates from Forest department on distance of forest boundary, Gram ó SabhaPrastav, appropriate EMP).

Response to the above queries was submitted by the PP through SEIAA and the same was placed before the committee. The committee decided to call the PP for presentation in any of the forthcoming meetings of SEAC.

43. **Case No. – 2815/2015 Smt. Anjana Shukla W/o Shri Ravi Shukla, 6, Rajwas Colony, Ujjain (MP)-456001 PipliyaBicha Stone (for Gitty) & Murram Quarry Lease Area- 4.00 ha., (Stone-50,000 cum & Murram-10,000 cum per year, Total Cap. 60,000 cum / year, at Khasra No. - 54/1/2(P), dVillage-PipliyaBicha, Tehsil-Ujjain, District- Ujjain (MP)**

This is a case of mining of PipliyaBicha Stone (for Gitty) & Murram Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is

located at Khasra No. - 54/1/2(P), Village-PipliyaBicha, Tehsil-Ujjain, District- Ujjain in 4.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is not proposed in the lease area. Concerned Mining Officer vide letter no.-1101, dated -20/03/15, has reported that there are 02 more mines operating or proposed within 500 meters around the said mine and total lease area is 10.0 ha. PP has also informed that a crusher is also proposed in the mining lease area.

The case was discussed in the 198th SEAC meeting dated 04/06/15 wherein Submissions made by the PP were found to be satisfactory and acceptable except some of the details in EMP. PP was asked to submit the year wise and component wise budgetary details of funds allocated for various activities (such as plantatation etc.) to SEAC.

Response to the above queries was submitted by the PP and the same was placed before the committee. The submissions made by the PP were found to be satisfactory and acceptable. Thus committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-A

1. Production of Stone not exceeding 50,000 cum/year and Murrum 10,000 not exceeding as per mine plan.
