

The 240th meeting of the State Expert Appraisal Committee (SEAC) was held on 05th November, 2015 under the Chairmanship of DR. R. B. Lal for discussion on the query responses submitted by the PP and the projects / issues received from SEIAA. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

1. Case No. 3728/15 Shri Nardev Sharma, Village-Badawda, Tehsil-Jarwra, District-Ratlam (MP). Prior Environment Clearance for approval of Stone Quarry in an area of 3.450 ha. (14,250 cum/year) at Village-Sindurkiya, Tehsil-Jawra, District-Ratlam (MP).

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-321, Village-Sindurkiya, Tehsil-Jawra, District-Ratlam (MP) 3.450 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-992, dated: 26/06/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

The case was presented by PP and their consultant. During deliberations committee observed that in mine plan area of existing land use and land use after lease is mismatching and moreover, mandatory Buffer zone of 7.5 meters around the mine is not left in submitted maps attached with mine plan. Thus the mine plan needs complete revision. PP was asked to submit the revised mine plan through SEIAA. The case is therefore returned to SEIAA for delisting.

2. Case No. 3729/15 Shri Santilal Rudani, 10, Poonam Vihar Colony, Tehsil-Jawra, District-Ratlam (MP) . Prior Environment Clearance for approval of Stone Quarry in an area of 2.00 ha. (14,250 cum/year) at Village-Akyadeh, Tehsil-Piploda, District-Ratlam (MP).

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 461/1, Village-Akyadeh, Tehsil-Piploda, District-Ratlam (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-991, dated: 26/06/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

The case was presented by PP and their consultant. During deliberations committee observed that:

1. The certificate issued by the mining officer vide letter dated 26.06.16 states that there is no other mine in 500 meters while the certificate issued by the Tehsildar states that one mine is in existence in 500 meters for which PP was asked to get reconfirmation of facts from Tehsildar.
2. Mandatory Buffer zone of 7.5 meters around the mine is not shown in the maps attached with mine plan. PP was asked to submit surface map duly signed by the mining department.

3. Case No. 3730/15 Shri Preamdev Patidar S/o Shri Tridev Patidar, 9, Goushala Bhawan, Mandsaur (MP). Prior Environment Clearance for approval of Stone Quarry in an area of 2.00 ha. (17,100 cum/year) at Village-Narayangarh, Tehsil-Malhargarh, District-Mandsaur (MP).

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 538/1 Min-2, 538/1 Min-3, Village-

Narayangarh, Tehsil-Malhargarh, District-Mandsaur (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1041, dated: 07/07/2015, has reported that there is 04 more mines operating or proposed within 500 meters around the said mine and Total Area-10.00 ha.

The case was presented by PP and their consultant. During deliberations committee observed that in mine plan no area is left for plantation inöland use after leaseö and moreover, mandatory Buffer zone of 7.5 meters around the mine is not shown in the maps attached with mine plan. Thus the mine plan needs complete revision. PP was asked to submit the revised mine plan through SEIAA. The case is therefore returned to SEIAA for delisting.

4. Case No. 3731/15 Shri Vinay Kumar Munji, C-60, Janta Colony, Mandsaur, District-Mandsaur (MP)-458002. Prior Environment Clearance for approval of Stone Quarry in an area of 2.00 ha. (17,100 cum/year) at Village-Narayangarh, Tehsil-Malhargarh, District-Mandsaur (MP).

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 931/1 Min-1, 931/Min-4, Village-Narayangarh, Tehsil-Malhargarh, District-Mandsaur (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1039, dated: 07/07/2015, has reported that there is 04 more mines operating or proposed within 500 meters around the said mine and Total Area-12.00 ha.

The case was presented by PP and their consultant. During deliberations committee observed that in mine plan no area is left for plantation inöland use after leaseö and moreover, mandatory Buffer zone of 7.5 meters around the mine is not shown in the maps attached with mine plan. Thus the mine plan needs complete revision. PP was asked to

submit the revised mine plan through SEIAA. The case is therefore returned to SEIAA for delisting.

5. Case No. 3732/15 Shri Santosh Kumar Pandey S/o Shri Madan Mohan Pandey R/o LalBahadurShastri Ward No. 2, Kothla, Tehsil-Katni, District-Katni (MP)-483501. Prior Environment Clearance for approval of Flag Stone Quarry in an area of 1.00 ha. (6,000 cum/year) at Village-Hardua, Tehsil-Pawai, District-Panna (MP)

This is case of **Flag Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-78, 79, 85, , Village-Hardua, Tehsil-Pawai, District-Panna (MP)1.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-1541, dated: 01/09/2014, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

The case was presented by the PP and their consultant. During presentation it was noticed that earlier a case with similar details and location was discussed as follows in 170th. SEIAA meeting dated 15/12/15:

“Case No. – 1801/2014 Shri Santosh Kumar Pandey S/o Shri Madan Mohar Pandey, LalBahadurShastri Ward No. 2, KothlaKatni, Tehsil & District- Katni (MP)-483501 Hardua Flagstone Quarry Lease Area –1.0 ha.– at Village-Hardua, Tehsil-Pawai, District-Panna (MP) Lease Period – 10 Year, Capacity – 4800 Cu.mt./Year.”

Now the PP has re-applied with new case number as follows:

“Case No. 3732/15 Shri Santosh Kumar Pandey S/o Shri Madan Mohan Pandey R/o LalBahadurShastri Ward No. 2, Kothla, Tehsil-Katni, District-Katni (MP)-483501. Prior Environment Clearance for approval of Flag Stone Quarry in an area of 1.00 ha. (6,000 cum/year) at Village-Hardua, Tehsil-Pawai, District-Panna (MP)”

All the details except the production quantity are same and the case was not recommended by the SEIAA in its 170th. SEIAA meeting dated 15/12/15. Thus the case is sent back to

SEIAA for clarification that whether above facts has been brought to the notice of SEIAA and whether this case be treated as new case.

6. Case No. 3733/15 Shri Shailesh Nagayach S/o Shri Jagdish Prasad Nagayach R/o Pawai, Ward No. 3, District-Panna (MP)-488446. Prior Environment Clearance for approval of Stone Quarry in an area of 1.39 ha. (16,958 cum/year) at Village-Tai, Tehsil-Pawai, District-Panna (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-1025, 1029, 1066, at Village-Tai, Tehsil-Pawai, District-Panna (MP) 1.39 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1550, dated: 07/08/2015, has reported that there is 03 more mines operating or proposed within 500 meters around the said mine and Total Area-5.53 ha.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production of **Stone** not exceeding 16,958 cum/year as per mine plan.
2. A village road is about 125 meters from the ML area, thus additional row of plantation be carried out towards road side along with 3 meter barrier wall.

7. Case No. 3734/15 Shri Bhanuraja Singh S/o Shri Kammod Singh R/o Village-Khirwa, Post-Piparwah, Tehsil-Amanganj, District-Panna (MP). Prior Environment Clearance for approval of Flag Stone Quarry in an area of 2.00 ha. (1,400 cum/year) at Village-Kuthrahiya, Tehsil-Pawai, District-Panna (MP)

This is case of **FlagStone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-281/1, Village-Kuthrahiya, Tehsil-Pawai, District-Panna (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and SFO (forest). Concerned Mining Officer vide letter no.-1541, dated: 07/08/2015, has reported that there is 07 more mines operating or proposed within 500 meters around the said mine and Total Area-16.00 ha.

The case was presented by the PP and their consultant wherein it was observed that Forest Certificate is issued by the DFO (forest) and is not by the DFO. Thus PP was asked to submit Forest certificate duly signed by the DFO.

8. Case No. 3735/15 Shri Chaturesh Kumar Pandey S/o Shri Ramavtaar Pandey, R/o C/o Papu Pandey, Village-Pawai, Tehsil-Pawai, District-Panna (MP)-488448. Prior Environment Clearance for approval of Flag Stone Quarry in an area of 2.50 ha. (7,500 cum/year) at Village-Kuthrahiya, Tehsil-Pawai, District-Panna (MP)

This is case of **Flag Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-280, Village-Kuthrahiya, Tehsil-Pawai, District-Panna (MP) 2.50 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1540, dated: 07/08/2015, has reported that there is 05 more mines operating or proposed within 500 meters around the said mine and Total Area-14.10 ha..

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production of **Flag Stone** not exceeding 7,500 cum/year as per mine plan.

9. Case No. 3736/15 Shri Dushyant Singh Bundela S/o Shri JagatPratap Singh R/o Village & Post-Sugrha, Tehsil-Gunnaur, District-Panna (MP)-488050. Prior Environment Clearance for approval of Stone Quarry in an area of 0.650 ha. (3,002 cum/year) at Village-Luhargaon, Tehsil-Gunnaur, District- Panna (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-386, Village-Luhargaon, Tehsil-Gunnaur, District- Panna (MP) 0.650 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1590, dated: 10/08/2015, has reported that there is 02 more mines operating or proposed within 500 meters around the said mine and Total Area-2.950ha.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production of **Stone** not exceeding 3,002 cum/year as per mine plan.

10. Case No. 3737/15 Shri Pradeep Kumar Shukla R/o Village-Tighara, Post-Kachoor, Tehsil-Huzur, District-Rewa (MP)-486001. Prior Environment Clearance for approval of Stone Quarry in an area of 2.024 ha. (9,000 cum/year) at Village-Kauvadhan, Tehsil-Huzur, District-Rewa (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-257, 258, 259, Village-Kauvadhan, Tehsil-Huzur, District-Rewa (MP) 2.024 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1110, dated: 14/07/2015, has reported that there is 04 more mines operating or proposed within 500 meters around the said mine and Total Area-16.93 ha..

The case was presented by the PP and their consultant and during presentation based on the Google image as per the co-ordinates provided by the PP, it was observed that the mine site is in the midst of an agricultural field and crusher is also proposed which further will contribute to the particulate emissions and thus any mining activity at this

site will have adverse impact on adjoining agricultural fields. Hence, the case is not recommended for the grant of EC.

11. Case No. 3738/15 Shri YagyaPratap Singh R/o Rohaniya, Tehsil-Sohagpur, District-Shahdol (MP)-484001. Prior Environment Clearance for approval of Stone Quarry in an area of 1.00 ha. (3,000 cum/year) at Village-Diyapiper, Tehsil-Gohparu, District-Shahdol (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-197/1, 197/2, Village-Diyapiper, Tehsil-Gohparu, District-Shahdol (MP) 1.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1213, dated: 31/07/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

The case was presented by the PP and their consultant and during presentation it was observed that the tehsildar's certificate submitted by the PP as annexure -4 has no mine details such as khasra no., area etc and thus PP was asked to submit tehsildar's certificate containing above details.

12. Case No. 3739/15 Shri Sanjay Kumar Mishra R/o Village-SinduriBharri, Tehsil-Sohagpur, District-Shahdol (MP)-484001. Prior Environment Clearance for approval of Stone Quarry in an area of 1.619 ha. (11,400 cum/year) at Village-Ahrgawa, Tehsil-Pushprajgarh, District-Anuppur (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-133/2 K/2, Village-Ahrgawa, Tehsil-Pushprajgarh, District-Anuppur (MP) 1.619Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer

vide letter no.-1074, dated: 23/07/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

The case was presented by the PP and their consultant and during presentation it was observed that the surface plan/other plans attached with the mine plan are not approved by the mining department. Thus PP was asked to submit surface plan duly approved by the mining officer.

13. Case No. 3740/15 Shri Mahesh Singh Kushwaha S/o Shri Radha Krishna Kushwah R/o Dangiyapura, Behat, Gwalior (MP)-474001. Prior Environment Clearance for approval of Stone Quarry in an area of 1.00 ha. (6,840 cum/year) at Village-Bilaua, Tehsil-Dabra, District-Gwalior (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-3921, Village-Bilaua, Tehsil-Dabra, District-Gwalior (MP) 1.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-QL-34, dated: 15/07/2015, has reported that there is 12 more mines operating or proposed within 500 meters around the said mine and Total Area-21.03 ha.

The above site is located in bilaua which is a cluster of mines and site visit is already proposed for this location by SEAC committee members. So it was decided to call PP for presentation after the site visit.

14. Case No. 3741/15 Shri Abhay Tiwari R/o Niviha Mohalla, Mangawan, District-Rewa (MP)-486111. Prior Environment Clearance for approval of Stone Quarry in an area of 4.00 ha. (5,000 cum/year) at Village-Pakariya, Tehsil-Budhar, District-Shahdol (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-14/1 (P), Village-Pakariya, Tehsil-

Budhar, District-Shahdol (MP) 4.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1212, dated: 31/07/2015, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and Total Area-7.00 ha.

The case was presented by the PP and their consultant and during presentation it was observed that a village road is about 120 meters away from the mining lease and it was recommended to erect a barrier wall of 3 meter height of suitable material.

During presentation it was also observed that the surface plan/other plans attached with the mine plan are not approved by the mining department. Thus PP was asked to submit surface plan duly approved by the mining officer.

15. Case No. 3742/15 M/s Jugal Kishore Stone Crusher R/o Kotwali Road, Benisagar Mohalla, Near Ramkunwar Advocate, District-Panna (MP). Prior Environment Clearance for approval of Stone Quarry in an area of 3.563 ha. (32,000 cum/year) at Village-Sili, Tehsil-Gunaur, District-Panna (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-228/1 KA, 228/1 KHA, 228/4, Village-Sili, Tehsil-Gunaur, District-Panna (MP) 3.563 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1435, dated: 01/08/2015, has reported that there is 02 more mines operating or proposed within 500 meters around the said mine and Total Area-8.126 ha.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure A

1. Production of **Stone** not exceeding 32,000 cum/year as per mine plan.

16. Case No. 3743/15 Shri Ritesh Pandey S/o Shri Ramnarayan Pandey R/o Bada Bazar, Village-Mohandra, Tehsil-Pawai, District-Panna (MP). Prior Environment Clearance for approval of Flagstone Quarry in an area of 2.00 ha. (1,200 cum/year) at Village-Kuthrahiya, Tehsil-Pawai, District-Panna (MP)

This is case of **Flag stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-278/1, Village-Kuthrahiya, Tehsil-Pawai, District-Panna (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1544, dated: 07/08/2015, has reported that there is 05 more mines operating or proposed within 500 meters around the said mine and Total Area-13.60 ha.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production of **Flag Stone** not exceeding 1,200 cum/year as per mine plan.

17. Case No. 3744/15 Shri Sanjay Pandey R/o HIG-30, Madhav Rao Sindia Enclave, Darpan Colony, Murar, Gwalior (MP). Prior Environment Clearance for approval of Murrum Quarry in an area of 1.213 ha. (15,000 cum/year) at Village-Bilheti, Tehsil-Gwalior, District- Gwalior (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-2035/1/1, 2226/1/1, 2226/2/1, 2224/1 , Village-Bilheti, Tehsil-Gwalior, District- Gwalior (MP) 1.213 Ha. The project requires prior EC before commencement of any activity at site.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

1. Production of **Murram** not exceeding 15,000 cum/year as per mine plan.

18. Case No. 3745/15 Shri Mohammed Afjaal S/o Shri Auliya Sahab R/o Lohar Mandi, Tehsil-Burhanpur, District-Burhanpur (MP)-450331. Prior Environment Clearance for approval of Stone Quarry in an area of 2.00 ha. (14,250 cum/year) at Village-Khadkod, Tehsil-Burhanpur, District- Burhanpur (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-671, Village-Khadkod, Tehsil-Burhanpur, District- Burhanpur (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-5017, dated: 25/07/2015, has reported that there is 08 more mines operating or proposed within 500 meters around the said mine and Total Area-16.07 ha.

The case was presented by the PP and their consultant. During presentation and deliberations it was observed that as per Khasra, the proposed site is reserved for rehabilitation plan of Narmada Ghati Development Authority. Concerned Mining Officer vide letter no.-1778, dated: 10/07/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine .

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A
