

The 241st meeting of the State Expert Appraisal Committee (SEAC) was held on 06th November, 2015 under the Chairmanship of DR. R. B. Lal for discussion on the query responses submitted by the PP and the projects / issues received from SEIAA. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

1. Case No.- 3760/15 Smt. Harvinder Kour Wadhawa S/o Shri Mangal Singh Wadhawa R/o Gard Line, Town-Damoh, District-Damoh. Prior Environment Clearance for approval of Stone Quarry in an area of 1.00 ha. (6,850 cum/year) at Khasra No.-596/1, Village-Aapchand, Tehsil-Sagar, District-Sagar (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-596/1, Village-Aapchand, Tehsil-Sagar, District-Sagar (MP) 1.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-879, dated: 13/07/2015, has reported that there are 03 more mines operating or proposed within 500 meters around the said mine and total area including this mine is -3.55 ha.

The case was presented by the PP and their consultant and the EMS and other submissions made by the PP were found to be satisfactory and acceptable except the certificate issued by the DFO which has over writing. Thus PP was asked to submit fresh DFO's certificate.

This is case of **Flag Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-126, Village-Talgaon, Tehsil-Pawai, District-Panna (MP) 0.41 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1497, dated: 04/08/2015, has reported that there is 01 more mine operating or proposed within 500 meters around the said mine and total area including this mine is - 1.82 ha.

The case was presented by the PP and their consultant and the EMS and other submissions made by the PP were found to be satisfactory and acceptable except the forest certificate which is issued by the SDO (F) while it should be issued by the DFO. Thus PP was asked to submit forest certificate issued by DFO.

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-12/1, Village-Chothiya, Tehsil-Multai, District-Betul (MP) 0.60 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-711, dated: 18/11/2015, has reported that there is 01 more mine operating

or proposed within 500 meters around the said mine and total area including this mine is - 1.30 ha.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

1. Production of **Stone** not exceeding 1,470 cum/year as per mine plan.

This is case of **Metal Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-51/1/1/1 (Part) Village-Dhureri, Tehsil-Depalpur, District-Indore (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-914, dated: 26/03/2015, has reported that there are 11 more mines operating or proposed within 500 meters around the said mine and total area including this mine is -25.77 ha.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

This is case of **Limestone and Dolomite Mine**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-514, 517, 518, 532, Village-Jamuwani Kala, Tehsil-Vijayraghogarh, District-Katni (MP) 3.50 Ha. The project requires prior EC before commencement of any activity at site.

The case was presented by the PP and their consultant for the TOR. After deliberations, committee recommends to issue standard TOR prescribed by the MoEF&CC with following additional TORs:-

1. Since the forest boundary is only 416 meters away from the lease area, the PP should address the possible impacts of this mining activity in EIA and the proposed mitigation plan in the EMP.
 2. Issue of shifting of high tension line (if any) should be addressed in the EIA with supporting documents.
 3. Details of afforestation done till date should be provided in EIA with supporting photographs.
 4. Details of compliance made by the PP of consent conditions issued by the M. P. Pollution Control Board should be provided in EIA.

During deliberations committee observed that in mine plan Chapter-II in land use after lease no area details are provided for OB dumps storage and plantation. PP was asked to get the same revised and submit it after due approval from the mining department.

Thus it was decided to write by SEAC to Chief Conservator of Forest, Bhopal for confirmation of NOC issued by the DFO for appraisal of the project.

PP was asked to submit the revised mine plan through SEIAA. The case is, therefore, returned to SEIAA for delisting.

DISCUSSION ON INSPECTION REPORTS OF SEAC MEMBERS

29. Case No. - 818/2012- Mr. Mahesh Manwani, Director, "Alpine Greenage" of M/sHimanshu Infrastructure Pvt. Ltd." A 2, IInd Floor, Above Metro Shoes, Ravishankar Market, Bhopal (M.P.) " Alpine Greenage" of M/s Himanshu Infrastructure Pvt. Ltd." Khasra No. 529 (Old No.- 47/1/2/1), 530 (Old No. 47/1/1) Village –Gehukheda, Tehsil – Huzur, Distt. – Bhopal (M.P.) Total Land Area – 34,400.00 Sq.m. (3.44 Ha.), Total Built-up Area – 27334.22 Sq.m. Env. Consultant – In- Situ Enviro Care, Bhopal.

This is building construction case with built-up area more than 20000m². The project is covered under the provisions of EIA Notification as item 8(a) of the schedule of the notification; hence the project requires prior EC from SEIAA before commencement of any activity at site. The application for EC was forwarded by SEIAA to SEAC for appraisal. The salient features of the project were presented by the PP accompanied by his consultant.

Chronology of the Case

- The case was discussed in 104th meeting of SEAC. It was found that the land was not transferred to PP, hence the case was differed till submission of papers of land.
- The case was again discussed in 158th meeting of SEAC held on 28.11.2014 and was recommended for clearance to SEIAA.
- Consequent up on following decision of 220th meeting (dated 22-07-15) of SEIAA, the case has been referred by SEIAA to SEAC for site inspection to verify the status of construction with following comments:

“From the Google image it appears that the PP has already started construction on the site. This is to be verified by SEAC and if it is correct that construction has commenced, then a report in this regard along with modified recommendation (as per latest NGT order dated 07-07-2015) be conveyed to SEIAA. PP should be informed accordingly”.

In view of above background a team of SEAC members Dr. U R Singh and, Dr. Alok Mittal along with Shri Sudhakaran from SEAC Secretariat inspected the project site on 3rd of Oct’2015.

Observations by the committee during the site visit of the project are

- A public road is passing through the project and PP informed that this is not the part of the project and is to be constructed by government.
- Thus the project site is divided into two parts and there have been constructions on both the sides of road.
- On each side, two six storied blocks have been constructed, out of which one block is plastered and nearly completed, while the other block is un-plastered with part brick work.
- In each constructed block there is facility for stilt parking.
- Representative of PP informed that the present construction is less than 35-40% of the proposed construction and construction was stopped long back.
- There is sump well and single (ground) floor sample house cum office are also constructed within the project premises.
- There was no residual evidence of ongoing construction. Almost negligible construction material was lying on the site.
- There was neither construction labors nor labor hutments present at the site.

At the time of site visit committee members found that part construction has been done and even with part construction the case falls under violation and needs credible action. However, members did not notice any ongoing construction activities at the time of inspection.

The report of committee (Annexure-1) was discussed in the meeting and after deliberations, committee decided that credible action may be initiated and recommendations made in 158th meeting of SEAC held on 28.11.2014 may be kept in abeyance.

Consultant – In- Situ Enviro Care, Bhopal.

This is building construction case with built-up area more than 20000m². The project is covered under the provisions of EIA Notification as item 8(a) of the schedule of the notification; hence the project requires prior EC from SEIAA before commencement of any activity at site. The application for EC was forwarded by SEIAA to SEAC for appraisal. The salient features of the project were presented by the PP accompanied by his consultant.

Detail of Project: Sterling Globe Grand, Residential Project, Total Plot Area- 12600 Sq.mt., Proposed BuiltUp Area : 26886.34 Sq.mt, Building Height : 21.0 m (maximum).

Chronology of the Case

- The case was discussed in 153rd meeting of SEAC held on 21.10.2014, wherein query was sought about anomaly in built-up area which was shown to be less than 20,000 sq m. (which does not fall within the purview of EIA notification-2006)
- The case was rescheduled for 155th meeting of SEAC held on 11.11.2014 after receiving query response on 30-10-2014. But the proponent was absent.
- The case was again scheduled for 158th meeting of SEAC held on 28.11.2014 where in case was recommended for clearance to SEIAA.
- Consequent up on following decision of 220th meeting (dated 22-07-15) of SEIAA, the case has been referred by SEIAA to SEAC for site inspection to verify the status of construction with following comments:

“From the Google image it appears that the PP has already started construction on the site. This is to be verified by SEAC and if it is correct that construction has commenced, then a report in this regard along with modified recommendation (as per latest NGT order dated 07-07-2015) be conveyed to SEIAA. PP should be informed accordingly”.

In view of above background a team of SEAC members Dr. U R Singh and, Dr. Alok Mittal along with Shri Sudhakaran from SEAC Secretariat inspected the project site on 3rd of Oct’2015.

Observations by the committee during the site visit of the project are

- A 24 m wide road is passing through the project and PP informed that this is a public road, which is to be constructed by government.
- Thus the project site is divided into two parts. However, the present construction is limited to the left side (while entering) of the road and there is no construction activity on the right side of the road.
- On the left side, part construction has been done, which is limited to two interconnected blocks. In the basement of the constructed block there is two level parking. PP informed that the present construction is less than 20% of the proposed construction and the construction activities were stopped immediately after submitting application to the MPSEIAA.

At the time of site visit committee members found that part construction has been done. However, members did not notice any ongoing construction activities at the time of inspection. There was no residual evidence of ongoing construction. Almost negligible construction material was lying on the site. Some iron rods (Sariya) were lying on the site, which were heavily rusted further indicating sign of no ongoing construction activities at the site in recent past. Moreover, neither construction labors nor labor hutments were present at the site.

Even with part construction the case falls under violation and needs credible action.

The report of committee (Annexure-2) was discussed in the meeting and after deliberations, committee decided that credible action may be initiated and recommendations made in 158th meeting of SEAC held on 28.11.2014 may be kept in abeyance.

31. Case No. - 2350/2015 Shri Dinesh Moolchandani, Director, M/s Paras Housing (India) Pvt. Ltd. , 243-B, Zone-1, M.P. Nagar, Bhopal-462011 (MP) Group Housing

Project "Urbane Park" at Village-Bawadiakalan, Tehsil-Huzur, District-Bhopal (M.P.) at Khasra No. – 98, 99, 100, 101, 495/98, 102/1, 107, Total Project Area – 13587.30 Sq.m., Total Built up Area- 21332.70 Sq.m.

This is an area development project comprising a Residential premise. Plot area of the project is 13587.30 Sq.m. and total built-up area proposed is 21332.70 Sq.m. The project is covered under the provisions of EIA Notification as item no. 8(a). Hence requires prior EC before commencement of activity at site. The application was forwarded by SEIAA to SEAC for appraisal and necessary recommendations. It was submitted by the PP that construction at site has already been taken up. Being a case of violation it was deferred by the committee for want of credible action in the matter. The project shall be considered after receipt of evidence pertaining to initiation of credible action against the project proponent.

Detail of Project:

Group Housing Project "Urbane Park" at Village-Bawadiakalan, Tehsil-Huzur, District-Bhopal (M.P.) at Khasra No. – 98, 99, 100, 101, 495/98, 102/1, 107, Total Project Area – 13587.30 Sq.m., Total Built up Area- 21332.70 Sq.m.

Chronology of the Case

- The case was discussed in 172nd SEAC meeting held on 22.02.2015. It was submitted by the PP that construction at site has already been taken up. Being a case of violation it was deferred by the SEAC, and was sent back to SEIAA for credible action.
- In the 196th meeting of SEIAA held on 27.04.2015 it was decided that the case should be sent to SEAC. The SEAC should submit the report on the basis of site visit ascertaining the construction already undertaken and the present status of the project along with the photographs. Clear recommendation should be given whether construction activity has been stopped or still going on.
- In the 199th meeting of SEAC held on 21.06.2015 it was decided to carry out the site visit by SEAC members.

In view of above background a team of SEAC members Dr. U R Singh and, Dr. Alok Mittal along with Shri Sudhakaran from SEAC Secretariat inspected the project site on 3rd of Oct'2015.

Major observations by the committee during the site visit of the project are

- It was informed by the representative of PP present at the site during the visit of the team that as per MPVPR, the total built up area for the project is 18523.4 m², but as per MoEF, total built-up area of the project is 21332.70 m² (This fact was also confirmed from the available records). Because of this confusion in the definition of built-up area, the violation of prior clearance occurred. Upon advice from consultants the issue of built-up area definition was reworked and hence the project proponent immediately applied to MPSEIAA for the environmental clearance.
- The Project is a Group-housing with all the basic amenities. Entry/exit to the project site is through 30 m wide service road, connecting to Hoshangabad road. Main entry exit is 9 m wide while all the roads for internal circulation are 6 m wide.
- There are 144 numbers of flats distributed in 6 towers and one addition block for club house. PP informed that no EWS/LIG houses were constructed at the site and in-lieu of these, due fee has been paid to the T&CP.
- Podium is provided connecting all the residential blocks and access to each block is provided through the podium through guarded entry.
- Six meter wide circular roadway has been provided along the periphery of the project for movement of fire tenders. Suitable fire water storage tanks are also constructed on each block. Fire hydrants are also provided.
- Roof top garden in the podium area is quite impressive and well maintained with low or medium root plants, short heighted shrubs, proper turf area along with seasonal annual plants. As per the PP green area provided in the project is almost 34% of the net plot area, out of which 10% area is hard green area with tall trees rooted into the ground. Plantation is also provided on the road dividers and play ground. Plantation of mix species has been provided along the periphery of the campus. These plants have risen to good height and seem to be old.
- The water requirement for the residents is sourced through the municipal supply and the sewage generated is being treated using on site STP. 75 KLD STP is already installed at site. Technology used for treatment process is FAB. STP tanks for the project were found installed underground with proper access through the manholes covered with cast iron lids. The filters and machine room are provided above the ground level which is easily accessible. The project has dedicated treated water storage tank of 135 KLD (75KLD underground + 60 KLD over head tanks). STP was found functional and the treatment quality was found satisfactory as there was no odor nuisance even near the STP and dual pumping areas.
- Dual plumbing is provided for recycle of treated water for flushing and gardening purpose. PP has provided color coded pipes for separate fresh and recycled water supply. PP informed that presently the excess treated water is being consumed by the nearby construction site and in future, if need arises the same will be discharged into

the municipal sewers. However, at present due to low occupancy availability of excess treated water is quite less.

- A MSW collection site is constructed outside the project boundary on a land patch owned by the project proponent. Color coded bins are provided at various points for collection of waste material. As per PP the segregated MSW along with dried sludge is being handed over to Municipal Corporation at their expense.
- Parking space in the project is found to be adequate for residents and the visitors. Most of the parking is provided in the stilt area below podium. Designated Visitor's parking is provided by the PP in the open area. Proper traffic circulation in the stilt area and peripheral roads are maintained through signage.
- Rain water harvesting structures are constructed for ground water recharge. Pipe network exists for transportation of collected rain water. All the roads and stilt area below podium are lined with paver blocks to support the percolation of rain water. No concrete paved surface was found at site. As per PP peripheral drains have been provided below roof top garden over podium to recollect the excess water used for irrigation. Members instructed PP to make proper arrangements for flushing of first rain water to ensure that clean water enters into the recharge system.
- Adequate recreational area is provided in the form of roof top garden over podium, club house and plays ground. Small cricket pitch is also constructed in the playground area. Soft synthetic carpeting has been provided in the children play area particularly under swings, sea-saw etc.
- Energy saving fixtures are installed in the common areas, viz. CFL, LEDs.

It was found that presently, at the time of site visit, no construction was going on. Actually there is no scope of any further construction as the construction of the entire project has already been completed and few possessions have been given. According to PP almost 30% flats have already been occupied.

The report of committee (Annexure-3) was discussed in the meeting and after deliberations; committee decided that the inspection report may be sent to SEIAA for necessary action.

DISCUSSION ON QUERY RESPONSES

This is a case of mining of Pyrophyllite and Diaspore in an area of 14 Ha. The project is covered under EIA notification and mentioned at SN 1(a). Therefore it requires prior EC before commencement of any activity at site. The application with related documents was forwarded by SEIAA to SEAC for scoping so as to finalize the TOR to carry out EIA study and prepare EMP for the project. PP and his consultant presented the salient features of the project and proposed TOR. It was reported that the project does not attract general conditions. The submissions and presentation reveals following:

Mining Method

- Opencast manual method of mining has been carried out and same will continue.
- All operations of opencast working like face clearing, sorting, sizing and loading of mineral etc. will be done manually.
- Drilling has been carried out by tractor mounted compressor with Jack Hammer same will be continuing.
- Blasting is not required hence not proposed.

The TOR was approved in the 134th SEAC meeting dated 03/06/2013 and EIA was presented by the PP and their consultant in the 214th SEAC meeting dated 20/08/2015 wherein PP was asked to submit response with supporting documents to the following quarries raised by the committee:-

- Clarification on the comments given by the ADM in Public Hearing.
It is noted that the temple, hostel and several trees are located on the same khasra along with the proposed lease area; hence in this context PP is required to submit a map of the complete khasra depicting relative locations of all the above features and the relative distance of each of the above features from the project boundary. A note highlighting the safety measures and the eco-friendly practices proposed in the mining operations.
- Expected impacts from the mining activities on various nearby components and the mitigations planned to be furnished separately.
- Lease area approach road net-work with status of the same to be furnished.

Response to the above queries was submitted by the PP and the same was placed before the committee wherein it was observed that public hearing issue has been dealt in EIA. It has been observed that ADM has made adverse comments on the project but considering the technical aspect of the project where mining is manual and without blasting significant impact is not envisaged. It is also submitted that adequate distance shall be made from the temple and other observed features and no mining will be opened towards direction of temple and hostel building. PP has further submitted that mining department has deducted

4.00 ha of area considering the location of temple as the total area of Khasra no. 1045 was of 18.00 ha.

The submissions made by the PP were found to be satisfactory and acceptable. Thus committee decided to recommend the case for grant of prior EC subject to the following special conditions:

1. Garland drains shall be constructed all around the mine and these shall be connected to a settling tank of suitable capacity.
2. Only manual mining is allowed.
3. No blasting should be carried out as the site is in close vicinity of temple and hostel.
4. Temple and hostel roads shall not be used for transportation of materials.
5. Evacuation of mineral shall be done from the north to southern part of the hillock away from the temple and hostel location.
6. All recommendations mentioned in the EMP shall be binding for the project authorities.
7. Appropriate activities shall be taken up for social upliftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.
8. Necessary consents / authorization shall be obtained from MPPCB before commencement of the proposed production.

33. Case No. 1854/15 Mr. R.A. Joshi, Depot-in-Charge, Bhitoni, BPCL, Bhitoni POL Depot, N.H. 12, Shahpura, District-Jabalpur (MP)-483119. Prior Environment Clearance for approval of proposed New Storage Tank at Bhitoni POL Depot, NH12, Shahpura, District-Jabalpur (MP)

BPCL has installed its POL Depot in Bhitoni 29 KMs from Jabalpur for handling of HSD, MS, SKO, and Ethanol. The Bhitoni Depot, is a pure for sure certified unit of M/s BPCL commissioned in the year 1992. The depot facilitates receipt, storage & dispatch of various petroleum products like MS, HSD, SKO and Ethanol as well as products like Speed Grade MS and High Speed Diesel to Jabalpur and adjoining districts.

The demand of petroleum products is increasing in the command area of Bhitoni POL Depot and as per assessment; the existing storage is inadequate to fulfill the requirement. Hence, BPCL proposes to augment the existing facilities for storage & dispatch. The proposal relates to construction of Additional Tankage in the existing premises of POL depot.

- BPCL has proposed to enhance the capacity of MS & HSD in existing POL Depot, Bhitoni, Madhya Pradesh and other allied facilities.
- The input to the Bhitoni Depot is mainly from Bina Dispatch Terminal and BPCL Manmad Installation for receipt, storage and dispatch of MS, SKO and HSD by railway tankers (receipt), Ethanol by road tanker (receipt) and road tankers (dispatch).
- Existing Depot occupies an area of 34.0 acres.
- The Depot presently has 12818 KL of Tankage for handling Motor Spirit, High Speed Diesel, Superior Kerosene and Ethanol.

TOR for conduction EIA was issued vide letter no. 276 dated 20/12/14 and the EIA was presented in 224th SEAC meeting dated 16/09/2015 wherein after deliberations, PP was asked to submit response within 15 daysø time with supporting documents to the following points raised by the committee-

- Detailed plantation scheme as per the TOR issued vide letter no. 276 dated 20/12/14.
- Compliance report of consent condition from Regional Officer, M. P. Pollution Control Board, Jabalpur.
- Detailed Plan of measures taken by PP to address issues of traffic congestion raised during Public Hearing.

PP has submitted response to the above queries and the same was placed before the committee for scrutiny and necessary comments. The EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable. Thus committee decided to recommend **the case for grant of prior EC subject to the following special conditions:**

1. Adequate buffer zone to be created around the tankage facilities, as per the requirements of OSID or other statutory requirements.

2. VOC and HC shall be regularly monitored in the work zone in the plant along with the other parameters and data shall be submitted to MPPCB and R.O of MoEF&CC.
3. The company shall construct garland drain all around the project site to prevent runoff of any oil containing waste into the nearby water bodies. Separate drainage shall be created for oil contaminated and non-oil contaminated streams. During rainy season, the storm water drains shall be connected to oil water separator and passed through guard pond. Water quality monitoring of guard pond shall be conducted.
4. The project authorities should comply with the provisions made in Manufacture. Storage and Import of Hazardous Chemicals Rules 1989, as amended and the Public Liability Insurance Act for handling of hazardous chemicals etc. All Hazardous Waste (management, handling & Trans-boundary Movement) Rules 2008.
5. Company shall obtain all requisite clearances for fire safety and explosives and shall comply with the stipulations made by the respective authorities.
6. Green area including thick green-belt shall be developed in at least 33% of the plot area to mitigate the effect of fugitive emissions all around the plant in consultation with the forest department as per the guidelines of CPCB.

The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. The EMS and other submissions made by the PP were found to be satisfactory but as per the co-ordinates submitted by the PP, the Google image indicated that mining lease area falls within the 5 K. M of interstate boundary. In such situation the committee recommends PP to obtain reconfirmation of distance from Mining lease Area to the Interstate Boundary from the Revenue Authority.

PP has submitted response to the above queries and the same was placed before the committee for scrutiny and necessary comments. Scrutiny of the certificate submitted by the PP with reference to the above query reveals that certificate given by the Tehsildar dated 14/10/15 does not give the exact distance from the interstate boundary. However, as per the co-ordinates given in mine plan, show that area falls within 5.00 kms of inter-state boundary. Hence it is a Cat-Aø case. The committee decided to send this case to SEIAA for onward necessary action.

42. Case No. – 2994/2015 Shri Foulad Singh Patel, Authorized Representative, M/s Vanshika Construction Company, Devri Rajmarg, Teh.-Tendukheda, Narsinghpur (M.P.)-487770.Murgakheda (Narmada River) Sand Quarry Lease Area - 5.00 Ha., Capacity - 1,47,000 cum/year, at Vill.-Murgakheda, Teh.-Narsinghpur, District-Narsinghpur (M.P.)

This is a case of mining of Murgakheda (Narmada River) Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.- 206/2, 209/2, 211/2, 212/2, 213/2, 220/2, 223/2, 224/2, 227/2, 270/2, 271/2, 272/2, 272/1, Vill.-Murgakheda, Teh.-Narsinghpur, District-Narsinghpur (M.P.) in - **5.00** ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no. 509 dated: 30/16/2015 has reported that there is 01 more mine operating or proposed within 1000 meters around the said mine and total area including this mine is -15.063 ha.

The case was recommended in the 210th SEAC meeting dated 25/07/15. SEIAA in their 230th meeting dated 27/08/15 observed that mining officer, Narsinghpur has reported that there are three mines (area 22.063 ha) excluding the proposed mine of 5.00 ha. From the report of the mining officer, Narsinghpur, the total area within 1000 meter becomes 27.063 ha and since it is more than 25 ha the case should be appraised as B-1 category.

On perusal of the forwarding application of the proposal sent by the SEIAA, it was mentioned that the letter of Mining Officer not submitted by the PP at the time of filing of application. PP was therefore asked to submit desired documents which were not enclosed with the application directly to SEAC which includes the letter from mining officer. The same letter of mining officer issued vide letter no. 509 dated 30/06/2015 was taken in to consideration at the time of appraisal of the case and as per the certificate issued by the mining officer the cumulative area is 15.063 ha including this mine. With the above certificate of MO, the case does not falls within the B-1 category and committee stands by its earlier recommendations made in 210th SEAC meeting dated 25/07/2015.

43. Case No. – 2975/2015 Shri Avdhesh Rajpur S/o Shri Shivnarayan Rajput, Biloni, Teh.-Gadarwara, Narsinghpur (M.P.)-487551 Panagar River Sand Quarry Lease

Area - 5.00 Ha. Capacity - 1,47,000 cum/year, at Vill.-Panagar, Teh.-Gadarwara, District-Narsinghpur (M.P.)

This is a case of Panagar River Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located, at Khasra No.-305, at Vill.-Panagar, Teh.-Gadarwara, District-Narsinghpur (M.P.) 5.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the DFO. Concerned Mining Officer vides letter no. 231, dated: 31/03/2015, has reported that there is no more mine operating or proposed within 1000 meters around the said mine.

The case was placed in the 215th SEAC meeting dated 21.08.15 wherein PP was asked to submit the certificate from Tehsildar in the prescribed format. PP has submitted response to the above query and the same was placed before the committee for scrutiny and necessary comments. The EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Bø

1. Production of Sand not exceeding 1,47,000 cum/year as per mine plan.

44. Case No. - 3058/2015 Shri Shiv Kumar Bansal, Manager, M/s A & A Enterprises, 15/978, Rudra Enclave, Front of Collector Banglow, Malakhedi Road, Hoshangabad (M.P.)-461001. Sand Quarry Lease Area - 5.300 Ha., Capacity - 40,000 cum/year at Khasra No.-155, Village-Sunwani Khurd, Tehsil-Amanganj, District-Panna (M.P.)

This is a case of mining of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The EMP should include ó Bank erosion consequences and prevention / repair plans, evacuation plan, protection of fauna/flora, protection/safety of habitation on the transport route etc. PP has submitted response to the above query and the same was placed before the committee for scrutiny and necessary comments. The EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-Bø

The case was placed in the 216th SEAC meeting dated 16.09.15 wherein after deliberations PP was asked to submit site specific EMP addressing the protection plans of this natural drainage. PP has submitted response to the above query and the same was placed before the committee for scrutiny and necessary comments. The EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-Aø

1. Production of Stone not exceeding 36,000 cum/year as per mine plan.

46. Case No. 3163/2015 - Shri Jagdish Patidar S/o Shri Banshilal Patidar, Songra, Tehsil-Malhargarh, Mandsaur (MP)-458339 Prior Environment Clearance for approval of Stone/Murram Quarry in an area of 2.00 ha. (8,550 cum/year) at Village-Dodiyamina, Tehsil-Malhargarh, Mandsaur (MP)

This is a case of mining of *Basalt Stone and Murram Quarry*. The application was forwarded by SEIAA to SEAC for appraisal. PP was asked to submit forest certificate duly signed by the DFO. PP has submitted response to the above query and the same was placed before the committee for scrutiny and necessary comments. The EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

1. Production of Stone not exceeding 52,000 cum/year as per mine plan.

48. Case No. 623/2011 Mr. KBR Sood, Director (P) M/s Chindwara Power Limited D/12, Freedom Fighter Enclave, Gate No.- 4, IGNOU Road, Nebasarai, New Delhi-68. 60 MW (2x 30 MW) Tandsi Thermal Power Project of M/s Chindwara Power Limited Village- Dungaria, Semarkuhi , Tehsil – Junardeo, Distt.- Chindwara (M.P.) The case was recommended for delisting by SEAC as PP was not submitting the desired information. This case was discussed in the 234th SEIAA meeting dated 08/08/15 wherein it was observed that as per the minutes of SEAC TOR was issued to the PP on 12/10/2014 and thus the case was sent back by the SEIAA for reexamination/clarification. On scrutiny of file it was observed that the TOR was issued to the PP on 12/10/11 but due to typographical error, it was mentioned as 12/10/14. The committee decided that the case may again be sent back to SEIAA for delisting with above clarification.

Further DFO vide letter dated 01/05/15 has confirmed that the said PA is beyond 10 kms distance. The EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

1. Production of Flag Stone not exceeding 10,300 cum/year as per mine plan.
