

The 249th meeting of the State Expert Appraisal Committee (SEAC) was held on 14th December, 2015 under the Chairmanship of Dr R.B. Lal for discussion on the query responses submitted by the PP and the projects / issues received from SEIAA. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

- 1. Case No.- - 2477/2015 Shri Mukesh Sharma S/o Shri Kailash Sharma R/o Vill.- Barwani, Th.- & Distt-Barwani (M.P.). Stone Quarry Lease Area - 2.00 ha., Capacity -10,000 cum/year at Khasra No.-28/1 at Vill.- Lonsara, Th.- Barwaha, Distt-Barwani(M.P.)**

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-28/1 at Vill. - Lonsara, Th.- Barwaha, Distt-Barwani (M.P.) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-996, dated: 15/12/2014 has reported that there are no more mines operating or proposed within 500 meters around the said mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

- Production of **Stone** as per mine plan with quantity not exceeding (10,000 cum/year).

This is case of **Dursada Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra no.-227, 314, Vill. - Dursada, Teh.-Datia, Distt.-Datia (M.P.) 1.48 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-284, dated: 28/05/2015 has reported that there are 02 more mines operating or proposed within 500 meters around the said mine with total area of 11.014 ha including this Mine. The case was presented by the PP and their consultant and it was observed that there is an elevation of 10 meter and site is a hillock. It was observed that since the shape of mine is awkward thus for safe and sustainable mining quantity may be restricted to 30,000 cum/year.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure Aø

- Production of **Stone** as per mine plan with quantity not exceeding 40,000 cum/year.

This is case of **Dursada Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-296, 297, 298, Vill.- Dursada, Teh.-Datia, Distt.-Datia (M.P.) 1.91 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-282, dated: 28/05/2015 has reported that there are 02 more mines

operating or proposed within 500 meters around the said mine with total area of 11.014 ha. including this Mine. The case was presented by the PP and their consultant and it was observed that there is an elevation of 10 meter and site is a hillock.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure Aø

- Production of **Stone** as per mine plan with quantity not exceeding 40,000 cum/year.

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-1538/2, Vill.-Jagoti, Tehsil-Mahidpur, District-Ujjain (MP) 1.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-2015, dated: 29/07/2015 has reported that there are 01 more mines operating or proposed within 500 meters around the said mine with total area of 3.00 ha including this Mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure Aø

- Production of **Stone** as per mine plan with quantity not exceeding 6,000 cum/year and 06 meter depth restriction.

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-84, Vill.-Chainpura, Tehsil-Radhogarh, District-Guna (MP) 3.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-280, dated: 22/06/2015 has reported that there are no more mines operating or proposed within 500 meters around the said mine.

The case was presented by the PP and their consultant wherein it was observed that as per the Google image based on the co-ordinates provided by the PP, the site is visibly appears in close proximity with township and container storage area but Tehsildar in his certificate has not commented on these issues. Thus committee decided to seek clarification from District Collector on existence of above structures. It was also noticed that the forest NOC is issued by the SDO (forest) while it should have been issued by DFO. PP was asked to get the DFO's certificate.

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-270, Vill.-Pachara, Tehsil-Datia, District-Datia (MP) 4.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer

vides letter no.-196 dated: 13/05/2015 has reported that there are 09 more mines operating or proposed within 500 meters around the said mine with total area of 27.770 ha including this mine.

The case was presented by the PP and their consultant. Being it's a case of cluster where the total area is > 25 ha. it was decided to consider this case as B-1 category and committee recommended to issue standard TOR prescribed by the MoEF&CC for conducting the EIA.

7. Case No 3766/15 Shri Sameer Singh R/o Govind Niwas Palace, Tehsil-Datia, District-Datia (MP)-475335. Prior Environment Clearance for approval of Stone Quarry in an area of 2.00 ha. (20,000 cum/year) at Khasra No.-270, Vill.-Pachara, Tehsil-Datia, District-Datia (MP) –ToR.

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-270, Vill.-Pachara, Tehsil-Datia, District-Datia (MP) 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-207, dated: 20/05/2015 has reported that there are 17 more mines operating or proposed within 500 meters around the said mine with total area of 42.80 ha including this mine.

The case was presented by the PP and their consultant. Being it's a case of cluster where the total area is > 25 ha. it was decided to consider this case as B-1 category and committee recommended to issue standard TOR prescribed by the MoEF&CC for conducting the EIA.

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-22, Vill.-Rahangi, Tehsil-Dindori,

District- Dindori (MP) 1.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-288, dated: 05/05/2015 has reported that there are no more mines operating or proposed within 500 meters around the said mine.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

Prior Environment Clearance for approval of Stone Quarry in an area of 1.10 ha. (5,700 cum/year) at Khasra No.-565, 566, Vill.-Kajarwada, Tehsil-Nainpur, District-Mandla (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-565, 566, Vill.-Kajarwada, Tehsil-Nainpur, District-Mandla (MP) 1.10 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-817 dated: 14/08/15 has reported that there are -06 more mines operating or proposed within 500 meters around the said mine with total area of 7.30 ha including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A-

- Production of **Stone** as per mine plan with quantity not exceeding 5,700 cum/year.
- There is a stop dam in SE direction at a distance of 305 meters. Thus garland drains and settling tank be provided all around the ML area.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-362, dated: 25/03/2015 has reported that there are 02 more mines operating or proposed within 500 meters around the said mine with total area of 7.30 ha including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

- Production of **Stone** as per mine plan with quantity not exceeding 10,000 cum/year.

11. Case No. - 3812/15 Smt. Minakshi Devi w/o Shri Vipin Jain R/o Bahubalipuram Guna, District-Guna (MP)-473001. Prior Environment Clearance for approval of Stone Quarry in an area of 2.00 ha. (12,000 cum/year) at Khasra No.-35, 37, Vill.-Bajrang Garh, Tehsil-Guna, District-Guna (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-35, 37, Vill.-Bajrang Garh, Tehsil-Guna, District-Guna (MP) 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-326, dated: 03/07/2015 has reported that there are no more mines operating or proposed within 500 meters around the said mine. The case was presented by the PP and their consultant. During presentation it was observed that National Highway and State Highway are at a distance of 2.00 Kms and 1.15 kms respectively. A water body also exists at a distance of 1.80 kms.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

- Production of **Stone** as per mine plan with quantity not exceeding 12,000 cum/year.

12. Case No. - 3866/15 Shri Sohan Singh Thakur, M/s Thakur Constructions, Village-Bamora Behda Chhparai, Band, District-Sagar (MP)-. Prior Environment Clearance for approval of Sand Quarry in an area of 19.746 ha. (1, 25,000 cum/year) at Khasra No. – 226, Village-Horiyapipar, Tehsil-Hoshangabad, District-Hoshangabad (MP)

This is case of **Sand Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 226, Village-Horiyapipar, Tehsil-Hoshangabad, District-Hoshangabad (MP) 19.746 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-2662, dated: 06/07/2015 has reported that there are 10 more mines operating or proposed within 1000 meters around the said mine with total area of 152.711 ha including this Mine.

Executive Director, M.P. State Mining Corporation Ltd., Bhopal vide letter No. Ret-2/2015-16/450 Bhopal dated 08/09/2015 has submitted a list of cluster of mines existing in the state for issuance of TOR which was forwarded by SEIAA vide letter no 5774/

SEIAA/15 Bhopal dated 26.09/15 for consideration as per EIA notification. As per above list the 54 mines are in the cluster and total Area-731.791 ha including this mine.

After presentation and deliberations it was observed that following sanctioned/proposed mines in the area are forming a cluster which is >25 ha.:-

All the mines of above cluster after their individual valid application in SEIAA & presentation in SEAC for TOR can conduct regional EIA but their EMP should be site specific and will be considered on case to case basis.

Being it a case of cluster where the total area is > 25 ha. it was decided to consider this case as B-1 and committee recommended to issue TOR with following additional TOR to the standard TOR prescribed by the MoEF&CC for conducting the EIA:-

1. Detailed evacuation plan is to be discussed in the EIA report.

2. EIA/EMP is required to be prepared for entire cluster in order to cover all the possible externalities. The report should cover carrying capacity, transportation and other related issues for the cluster.
3. Photographs and maps depicting all the mines present in the cluster.
4. On a Google map, show all the mines in a cluster with all four co-ordinates of individual mines.
5. Photographs of individual mine during EIA process with date.
6. Justify the production from each mine and also justify the duration when mining is possible.
7. If on the evacuation route there are human settlements justify how they will be protected or suggest alternate evacuation route.
8. Show on a map, where temporary storage facility of sand will be created along with environmental protection measures proposed for such storage facility.
9. Discuss and assess impacts of sand mining on pisciculture.
10. Discuss and assess impacts of sand mining on agricultural practices (such as growing of water melons etc) if taking place in the cluster area.
11. Discuss the measures that will be adopted for the bank erosion.
12. Indicate in EIA the structures such as bridges/barrages/dams close to individual leases in cluster and effects of mining on their structure stability with protection plan.
13. Provide the historical data of last 05 years about the sand already evacuated and the replenishment capacity of individual mine lease.
14. A habitation is in close vicinity and possible impacts & mitigation measures be addressed in EIA.
15. Fresh DFO certificate be submitted as in the submitted certificate date of issue is not clear.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -B

- Production of **Sand** as per mine plan with quantity not exceeding 3,465 cum/year.

DISCUSSION ON QUERY RESPONSES

29. **Case No. 2153/2011 Smt. Savitri Mishra W/o Shri Laxman Prasad Mishra, Village & Post-Paarwa, Tehsil-Rajnagar, Chhatarpur (MP)-471001, Village & Post-Paarwa, Tehsil-Rajnagar, Chhatarpur (MP)-471001 Paarwa Stone Mine, Lease Area – 4.00 ha. at Khasra No. -1288. Capacity - 51852 Cum/Year, Village-Paarwa, Tehsil-Rajnagar, District-Chhatarpur (MP).**

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra No. -1288. Capacity - 51852*

Cum/Year, Village-Paarwa, Tehsil-Rajnagar, District-Chhatarpur (MP) in 4.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 1251 dated 15/10/2014, that 02 more mines are operating / proposed within 500 meter radius around the said mine with total lease area of 11.0 Ha. PP has reported that the pit formed after mining shall be developed into a water body.

The case was discussed earlier in the 170th SEAC meeting dated 28/01/2015 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable. It is reported by the DFO, Chhatarpur vide letter no. 2945 dated 17/10/2013 that the mine is located at 8.4 Km from the boundary of the Panna Tiger Reserve. As the Eco-sensitive zone of the said reserve has yet not been notified the comments of Chief Wild Life Warden in the prescribed format of MoEF is required to be submitted by PP for further consideration of the committee.

PP has submitted response to the above queries and has applied online for wild life clearance vides proposal number FP/MP/MIN/336/2015 and date of submission is 17/11/2015 which was placed before the committee for scrutiny and necessary comments. As the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

1. Production of Stone as per mine plan with quantity not exceeding 51,852 cum/year.
2. Necessary Wild Life Clearance from NBWL shall be obtained by PP.

30. Case No. – 2663/2015 Shri Anup Kumar Chobey, Village-Dhana, District-Sagar (M.P.)-470228. Stone Boulder Quarry Lease Area – 1.60 ha. Capacity - 6,500 cum/year, at Village-Biharikheda, Tehsil-Sagar, District-Sagar (MP).

This is a case of mining of Stone *Boulder Quarry*. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located *at Village-Biharikheda, Tehsil-Sagar, District-Sagar in 1.60 ha*. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Crusher is proposed in the lease area. Concerned Mining Officer vide letter no. 281 dated: 15/04/2015 has reported that there is 01 more mine operating / proposed within 500 meters around the said mine and the total lease area is 3.30 Ha.

The case was discussed earlier in the 213th SEAC meeting dated 04/11/2015 wherein it was observed that DFO in his letter no. 2297 dated 17/07/2014 has reported that the lease area is entered as 'Grazing Land' in Khasra - Paanch-Saala and has shown his concern regarding grazing pressure on the forest area. However, no clear comments have been provided by the DFO in this regard. Hence it was decided to ask the concerned DFO to provide specific comments on the issue. The case shall be further considered after the comments from DFO are received.

PP has submitted response to the above queries and has submitted revised DFO letter issued vide letter no. 712 dated 18/02/2015 which was placed before the committee. After deliberations committee decided that since as per revised letter issued on dated 18/02/2015, since DFO has not objected the case may be considered. As the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

1. Production of Stone as per mine plan with quantity not exceeding 6,500 cum/year.

31. Case No.-2516/2015 Shri Anup Tiwari S/o Shri Shyam Sunder Tiwari, Guard Line, Damoh (M.P.)-470772 Stone Boulder Mine Lease Area - 2.250 ha., Capacity- 27,470 cum/year at Vill.-Jujharpura, Th.--Bakswaha, Dist- Chhatarpur (M.P.).

This is a case of mining of *Basalt Stone Quarry*. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located Vill.-Jujharpura, Th.-- Bakswaha, Dist- Chhatarpur(M.P.) in **2.250 ha.**, The project requires prior EC before commencement of any activity at site. PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and Range Officer. Concerned Mining Officer vide letter no. 1646 dated: 23/12/2014 has reported that there

are 09 more mines operating or proposed within 500 meters around the said mine and the total lease area is 13.712 Ha.

The case was presented in 207th. Meeting of SEAC dated 22/07/15 wherein it was observed that the certificate regarding information on forest has been issued by the Range Officer; the same has to be endorsed by the concerned DFO and submitted along with the production schedule for the left out lease period.

The case was discussed earlier in the 223rd SEAC meeting dated 15/09/2015 wherein Scrutiny of the case reveals that the PP has submitted the requisite information i.e. certificate of DFO. Based on the information submitted by the PP committee recommended the case for grant of prior EC.

SEIAA vide their letter no. 4206 dated 04/11/2015 has sent back the case for re-appraisal as site falls on the edge of the State Highway whereas as per the MMR 1996 (as amended up to 2013) the clear distance between the mining site and State Highway should not be less than 100 meters. In response to the above minutes of the SEIAA, PP has submitted a reply with revised co-ordinates which was placed before the committee. After deliberations committee decided that since revised co-ordinates are submitted by the PP which is different from the co-ordinates mentioned in mine plan, PP may be asked to get them authenticated from the mining department.

32. Case No. 3454/15 Shri Subhash Joardar C/o Pradeep Joardar, Station Road, Maihar, District-Satna (MP)-485771. Prior Environment Clearance for Stone Quarry in an area of 1.023 ha. (5,700 cum/year) at Khasra No.-52P, Vill.-Silauti, Teh.-Maihar, Dist-Satna (MP).

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-52P, Vill.-Silauti, Teh.-Maihar, Dist-Satna (MP)1.023 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-692, dated: 27/05/2015, has reported that there is 04 more mines operating or proposed within 500 meters around the said mine and Total Area-6.106 ha.

The case was discussed earlier in the 233rd SEAC meeting dated 29/10/2015 wherein after presentation by the PP and deliberations, it was observed that the existing features were not shown in surface plan nor the surface plan was approved by the mining department. PP was asked to get the surface plan duly approved by the mining department showing existing features within 15 days.

PP has submitted response to the above queries which was placed before the committee. After deliberations committee decided that as the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-Aø

1. Production of Stone as per mine plan with quantity not exceeding 5,700 cum/year.

33. Case No. 3457/15 Shri Surya Prakash Chaurasiya R/o Purani Basti, Maihar, District-Satna (MP)-485771. Prior Environment Clearance for approval of Stone Quarry in an area of 1.250 ha. (8,550 cum/year) at Khasra No.-52P, Vill.-Silauti, Teh.-Maihar, District-Satna (MP)

This is case of **Stone Quarry** . The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-52P, Vill.-Silauti, Teh.-Maihar, District-Satna (MP) 1.250 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.691, dated: 27/05/2015, has reported that there is 02 more mines operating or proposed within 500 meters around the said mine and Total Area-4.384ha.

The case was discussed earlier in the 233rd SEAC meeting dated 29/10/2015 wherein after presentation by the PP and deliberations, it was observed that the existing features were not shown in surface plan nor the surface plan was approved by the mining department. PP was asked to get the surface plan duly approved by the mining department showing existing features within 15 days.

PP has submitted response to the above queries which was placed before the committee. After deliberations committee decided that as the EMS and other submissions made by the

PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-Aø

1. Production of Stone as per mine plan with quantity not exceeding 8,550 cum/year.

34. **Case No. – 2227/2014 Shri Sachan Tiwari S/o Shri Rajendra Tiwari, Village-Rupadon Ryt, Tehsil-Ghansor, District-Seoni (MP) Basalt Stone Quarry Lease Area –0.300 ha. Khasra No. 23 , at Village-Rupadon Ryt, Tehsil-Ghansor, District-Seoni (MP), Capacity -2850 Cum/Year.**

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Khasra No. 23, at Village-Rupadon Ryt, Tehsil-Ghansor, District-Seoni (MP)* in 0.3 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Concerned Mining Officer vide letter no. 2742 dated 25/12/2014 has reported that there is no mine operating /proposed within 500 meters around the said mine. No crusher is proposed in the lease area.

The case was discussed earlier in the 185th SEAC meeting dated 29/04/2015 wherein scrutiny of the mining plan reveal the presence of certain scheduled animals in the area which needs confirmation from the forest department. The DFO in his letter has not commented on this issue. Hence PP was asked to submit comments of concerned Forest Officer on this issue.

PP has submitted response to the above queries which was placed before the committee. After deliberations committee decided that as the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure :-Aø

1. Production of Stone as per mine plan with quantity not exceeding 2,850 cum/year.

35. Case No. – 2592/2015 Shri Shrey Jain S/o Shri Sharad Jain, H.N. 1204, State Bank Colony, Hathital, Jabalpur (M.P.)-482001 Stone Boulder Mine Lease Area - 1.00 ha., Capacity - 13,000 cum/year, at Village-Nadiya, Teh.-Kesli,Distt.-Sagar (M.P.)

This is a case of mining of stone boulder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Village-Nadiya, Teh.-Kesli,Distt.-Sagar (M.P.)* in 1.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. Concerned Mining Officer vide letter no. 78 dated 28/01/2015 has reported that there is no mine operating / proposed within 500 meters around the said mine.

The case was considered in the 190th SEAC meeting dated 06/05/15 whereby the PP was asked to submit following:

- Certificate from competent authority regarding land-use diversion from Grazing land to mining.
- Revised activity-wise EMP cost and budget allocation for socio-economic activities in the region.

The requisite information was submitted by the PP and based on the submissions of the PP and the presentation made earlier the case was recommended for grant of prior EC subject to the following special conditions in addition to the standard conditions ó at annexure -Bø

1. Annual abstraction of sand shall be as per the approved Mining Scheme and the depth of mining shall be restricted to 3m or water level, whichever less is and production capacity not exceeding **13000 cum/year**.

SEIAA vide their letter no. 7564 dated 10/11/2015 has sent back the case for appraisal based on the points submitted by the PP. On examination of the file it was observed that it was case of õStoneö mining while during recommendation it is mentioned as õSandö.

Thus committee decided that typographical error stands corrected and recommendations may be read as follows:-

Recommended for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure A.

1. Production of Stone as per mine plan with quantity not exceeding 13,000 cum/year.

36. **Case No. – 2705/2015 Shri Atul Goldal S/o Shri Kuldeep Goldal, 12, Metro Plaza, Bittal Market, Bhopal-462016 (M.P.). Sand Quarry Lease Area-5.00 ha., Capacity - 1,47,000 cum/year, at Village-Saikheda, Tehsil-Gadarwara, District-Narsinghpur (M.P.)**

This is a case of mining of *Sand Quarry*. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 634 , *at Village-Saikheda, Tehsil-Gadarwara, District-Narsinghpur (M.P.)* 5.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no. nil dated: 24/3/15, has reported that there is no mine operating or proposed within 500 meters around the said mine.

The case was discussed earlier in the 210th SEAC meeting dated 25/07/2015 wherein scrutiny of the documents revealed that the Tehsildar in his report has commented on expected land degradation from the mining activities. However no clarification has been provided on this issue. Also it was reported by the PP that the evacuation road from the Mine site connecting to the main road is under dispute with the local residents. Thus, PP was asked to get clear comments from the revenue department on the above issues and submit the same within a month's time.

Tehsildar vide letter no. 2562 dated 09/11/2015 has submitted response to the above query which was placed before the committee. Committee after deliberations decided that Environmental Clearance at this site should not be considered based on the points raised by the Tehsildar which are of Environmental Sensitivity. Hence the case is not recommended for grant of EC.

37. **Case No. - 2359/2015 Shri Ajay Singh, Director, M/s Jatashankar Marbles Pvt. Ltd., Ganesh Villa, 153, Sector-46, Faridabad (Haryana)-121003 Granite Mine Lease Area – 4.529 Ha., (Capacity -24,000 cum/year) at Village-Kesripura, Tehsil-Lavkush Nagar, District-Chhatarpur (MP)**

This is mining project comprising mining of *Granite* in a lease area of 4.529 Ha. The project is covered under the provisions of EIA notification as item no. 1(a), hence requires prior EC from SEIAA. Application submitted by the PP was forwarded by SEIAA to SEAC for scoping so as to determine TOR to carry out EIA and prepare EMP. The salient features of the project and proposed TOR were presented by the PP and his consultant before the committee.

The case was discussed earlier in the 210th SEAC meeting dated 25/07/2015 wherein after deliberations committee approved the **TOR** which was issued to the PP vide letter no. 79 dated 10/04/2015.

Now PP vide their letter dated 05/12/2015 has requested for the withdrawal of application submitted for the grant of EC. The above request of PP was placed before the committee. Committee has no objection to the request and decided that the case may be sent SEIAA for appropriate action in view of PP's request.

38. **Case No. 3734/15 Shri Bhanuraja Singh S/o Shri Kammod Singh R/o Village-Khirwa, Post-Piparwah, Tehsil-Amanganj, District-Panna (MP). Prior Environment Clearance for approval of Flag Stone Quarry in an area of 2.00 ha. (1,400 cum/year) at Village-Kuthrahiya, Tehsil-Pawai, District-Panna (MP)**

This is case of **Flag Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-281/1, Village-Kuthrahiya, Tehsil-Pawai, District-Panna (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and SFO (forest). Concerned Mining Officer vide letter no.-1541, dated: 07/08/2015, has reported that there is 07 more mines operating or proposed within 500 meters around the said mine and Total Area-16.00 ha.

The case was discussed earlier in the 240th SEAC meeting dated 05/11/2015 wherein it was observed that Forest Certificate is issued by the SFO (forest) and is not by the DFO. Thus PP was asked to submit Forest certificate duly signed by the DFO.

PP has submitted response to the above queries which was placed before the committee. After deliberations committee decided that as the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure :-Aø

1. Production of Flag Stone as per mine plan with quantity not exceeding 1,400 cum/year.

39. Case No. 3235/15 Shri Rajesh Patidar, Partner, M/s Ratn Sampada Stone Crusher Udyog Evam Trading, Village-Lohari, Tehsil-Kukshi, District-Dhar (MP)-454335 Prior Environment Clearance for approval of Basalt Stone and Murram Quarry Lease Area - 4.00 ha., Capacity - (Basalt stone-29,431 & Murram-5,886 cum/year) at Khasra No.-Part of1/5, Village-Lohari, Tehsil-Kukshi, District-Dhar (MP)

This is case of Stone and Murram mining. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-Part of1/5, Village-Lohari, Tehsil-Kukshi, District-Dhar (MP) 4.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no. 831 dated: 2/5/2015, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and total land area 6.0 Ha including area of this mine.

The case was discussed earlier in the 217th SEAC meeting dated 23/08/2015 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable. However scrutiny of the documents revealed that the DFO certificate regarding information on forest has been issued by the Range Officer; the same has to be endorsed by the concerned DFO and submitted.

PP has submitted response to the above queries which was placed before the committee. After deliberations committee decided that as the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to

recommend the case for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure :-Aø

1. Production per mine plan with quantity not exceeding for Basalt stone-29,431 cum/year & Murram- 5,886 cum/year.

40. Case No. 3112/2015 Shri Bramhaswaroop S/o Shri Suresh Agrawal, D-101, Nilgiri Apartment, Kalindi Midtown, Indore (MP)-452007 Prior Environment Clearance for approval of Basalt Stone & Murram Quarry in an area of 1.950 ha. (Basalt Stone-20,326 & Murram-4,432 Quarry cum/year) at Village-Sejwani, Tehsil-Depalpur, District-Indore (MP).

This is a case of mining of *Basalt Stone and Murram Quarry*. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at *Village-Sejwani, Tehsil-Depalpur, District-Indore (MP)* in **1.950 ha.**, The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 543 dated: 21/05/2015 has reported that there are 11 more mines operating or proposed within 500 meters around the said mine the total lease area being 22.866 Ha.

The case was discussed earlier in the 207th SEAC meeting dated 22/07/2015 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-Aø

1. Production as per the mine plan with quantity not exceeding for stone boulder shall be 20326 m³ / Year and Murram not exceeding 4432 m³/Year.
2. Maximum depth of the pits shall not exceed 6.0 meters.
3. Barrier wall of at least 3 meters height shall be constructed on the boundary facing the industry (existing flour mill) reported at about 500 meters from the project boundary.

The case was placed in the 227th. SEIAA meeting and it was decided to revert back to SEAC for re-verifying the distance from the pucca road and the industrial establishment.

The case was discussed earlier in the 229th SEAC meeting dated 01/10/2015 wherein it was observed from the Google image based on the co-ordinates provided by the PP that the site is adjacent to the pucca road and distance from the industrial establishment is approx 500 meters. The committee after deliberation recommends that PP may be asked to submit distance certificate of village road and industrial establishment from mining lease from the concerned mining officer/ revenue authority within 15 days.

PP has submitted response to the above queries vides letter dated 03/11/2015 which was placed before the committee. Through above letter, PP has submitted a copy of the letter dated 29/10/2015 issued by the mining officer stating that the distance from the road and industry is 50 meters and 400 meters respectively. Committee after deliberations decided that the case may be sent to SEIAA in view of their query vides no 5524 dated 10/09/2015.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 1151 dated: 03/7/15, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and Total Area-7.00 ha.

The case was discussed earlier in the 225th SEAC meeting dated 17/09/2015 wherein after deliberations committee observed that this is an existing mine and same facts are not shown in the surface plan. PP was asked to get the revised surface plan duly approved by the mining department within 30 days.

PP has submitted response to the above queries which was placed before the committee. After deliberations committee decided that as the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to

recommend the case for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure -A

1. Production of Stone as per mine plan with quantity not exceeding 35,000 cum/year.

42. Case No. 2656/15 Shri Arpit Sakhlecha S/o Suresh Ji Sakhlecha, 1, Rathore Colony, Tehsil-Jaora, Ratlam (M.P.) Basalt Stone Quarry Lease Area – 2.00 ha., Capacity - 11,400 cum/year, at Khasra No. 461/1 at Village-Akyadeh, Tehsil-Piploda, District-Ratlam (MP).

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 461/1 at Village-Akyadeh, Tehsil-Piploda, District-Ratlam (MP) in **2.00 ha**. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar & DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 675 dated 7/11/2014, that one mines are operating / proposed within 500 meter radius around the said no mine and the total lease area is 4.0 ha. PP has reported that the pit formed after mining shall be developed into a water body.

This case was presented in 201st. SEAC meeting dated 01/07/15 and after deliberations PP was asked to submit revised mining plan with provision of 7.5 meter barrier zone around the lease area.

In response to above query of the SEAC, PP has submitted revised maps with provision of 7.5 meter barrier zone but these maps are not approved by the concerned mining department and no covering letter of such amendment is issued by them. Since the revised maps are not approved by the competent authority, the case cannot be appraised in the present form. PP is required to submit the requisite documents within 30 days time failing which it may be recommended for delisting.

PP has submitted response to the above queries which was placed before the committee. After deliberations committee decided that as the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to

recommend the case for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure :-Aø

1. Production of Stone as per mine plan with quantity not exceeding 11,400 cum/year.

Concerned Mining Officer vide letter no. 2237 dated: 24/11/15, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

This case was presented in 225th. SEAC meeting dated 17/09/15 and after deliberations committee observed that there is a natural drain in close vicinity of the mining lease area which is not addressed in the EMP. PP was asked to submit revised EMP addressing above issue along with signed copy of Tehsildar certificate.

PP has submitted response to the above queries which was placed before the committee. After deliberations committee decided that as the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure :-Aø

1. Production of Stone as per mine plan with quantity not exceeding 12,723 cum/year.

2. A natural drainage is about 100 meters away from the site thus garland drained with settling tank of suitable capacity be provided all around the ML area.

PP has submitted response to the above queries which was placed before the committee. After deliberations committee decided that as the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure -Aø

Concerned Mining Officer vides letter no. 301 dated: 01/8/2015, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and total mine 6.0 Ha including area of this mine. Crusher is also proposed but outside the lease area.

This case was presented in 216th SEAC meeting dated 22/08/15 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable. But the DFO certificate submitted by the PP has over writing in the dispatch number and thus committee recommends getting the same verified from the DFO by SEAC secretariat through post.

SEAC secretariat has received response of the above queries vide letter no. 3522 dated 06/10/2015 which was placed before the committee. After deliberations committee decided that as the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure -Aø

1. Production of Stone as per mine plan with quantity not exceeding 25,000 cum/year.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar & DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 509 dated:3/6/2015, that no more mines are operating / proposed within 500 meter radius around the said mine.

This case was presented in 201st SEAC meeting dated 01/07/15 wherein after deliberations PP was asked to submit revised mining plan with provision of 7.5 meter broad barrier zone around the lease area. Plantation scheme towards the road side to be submitted.

PP has submitted response to the above queries vide letter dated 12/10/2015 which was placed before the committee. After deliberations committee decided that as the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure -A

1. Production of Stone as per mine plan with quantity not exceeding 17,000 cum/year.
2. As committed 50 plants every year should be planted by PP towards road side.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no.6011 dated 17/11/2014, that no mine is operating / proposed within 500 meter radius around the said mine. This case was presented in 174th SEAC meeting dated 24/02/15 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable. Ratapani Abhyaran, hence PP was asked to obtain comments from the Chief Wild Life Warden of M.P. in the prescribed format and submit the same within one month. This is a case of mining of Basalt Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.- 91/1/1/KA, at Vill.-Badavda, Th.--Jawra, Dist-Ratlam (M.P.) Capacity- Cum/Year. in 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the DFO. Concerned Mining Officer vides letter no. 550 dated: 25/9/15, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and Total Area-6.00ha.

This case was presented in 225th SEAC meeting dated 17/09/15 wherein after deliberations committee observed it was observed that the certificate issued by Tehsildar was not clear. The PP is therefore required to submit fresh certificate within 15 days.

PP has submitted response to the above queries vide Tehsildar's letter dated 16/10/2015 which was placed before the committee. After deliberations committee decided that as the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure -A

1. Production of Stone as per mine plan with quantity not exceeding 11,400 cum/year.

This case was presented in 226th SEAC meeting dated 18/09/15 wherein after deliberations, it was observed that the co-ordinates are not mentioned in the mine plan and thus location specific issues of the mining lease area could not be for apprised. The PP was thus asked to submit co-ordinates of the site duly verified by the mining department within 15 days.

PP has submitted response to the above queries vide letter dated 12/10/2015 which was placed before the committee. After deliberations committee decided that as then site specific co-ordinates are now provided by the PP, the case may be placed for presentation in upcoming SEAC meeting and PP may be called for presentation.

51. **Case No. - 3097/15 - Shri Nilesh Batukle S/o Shri Suresh Rao Batukale, Brahmanwada, Teh.-Chandurbazar, Amravati (MH)-44460. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.152, dated: 09/02/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

This case was presented in 231st SEAC meeting dated 08/12/15 wherein after presentation and deliberations, it was observed that surface plan is not approved by the mining department. Thus PP was asked to get the surface plan approved by the mining department.

PP has submitted response to the above queries vide letter dated 07/12/2015 which was placed before the committee. It was also noticed that the ML area is only 03 kms away from Maharashtra State. Since the cumulative area within 500 radius of this mine is <5.00 ha (As per Mining Officer vide letter no.-152, dated: 09/02/2015) the general conditions are not applicable in this project as per GOI Notification No. S.O. 2731 (E) dated 09/09/2013 and thus the case was considered as B-2 category. After deliberations committee decided that as the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure -Aø

1. Production of Stone as per mine plan with quantity not exceeding 14,250 cum/year.

Concerned Mining Officer vides letter no. 171 dated: 12/5/15, has reported that there is 02 more mines operating or proposed within 500 meters around the said mine and total lease area **23.060** Ha including this mine.

This case was presented in 227th SEAC meeting dated 19/09/15 wherein after deliberation and presentation; it was observed that as per the co-ordinate provided by the PP, the Google image shows the location of mine in very near to interstate boundary. Hence PP was asked to get a verification report from the Tehsildar about the exact distance of this mine from the interstate boundary.

PP has submitted response to the above queries vide letter dated 06/11/2015 enclosing the letter of Tehsildar issued vide letter no. 6-B 121/14-15 dated 04/11/2015 stating that the Sand mine, Gram Deevankhedi is 10 Kms on western side of Rajasthan State Boundary which was placed before the committee. After deliberations committee decided that as the EMS and other submissions made by the PP earlier were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure -Bø

1. Production of Stone as per mine plan with quantity not exceeding 10,000 cum/year.

53. Case No. 2309/14 Shri Prakash Patidar S/o Narayan Patidar, Vill.-Beedwal, Th.-Badnawar, District-Dhar (M.P.)-454660 Prior Environment Clearance for approval of proposed Basalt Stone Quarry in an area of 2.00 ha. 14,250 cum/year at Vill.-Khutapala, Th.-Sardarpur, District-Dhar (M.P.)

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 90, 92 at Village-Khutapala, Tehsil ó Sardarpur, Distt. Dhar (MP) in 2.00 ha. The project requires prior EC before commencement of any activity at site.

This case was presented in 178th SEAC meeting dated 24/03/15 wherein Scrutiny of the case reveals that the Mining Plan and submitted documents has several discrepancies based on the same then it was decided to return the case to SEIAA for delisting -

- Mandatory Buffer zone around the mine has not been left.
- Total of post-mining land-use is exceeding the actual lease area.
- Surface plan not submitted with the Mine Plan.
- Scrutiny of the mining plan reveals the presence of certain scheduled animals in the area which needs confirmation from the forest department. The DFO in his letter has not commented on this issue.

As above the case was returned to SEIAA for delisting. SEIAA vide their letter dated no. 1036 dated 19/04/2015 has sent back the case enclosing a representation of PP which was placed before the committee. The committee gone through the contents of representation of PP and observed that till date PP has not submitted the desired information such as surface plan with 7.5 meter mandatory buffer zone, details about total of post-mining land-use is exceeding the actual lease area and presence of certain

scheduled animals in the area which needs confirmation from the forest department. In the meantime, PP has requested for one months time vide letter dated 30/11/2015 stating that they have revised the mine plan and the same is under the approval of competent authority. Committee decided that PP may be asked to submit the revised mine plan through SEIAA.

54. **Case No. - 2296/2014 Shri Sanjay Agrawal S/o Shri Kalyanmal Ji Agrawal, 102, Janki Nagar, Akashganga Apartment, Indore (MP)-452009 2801 dt. 26-12-2014, Rec. dt. 27/12/14 Stone Quarry Lease Area -4.00 ha., at Khasra No. -166/5/4 , Capacity-16,500Cu.mt./Year,Village-Kalyansi Khedi, Tehsil-Dhar, District-Dhar (MP)**

This case was earlier discussed in 185th SEAC meeting dated 29/04/15 wherein it was observed that neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Earlier also PP was absent when the case was placed in the 178th meeting. However, committee scrutinized the application and documents submitted by the PP in the meeting. It was observed that the concerned Mining Officer vide letter no. 10196 dated 26/11/2014 has reported that seven more mines are proposed / operating within 500 meters around the said mine and the total lease area of 28 Ha. Thus, the case is a cluster type and falls under category B-1 as per the MoEF O.M. No. J-13012/12/2013-IA-1I (I) dated 24/12/2013, accordingly, EIA has to be carried out. Thus, Committee decided to call the PP giving him one more opportunity to know his consent over the issue of TOR.

SEIAA vide their letter dated no. 7384 dated 06/11/2015 has forwarded the request of PP to withdraw the case due to weak economic condition which was placed before the committee. The committee gone through the contents of representation of PP and decided to send the case file back to SEIAA for withdrawal of the project as requested by the PP.

Tehsil-Morena, District-Morena (MP). The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-Q-L-35/14, dated: 16/07/2015, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and total area-3.885 ha including this mine.

This case was presented in 237th SEAC meeting dated 02/11/15 wherein during scrutiny of the documents, it was revealed that mine plan having only one co-ordinate and thus it is very difficult to locate the entire mining lease area. Thus PP was asked to submit surface plan with all the four co-ordinates duly approved by the mining department within 15 days time for further consideration of the project.

PP has submitted response to the above queries vide letter dated 07/11/2015 which was placed before the committee. After deliberations committee decided that as then site specific co-ordinates are now provided by the PP, the case may be placed for presentation in upcoming SEAC meeting and PP may be called for presentation.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no. 662 dated: 06/5/15, has reported that there is 02 more mines operating or proposed within 500 meters around the said mine total land area 4.248. The quantity

demanded is too high when compared with the shape & size of lease area. In present circumstances, the demanded quantity cannot be considered in view of environmentally safe & sustainable mining.

This case was presented in 237th SEAC meeting dated 02/11/15 wherein scrutiny of mining plan reveals that surface plan/production plan is not approved by the competent authority. PP should submit the copy of approved plan. It was also observed in the meeting that the quantity demanded is too high when compared with the shape & size of lease area. In present circumstances, the demanded quantity cannot be considered in view of environmentally safe & sustainable mining.

PP has submitted response to the above queries vide letter dated 16/11/2015 which was placed before the committee. After deliberations committee decided that as the site specific co-ordinates are now provided by the PP, the case may be placed for presentation in upcoming SEAC meeting and PP may be called for presentation.

57. **Case No. – 2400/2015 Shri Udayveer Singh Jatav S/o Shri Ramsiya Jatav, Kamad Road, Indaragarh, Datia (MP)-474006 Stone Quarry in an area of 1.40 ha. (10,000 cum/year) at VillagePaharirawat, Tehsil-Indaragarh, District-Datia (MP). Applications forwarded by SEAC by SEIAA vide letter no. 3177/SEIAA/15 dated: 19/01/2015.**

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at VillagePaharirawat, Tehsil-Indaragarh, District-Datia (MP) in 1.40 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 38 dated 22/09/2014, that one mine is operating / proposed within 500 meter radius around the said mine with total area of 2.40 ha.

This case was presented in 181th SEAC meeting dated 27/03/15 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable and committee recommend the case for grant of prior EC.

SEIAA vide their letter dated no. 7556 dated 10/11/2015 has sent back the file stating that information submitted by the Tehsildar shows the human settlement as 100 meters from the Google map. It is observed that the site is in close proximity to the bigger village and it shall be harmful for the health of villagers which was placed before the committee. After deliberations committee decided that as the Tehsildar's certificate submitted with the case file has no mentioning about villages and human settlements within 500 meters of distance thus clarification from Tehsildar may be obtained on above issues.

58. Case No. - 3320/2015 Shri Mukesh Singh, Partner, M/s Ganesh Stone Crusher, C-8B, Dwarikapuri, District-Gwalior (MP) Prior Environment Clearance for approval of Granite (Road Metal) Quarry in an area of 3.850 ha. (1,00,000 cum/year) at Khasra No.-10, Village-Sukha Patha, Tehsil-Dabra, District-Gwalior (MP)

This is case of Granite (Road Metal) mining. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-10, Village-Sukha Patha, Tehsil-Dabra, District-Gwalior (MP) 3.850 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. Q/2015 dated: 25/7/2015, has reported that there is 03 more mines operating or proposed within 500 meters around the said mine and total land area 11.150 Ha including area of this mine.

This case was presented in 216th SEAC meeting dated 22/08/15 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable and committee recommend the case for grant of prior EC.

SEIAA vide their letter dated no. 6384 dated 19/10/2015 has sent back the file stating that up to what depth the mining will be permitted by the SEAC. After deliberations committee decided that as per the plan the production capacity is 1.00 lacs cum/year for 06 years. Considering the area of mine of 3.850 ha the annual excavation will be 03 meters. Thus the total depth till the validity of mine plan will be 18 meters.

59. Case No. – 1693/2013 Smt. Kuwar Rani Ayodhya Singh, Owner R/o 6, Usha Colony, Lashkar – Gwalior, Distt. - Gwalior (M.P.)- 470339- Expansion of production capacity from 20,000 MTPA to 262538 Ton per year at Khasra No. – Part of 1262 in Village- Panihar, Tehsil- Gird, Distt. – Gwalior (M.P.) Lease Area – 14.70 Ha. Lease Period –30Yrs. Env. Consultant : Creative Enviro Services, Bhopal (M.P.)-TOR VALIDITY EXTENTION

This is a case of mining submitted for grant of prior EC as PP desire to expand the production capacity from 20000 MTPA to 262538 MTPA. The project presently has a valid EC for the existing production capacity. Enhanced production is envisaged in view of revised mining Plan. The application was forwarded by SEIAA to SEAC for scoping so as to determine TOR to carry out EIA study and prepare effective EMP for the project. The case was presented by the PP and his consultant. After deliberations committee has approved the standard TOR with inclusion of additional points in 138th SEAC meeting 25/07/2013.

The TOR was approved in the 138th SEAC meeting dated 25/07/2013 and the same was issued to the PP vide letter no. 724 dated 11/10/2013. The validity of TOR expired on 10/10/2015. PP vide their letter dated 09.09.15 has requested for TOR extention. After deliberations, the committee recommends the case for extension in TOR for one year with validity up to 10/10/16.

Following standard conditions shall be applicable for the mining projects of minor mineral in addition to the specific conditions:

Annexure- 'A'

Standard conditions applicable to Stone/Murrum and Soil quarries:

1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
3. Transportation of material shall be done in covered vehicles.
4. Necessary consents shall be obtained from MPPCB and the air/water pollution control measures have to be installed as per the recommendation of MPPCB.
5. Curtaining of site shall be done using appropriate media.
6. The proposed plantation should be carried out along with the mining @45 trees per hectare and PP would maintain the plants for five years including casualty replacement. Entire plantation should be carried out in the initial 2-3 years while maintenance and causality replacement be done in subsequent years.
7. Transportation shall not be carried out through forest area.
8. Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.
9. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
10. The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product - mix in proposed mining unit shall require a fresh Environment Clearance.

Standard conditions applicable for the sand Mine Quarries*

1. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
 2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
 3. Plantation shall be carried out on the banks for stabilization of the banks.
 4. The mining activity shall be done manually.
 5. Heavy vehicles shall not be allowed on the banks for loading of sand.
 6. The sand shall be transported by small trolleys up to the main transport vehicle.
 7. Transport vehicles will be covered with tarpoline to minimize dust/sand particle emissions.
 8. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
 9. No Mining shall be carried out during Monsoon season.
 10. The depth of mining shall be restricted to 3m or water level, whichever is less.
 11. No in-stream mining shall be allowed.
 12. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
 13. Established water conveyance channels should not be relocated, straightened, or modified.
 14. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
 15. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
 16. PP shall take Socio-economic activities in the region through the 'Gram Panchayat'.
 17. EC will be valid for mine lease period subject to a ceiling of 5 years.
