

The 265th meeting of the State Expert Appraisal Committee (SEAC) was held on 13th January, 2016 under the Chairmanship of Dr R.B. Lal for discussion on the query responses submitted by the PP and the projects / issues received from SEIAA. The following members attended the meeting

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

This is case of Sandstone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-25/1, Vill.-Kakri Kachhar, Tehsil-Pawai, District-Panna (MP) 1.40 ha. The project requires prior EC before commencement of any activity at site.

- A natural drain is about 125 meters away from the site thus garland drain with settling tank of suitable capacity be provided all around the ML area.

The case was presented by the PP and their consultant. During presentation it was observed that the QL area is in close proximity of the National Highway, State Highway and a water body. The national highway is at a distance of approx. 900 meters on one side while state Highway is at a distance of 1.2 kms on the other side. In the southern side of the QL area at a distance of approx. 1.00 Kms a river can be seen based on the Google image as per the co-ordinates provided by the PP. As the cumulative area of existing/proposed mines within 500 meters is 23.50 ha and considering the site sensitivity, the committee decided to consider this case as B-1 category and committee recommended to issue standard TOR prescribed by the MoEF&CC for conducting the EIA.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 1580 dated: 7/8/15, has reported that there is 01 more mine operating or proposed within 500 meters around the said mine with total area of 2.30 ha including this mine

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

- Production of Flooring Stone as per mine plan with quantity not exceeding 5000 Cum/Year.

- Production of Metal Stone as per mine plan with quantity not exceeding 18,458 cum/year.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 1238 dated: 3/6/15, has reported that there is no more mines operating or proposed within 1000 meters around the said mine.

The case was presented by the PP and their consultant. During presentation it was observed that replenishment details of sand are not mentioned in the mine plan. Thus PP was asked to provide replenishment details duly approved by the competent authority.

23. Case No. -4047/15 Shri Nagendra Pratap Singh S/o Shri Prem Kumar Singh R/o NH-2, B-447, NTPC Colony, Vindhya Nagar, District-Singrauli (MP)-486885 Prior Environment Clearance for approval of Metal Stone Quarry in an area of 4.00 ha. (50,251 cum/year) at Khasra no.-1034/1, Village-Badkud, Tehsil-Chitrangi, District-Singrauli (MP)

This is case of Metal Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra no.-1034/1, Village-Badkud, Tehsil-Chitrangi, District-Singrauli (MP) 4.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.

5026 dated: 25/7/2015 has reported that there are 02 more mines operating or proposed within 500 meters around the said mine with total area of 8.85 ha. including this mine.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a month's time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO Concerned Mining Officer vide letter no. 1417 dated 10/9/15 has reported that there is 02 more mines operating or proposed within 500 meters around the said mine with total area of 3.486 ha including this mine.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

- Production of Stone as per mine plan with quantity not exceeding 6,002 cum/year.

25. Case No. -4049/15 Shri Lalai Prasad Jaiswal S/o Shri Hublal Jaiswal R/o Jhara, Tehsil-Sarai, District-Singrauli (MP)-486881 Prior Environment Clearance for approval of Stone Quarry in an area of 2.00 ha. (23,750 cum/year) at Khasra no.-3130, Village-Jhara, Tehsil-Sarai, District-Singrauli (MP)

This is case of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra no.-3130, Village-Jhara, Tehsil-Sarai, District-Singrauli (MP) 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 1877 dated: 7/9/2015 has reported that there is 01 more mine operating or proposed within 500 meters around the said mine with total area of 6.0 ha including this mine.

Case was presented by PP and their consultant. During presentation, it was observed that as per the certificate issued by the DFO, Sanjay Gandhi National Park wild is at a distance of 6.0 kms (a Notified PA) Clearance from NBWL is therefore needed. PP has submitted the copy of online application made for wild life clearance with proposal no. FP/MP/MIN/250/2015 and date of submission is 17/10/2015.

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

- Production of Stone as per mine plan with quantity not exceeding 23,750 cum/year.
- Grant of Environmental Clearance would be subject to necessary Wild Life Clearance from NBWL to be obtained by PP.

26. Case No. -4050/15 Shri Satyendra Singh S/o Shri Pushpendra Singh Parmar R/o Lal Bahadur Shastri Marg, In Front of Govt. This is a case of mining of Flagstone. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 2564 at Village-Bisani, Tehsil-Shahnagar, District-Panna (MP) in 3.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO Concerned Mining Officer vide letter no. 1571 dated 7/8/15, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine with total area of 5.00 ha. Including this mine

The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

- Production of Flagstone as per mine plan with quantity not exceeding 3,900 cum/year.

27. Case No. -4051/15 Shri Atul Sharma R/o Laxmi Nivas, Civil Line, Tehsil-Chhatarpur, District-Chhatarpur (MP)-471405 Prior Environment Clearance for approval of Stone Quarry in an area of 3.650 ha. (7,000 cum/year) at Khasra No. 422 at Village-Bakayan, Tehsil-Chhatarpur, District-Chhatarpur (MP)

This is case of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 422 at Village-Bakayan, Tehsil-Chhatarpur, District-Chhatarpur 3.650 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 1109 dated: 10/9/2014 has reported that there are no more mines operating or proposed within 5000 meters around the said mine.

The case was presented by the PP and their consultant and during presentation it was observed that a residential colony is located as per the Google image based on the coordinates provided by the PP. PP submitted that the excavation of mineral will be done only by the rock breaking machine and in mine plan no blasting is proposed.

However, during scrutiny of documents it was observed that it is an existing mine but the existing features are not shown on the surface map. Moreover, the maps attached with the

mine plan are not approved by the competent authority. Thus PP was asked to get the surface map approved by the concerned authority showing existing features of the QL area.

28. Case No. 99/2008 M/s Nirmala Minerals Pathaleward Katni M.P. Dubiyara Iron Ore Mine 32.375 ha. at DubiyaraTalluka-Sihora Jabalpur M.P.Dubiyara Iron Ore Mine, Nirmala Minerals Distt. Jabalpur, Area: 32.374 Ha, Prod: 0.20 Million T/Y. TOR issued vide letter dated- 07/08/08.

This being a mining project with lease area between 50 ha to 5 ha is listed at S.N. 1(a) of schedule under BØ Category of EIA Notification, 2006 and is to be appraised by SEAC.

TOR was issued vide letter dated 07/08/08. The applicant presented the salient features of the project EIA / EMP and the public hearing issues were dealt in detail in the 45th SEAC meeting dated 27/01/2010. It was reported that the mine is existing but not operating. Method of mining is Open cast and manual. It was reported that no blasting shall be carried out. The nearest habitat is village Dubariya about 100 mts. from the project boundary. A crusher for sizing of mineral is also reported outside the lease area. The mining shall not intersect the GW table. PP has not submitted NOC from forest department. Mining lease has expired and was reported to be under renewal. After deliberation, committee has sought following information and details from the PP:

- NOC from forest and 'Gram Sabha'.
- Application/ Papers submitted for renewal of mining lease along with the relevant provision of the act and rules to be furnished.
- Leachate study of OB to be submitted.
- Air/Water Consent from MPPCB for operation of crusher.
- Full details of the nearby habitation with exact distances from the lease boundary and population etc.

PP has submitted the information and the case was placed for the presentation. The case was presented by the PP and their consultant on above issues. After presentation and discussion of above, it was observed that only issue remains unanswered is clearance / certificate of DFO for distance from forest boundary. PP during discussion submitted that since their mine is sanctioned prior to 2002, thus this clearance is not applicable in this case.

The committee after deliberation decides that SEIAA may be requested to provide necessary clarification on this issue. Committee also decided that it being very old case, a site visit may also be carried out for this site to ascertain the present status of mine.

29. **Case No. - 3976/15 Shri Sailendra J. Worah, Director & Owner, M/s N.M. Dubash Stone & Lime Company Pvt. Ltd., Station Road, P.O.-Maihar, District-Satna (MP)-485771 Prior Environment Clearance for approval of Limestone & Dolomite Mine in an area of 1.518 ha. (89,302 TPA) at khasra No.-205 Part, Vill.-Amehta, Tehsil-Vijayraghgarh, District-Katni (MP)**

This is case of Limestone & Dolomite Mine. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at khasra No.-205 Part, Vill.-Amehta, Tehsil- Vijayraghgarh, District-Katni (MP) 1.518 ha. The project requires prior EC before commencement of any activity at site. (TOR)

The case was scheduled for presentation in 263rd SEAC meeting dated 11/01/2016 but PP via mail had requested for postponement of presentation on 13/01/2015 which was considered by the committee subject to availability of time.

Representative of PP came for the presentation along with the consultant. On verification of the documents it was observed that representative did not have valid authority of the PP. Representative submitted that he may be given another opportunity for presentation on 16/01/2016 so that he may come with the valid authority. Committee after deliberations decided that this case can be heard on 16/01/2016, if time permits after all the scheduled presentation.

Following standard conditions shall be applicable for the mining projects of minor mineral in addition to the specific conditions:

Annexure- 'A'

Standard conditions applicable to Stone/Murrum and Soil quarries:

1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
3. Transportation of material shall be done in covered vehicles.
4. Necessary consents shall be obtained from MPPCB and the air/water pollution control measures have to be installed as per the recommendation of MPPCB.
5. Curtaining of site shall be done using appropriate media.
6. The proposed plantation should be carried out along with the mining @45 trees per hectare and PP would maintain the plants for five years including casualty replacement.
7. Transportation shall not be carried out through forest area.
8. Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.
9. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
10. The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product - mix in proposed mining unit shall require a fresh Environment Clearance.

Annexure- 'B'

Standard conditions applicable for the sand Mine Quarries*

1. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
3. Plantation shall be carried out on the banks for stabilization of the banks.
4. The mining activity shall be done manually.
5. Heavy vehicles shall not be allowed on the banks for loading of sand.
6. The sand shall be transported by small trolleys up to the main transport vehicle.
7. Transport vehicles will be covered with tarpoline to minimize dust/sand particle emissions.
8. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
9. No Mining shall be carried out during Monsoon season.
10. The depth of mining shall be restricted to 3m or water level, whichever is less.
11. No in-stream mining shall be allowed.
12. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
13. Established water conveyance channels should not be relocated, straightened, or modified.
14. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
15. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
16. PP shall take Socio-economic activities in the region through the 'Gram Panchayat'.
17. EC will be valid for mine lease period subject to a ceiling of 5 years.
