

**1.0 Opening Remarks of the Chairman**

The Chairman welcomed all the members of the Committee (**Annexure-1**) and thereafter agenda items were taken up for deliberations. The list of participants present during meeting is annexed as **Annexure-2**.

**2.0 Consideration of the Projects**

26 proposals (for TOR / EIA deliberations) were invited. Proponents / Representatives of all the proposals made their presence before the committee. It is decided to hold the 55<sup>th</sup> & 56<sup>th</sup> meetings on 24<sup>th</sup> & 25<sup>th</sup> of May 2010.

**TOR Deliberations:**

The sand quarries with lease area between 05 ha to 50 ha are covered under the provisions EIA Notification, 2006 as such projects are listed at S.N. 1(a) of the schedule under 'B' Category hence these are required to be appraised by SEAC. M.P. State Mining Corporation Ltd. is controlling the operations of following sand quarries and hence has applied for grant of prior EC for these projects.

Officials from M.P. State Mining Corporation were present in the meeting but they failed to explain the salient features and locations of the quarries as they did not come prepared with appropriate presentations. Committee has issued following instructions / suggestions to the PP:

1. TORs' issued earlier during June 2009 for preparation of EIA / EMP other sand quarries of M.P. State Mining Corporation have not been responded yet. Committee asked the PP to submit the EIA reports for these projects at the earliest. PP was also informed about the OM of MoEF dated 22/03/2010 in context to the validity of issued TORs'.
2. Applications submitted by the applicant were in old formats and were not filled in completely. Thus PP was asked to submit completely filled applications in revised format.
3. Project Proponents did not come prepared with presentations and other relevant documents so as understand the locations of various quarries and the salient

4. Committee also suggested the PP to create an Environment Cell so that data collection and EIA studies of all the sites of sand quarries may be taken up.

Finally the committee decided to call the PP only after submission of completely filled applications in revised format in the subsequent meetings.

This being a Thermal Power Plant with production capacity of < 500 MW (based on coal) is listed at S.N. 1(d) of schedule under 'B' Category of EIA Notification, 2006 and is to be appraised by SEAC.

The applicant, presented the salient features of the project. Information pertaining to the above project was examined by the committee. After discussion on the project it was revealed that:

This is a case of production of power to the tune of 50.0 MW at existing Cement Plant. Industry has planned to generate power for captive use from coal. The site is located in Maihar Cement Complex, Sarla Nagar, Maihar Distt Satna. Submissions and the presentation made by the PP and his Consultant reveals following information on the project:

Committee has agreed to issue TOR to the PP to carry out EIA /EMP, with inclusion of following:

1. Micro-level features shall be depicted on to-the-scale map and presented with the EIA.
2. Lay out map showing the details of surrounding features has to be furnished.
3. Compliance of Air & Water Consent conditions and Environmental Clearance (issued for the operational cement unit and mines) has to be furnished with the EIA.
4. Extra efforts for Conservation of water have to be proposed in EIA.
5. Intent of CDM where ever possible (such as waste heat recovery) has to be taken up.
6. As per Gazette Notification dated 19/09/97 the coal based thermal power plants located in urban / sensitive area shall use beneficiated coal with ash content not exceeding 34 %, if by any chance the proposed unit falls under the above category the proposal has to be revised accordingly.
7. Mode of transport of coal up to the industry along with the route to be furnished.
8. Ambient Air Quality monitoring has to be carried out in accordance to the notification dated 16/11/09.
9. NOC from local authority (Maihar) to be furnished.
10. All chemical analyses report from approved laboratory in original format. The chemical analyses should incorporate method of analyses, instruments used and the details of standards used. The date and time of sampling should also be mentioned in the report.
11. Monitoring has to taken up as per the norms using appropriate air/water quality modeling, based on meteorological data (wind-rose) of the region.
12. Plantation in at least 33% of the total area has to be ensured; accordingly plan has to be submitted with EIA.
13. Calculations for the oxygen likely to be consumed per second / month / hour in the industrial operations viv-a-vis oxygen likely to be produced by the proposed plantation has to be furnished in the EIA so as to justify the proposed plantation in the premises.
14. Any litigation pending against the industry should be addressed appropriately.
15. Use of Solar energy for utilities has to be explored and implemented.
16. The EIA should be prepared based on model TOR for appraisal of power projects issued by MoEF, Delhi.

Mineral beneficiation projects with capacity < 0.1 million ton/annum mineral throughput are listed at SN 2 (b) Column B of the Schedule of EIA Notification hence these are required to be appraised by the SEAC. The proposed project pertains to beneficiation of iron ore at village Dhamki, Tehsil- Sehora & District – Jabalpur (M.P). The capacity is 90,000 TPA. Water requirement is reported to be 2.0 m<sup>3</sup> / Hour which shall be re-cycled the make-up water requirement will be 16m<sup>3</sup> / day, which shall be obtained from the nearby mining pits. No forest is reported in the 10 Km radius. Total area available with the proposed industry is 1.92 Ha and the plant shall be established in 2000 m<sup>2</sup>. The unit is registered in DIC. Examination of the documents reveal that the PP has been allotted only 4.40 Ha against his application for renewal of lease area for 5.46 Ha vide M.P. Govt. Order No. 3-80/97/12/2 dated 08/10/2001& 16/08/2001. Based on the above orders this committee is of the view that the case may not be covered under the provisions of EIA Notification, hence it was decided to return the case to SEIAA.
  8. **Case no. 442/2009 of Sh. Pankaj Verma, Vice President- Coordination) Jaypee Rewa Plant, Jaypee Nagar, Rewa (M.P.)** Jaypee Hi Tech Casting Centre ( A unit of Jaiprakash Associates Limited) Steel Foundry with Capacity of - 18000 MTPA, Khasra No.641,643 & 644, Chijwar, Rewa Road, Distt.-Rewa (M.P.) The TOR was issued to the PP in meeting dated- 22/09/09. PP has wants to withdraw the case in view of amended EIA Notification. with capacity less than 30000 MT/Year would not require prior EC under the provision of amended EIA Notification dated 01/12/2009. The case falls under this category and would not require prior EC. Committee decided to send the case back to SEIAA for de-listing.

9. **Case No. 494/2009 - Chirayu Hospital 6, Malipura Pirgate, Bhopal (M.P) Building Construction** The Proposed site earmarked for development of Hospital and Medical College at Bhaishkedi Indore Road Bhopal (M.P) – The case was considered in the 52<sup>nd</sup> meeting dated 26/04/10, whereby the committee raised certain queries, PP requested to consider the case in the meeting scheduled for 28/04/10, so that the PP may submit the reply and satisfy the queries raised by the members. The reply presented by the PP with the supporting documents was found to be satisfactory hence the committee recommended the case for issue of the prior EC, with following special conditions:
- All hazardous wastes generated in the activity shall be stored and disposed off as per the provisions of the Hazardous waste (Management, Handling & Trans-boundary Movement) Rules.
  - All Bio-medical wastes shall be handled as per the provisions of the Bio-Medical waste (Management & Handling) Rules.
  - All Municipal Solid Waste shall be managed as per the provisions of BMW (M&H) Rules.
  - All measures shall be taken to prevent percolation of wastes from the hospital premises into the nearby nallah.
  - PP has to strictly comply with the commitments made during the meetings and the plan submitted for conservation of Upper Lake & Environment of the region. (Enclosed)
  - Construction of STP shall be taken up only at the time of construction of residential blocks.
  - All mandatory permissions and consents shall be obtained prior to initiation of operation.

**Case no. 494/2009 - Chirayu Hospital 6, Malipura Pirgate, Bhopal (M.P) Building Construction - the Proposed site earmarked for development of Hospital and Medical College at Bhaikhedi Indore Road Bhopal (M.P)**

Dr. Ajay Goenka, Secretary, Chirayu Charitable Foundation was present in person in the SEAC meeting held on 28/04/2010. During the presentation Dr Goenka assured the Committee to take timely and appropriate action on the following issues:

1. Hospital being a sensitive building, its structures shall be designed/ built according to the design parameters recommended by NBO for the buildings falling in seismic zone-II, to prevent it from the possible impacts due to earth-quakes.
2. A new STP shall be constructed towards eastern boundary of the site along with the construction of residential accommodation.
3. The existing structure for the ETP shall be dismantled and the new ETP will be constructed as per revised details and at least 9.0 m away from the boundary wall along the nallah.
4. The RCC boundary wall with adequate depth below ground level shall be constructed all along the nallah and with HDPE lining to prevent seepage. Depth of the boundary wall will be kept such that no effluent from the premises / ETP is percolated in to the nallah.
5. Characteristics of the raw and treated liquid waste from hospital activities have to be monitored regularly along with the measurement of Total Organic Carbon (TOC).
6. Commitment for developing and maintaining the green belt in 7.5 acres in compliance to the Notification of M.P. Govt. dated 30/01/2009 has to be fulfilled and no other activity shall be permitted in this area.
7. Provision of covered space enough to store BMW generated in two days and another covered storage for manure shall be provided in the premises as per provision.
8. Rain water collection pits will be provided with oil/grease and silt trap to ensure safe and uncontaminated rain water for harvesting. The PP will ensure that no contaminated water is used for recharge. Regular monitoring of this water has to be conducted and reported to the authorities.
9. Eight meters wide green belt should be created on other three boundaries (in addition to point 5) of the premises even if the total green area exceeds 33% of the total plot area.
