

The 01st meeting of the Second State Expert Appraisal Committee (SEAC-II) for mining projects was held on 02^{ed} February, 2016 under the Chairmanship of Dr. Navin Chandra for discussion on the query responses submitted by the PP and the projects / issues received from SEIAA. The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

1. DISCUSSION ON SAND MINING CASES AS PER THE DECISION TAKEN BY SEIAA IN ITS 284th MEETING 23/01/2016

SEIAA in its 284th meeting dated 23/01/2016 has taken following policy decision in response to the directives of Hon'ble NGT in their order dated 06/01/2016 in Appeal No. 53/2015:-

“All cases pertaining to sand mining, the mining plan to be submitted by Director, Geology and Mining should include details about annual replenishment of sand in the leased area and the normal water level prevalent in the lean season. The cases recommended by SEAC and under process in SEIAA will be considered only after the revised mining plan duly incorporating the additional chapters as directed above by the Hon'ble NGT is submitted by the PP and duly approved by the competent authority. The cases will be reappraised by SEAC on the basis of revised mining plan and in accordance with the directives of the Hon'ble NGT”.

The above policy decision of SEIAA and copy of judgment passed by the Hon'ble NGT in their order dated 06/01/2016 in Appeal No. 53/2015 was placed before thy committee for perusal and discussion.

The committee after deliberations decided that as per the policy decision taken by the SEIAA all the cases of sand mining are now to be appraised based on the revised mine plan incorporating the additional chapter on annual replenishment of sand in the leased area and the normal water level prevalent in the lean season.

The committee also decided that all the cases of sand mining which are in the process of appraisal (list enclosed as Annexure-1) in SEAC may be sent back to SEIAA for want of revised mine plan incorporating the additional chapter on annual replenishment of sand in the leased area and the normal water level prevalent in the lean season and appraisal may be carried out only after receipt of revised mine plan.

2. **Case No. 741/2012 Shrimati Prabha Sigaria W/o Shri Dwarkanath Sigaria, Gandhi Road, Mehgaon, Distt. Bhind, M.P. Prior Environment Clearance for approval of 4.0 Hectares Stone Quarry (Capacity – 2,00,000 TPA) at Khasra No. 921/1 at Village Babi Tehsil Niwadi Dist. Tikamgarh M.P. (Capacity – 6840 cum/year as per mine plan)**

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 921/1 at Village Babi Tehsil Niwadi Dist. Tikamgarh M.P. 4.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-101 dated 12/02/2015, has reported that there is 01 more mine operating or proposed within 500 meters around the said mine and total area 8.0 ha including this mine.

During evaluation of the documents it was found that PP has applied in form-1 for production capacity of 2,00,000 TPA with lease area of 4.00 ha at Khasra no. 921/1 while submitted mine plan is approved for the production capacity of 6,840 cum/year with sanctioned lease area of 2.700 ha. The Director, Directorate of Geology and Mining Madhya Pradesh has also sanctioned QL for an area of 2.700 ha vides letter no. 15230 dated 22/08/2013. The committee after deliberations decided that PP may be asked to submit the revised form-1 with

correct area details of the lease area and production capacity as per approved mine plan through SEIAA.

2. **Case No. 755/14 Smt. Arti Shrivastava W/o Pankaj Shrivastava, Jawahar Road, IFO-Hospital, Mehgaon, Dist. Bhind Application for obtaining Environment Clearance for approval of 04.000 (Capacity – 6840 Cum/Year as per mine plan) Hectares Stone Quarry at Khasra No. 176, 177 at Vill. Babai, Tehsil Niwadi, District Tikamgarh.**

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 176, 177 at Vill. Babai, Tehsil Niwadi, District Tikamgarh (M.P.) 4.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-102 dated: 12/02/2015, has reported that there is no more mine operating or proposed within 500 meters around the said mines.

During evaluation of the documents it was revealed that PP has applied in form-1 for production capacity of 2,00,000 TPA with lease area of 4.00 ha at Khasra no. 176,177 while submitted mine plan is approved for the production capacity of 6,840 cum/year. As per the Google image based on the co-ordinate provided by the PP, the interstate boundary of Uttar Pradesh is approx. 60 meters from the QL areas however, as per the MoEF&CC Notification No. S.O. 141 (E) dated 15/01/2016 "General Conditions are not applicable for project or activity of minor minerals of category B-2 (up to 25 ha of mining lease area).

The EMS and other submissions submitted by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A.

- Production of Stone as per mine plan with quantity not exceeding 6,840 Cum/Year.
4. **Case No. - 1147/2013 M/s Bhim Awadhiya Stone Mines R/o Dindori, Tehsil & Distt. - Dindori,(M.P.) 481880 Environmental Clearance for Stone mine of an area of 1.00 ha. at Khasra No. 109/2 at village Ganeshpur, Tehsil-Dindori, Dindori (M.P.) (Capacity – 3325 cum/year as per mine plan)**

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 109/2 at village Ganeshpur, Tehsil-Dindori, Dindori (M.P.) 1.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-909 dated: 30/08/2014 & 535 dated: 14/5/15, has reported that there is no more mine operating or proposed within 500 meters around the said mines.

During evaluation of the documents it was revealed that PP has not submitted the certificate of DFO for distance from forest boundary and as per the Google image based on the co-ordinate provided by the PP a blue colored shade like structure was also seen in the QL area. Committee after deliberations decided that PP may be asked to provide:-

- (a) DFO certificate for distance from forest boundary.
 - (b) Details about the blue colored shade like structure observed in the QL area as per the Google image.
5. **Case No. - 1171/2013 Smt. Gayatri Rani W/o Gajraj Singh Sisodiya, Champi Mohalla, Narsingharh, Dist-Rajgarh Environmental Clearance for approval of Stone Boulder mine (1.00 Hectare) Cap. – 2500 Cum/Year, at Khasra No. – 425/1/2, Village - Bhojpuriya, Tehsil -Narsingharh, Distt. - Rajgarh (M.P.)**

This is case of **Stone Boulder Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 6425/1/2, Village - Bhojpuriya, Tehsil -Narsingharh, Distt. - Rajgarh (M.P.) 1.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-654 dated: 12/8/15, has reported that there is no more mine operating or proposed within 500 meters around the said mines.

During evaluation of the documents it was revealed that PP has not submitted the certificate of DFO for distance from forest boundary and maps of mine plan are not corresponding with the Khasra map attached with the file. Committee after deliberations decided that PP may be asked to provide:-

- (a) DFO certificate for distance from forest boundary.
- (b) Revised maps duly approved by the competent authority corresponding to the Khasra map.
- (c) Revised EMP with proposed budgetary details.

6. **Case No. – 1224/2013 Smt. Poonam Devi Gupta, Near Tuti Puli, Bharather, Seoni, Distt.- Seoni (M.P.) 480661 M/s Natraj Group Prior Environment Clearance for approval of Stone Mine in Area – 1.50 Ha., (6270 Cubic Meter/Year as per mine plan) at Khasra No. 32, PH. No. – 12, Village – Gangeura, Tehsil – Seoni, Distt. – Seoni (M.P.)**

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 32, PH. No. 612, Village 6 Gangeura, Tehsil 6 Seoni, Distt. 6 Seoni (M.P.) 1.50 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite

information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1107 dated: 17/09/2015, has reported that there are 06 more mines operating or proposed within 500 meters around the said mine and total area 16.35 ha including this mine.

During evaluation of the documents it was revealed that all the certificates are issued in the name of PP (Smt. Poonam Devi) are for Khasra No. 32 and Patwari Halka no. 13 while the maps attached with the mine plan are of Khasra No. 323 and map attached with the mine plan is of Khasra no. 202.

The committee after deliberations decided that PP may be asked to provide revised mine plans duly approved by the competent authority through SEIAA.

7. Case No. 1386/13 M/S. Shri Ashish Enterprises, 4-5, Industries Area, Neemuch (M.P.) Environment Clearance for approval of 04.00 (Capacity 75,000 Cum/Year as per mine plan) Hectares Stone/Boulder Quarry at Khasra No. 8,11, 12, 13, 23, 33 at Vill.-Suvakheda, Teh.-Jawad, Dist.-Neemuch (M.P.)

This is case of **Stone/Boulder Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 8,11, 12, 13, 23, 33 at Vill.-Suvakheda, Teh.-Jawad, Dist.-Neemuch (M.P.) 4.0 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-926 dated: 4/08/2015, has reported that there is 01 more mines operating or proposed within 500 meters around the said mine and total area 8.0 ha including this mine.

During evaluation of the documents it was revealed that maps attached with mine plan are not corresponding with the Khasra map and are also not legible. Committee after deliberations decided that PP may be asked to provide:-

- (a) Revised maps duly approved by the competent authority corresponding to the Khasra map.

8. Case No. - 1557/2013 Shri Rajendra Kumar Khateek, Village-Pchore, Tehsil-Dabra, District-Gwalior (M.P.) Environment Clearance for approval of 01.00 Hectare Metal stone quarry at Khasra No. – 654, Cap. – 5950 Cum/Year as per mine plan, Vill.- Pichore, Tehsil-Dabra, Distt.-Gwalior

This is case of **Metal Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 654, Vill.- Pichore, Tehsil-Dabra, Distt.-Gwalior (M.P.) 1.0 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-QL-87 dated: 7/09/2015, has reported that there is 01 more mine operating or proposed within 500 meters around the said mine and total area 2.0 ha including this mine.

During evaluation of the documents it was revealed that PP has not submitted the certificate of DFO for distance from forest boundary however other submission made by PP were found satisfactory. Committee after deliberations decided that PP may be asked to provide:-

- (a) DFO certificate for distance from forest boundary.

9. Case No. – 1629/2013 Shri Dinesh Kumar Khare S/o Shri Vishambhar Dayal Khare , Owner, M/s Khare Minerals, Village & Post – Mahewa, Tehsil – Amanganj, Distt. – Panna – (M.P.) – 488001 Prior Environment Clearance for approval of Metal Stone Lease Area – 1.00 ha. at Khasra No.- 2650 Village – Mahewa, Tehsil – Amanganj, Distt. – Panna (M.P.) Capacity – 19,200 Cubic Meter Year, Lease Period – 10 Year. (Quantity as per Mine Plan – 3990 Cum/Year)

This is case of **Metal Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.- 2650 Village ó Mahewa, Tehsil ó Amanganj, Distt. ó Panna (M.P.) 1.0 Ha. The project requires prior EC before commencement of any activity at site.

PP had submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.1924 dated: 18/09/2015, has reported that there is no more mine operating or proposed within 500 meters around the said mine.

The EMS and other submissions submitted by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-Aø

- Production of Metal Stone as per mine plan with quantity not exceeding 3,990 Cum/Year.

10. Case No. 2156/14 Shri Jai Singh Parte, Owner, Khomai, Bhesdehi, Betul (MP) Prior Environment Clearance for approval of proposed Basalt Stone Quarry in an area of 1.00 ha. at Khasra No. 49 at Village-Nimbhoura, Tehsil-Bhesdehi, District-Betul

This is case of **Basalt Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 49 at Village-Nimbhoura, Tehsil-Bhesdehi, District-Betul (M.P.) 1.0 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.1095 dated: 05/08/2015, has reported that there is no more mine operating or proposed within 500 meters around the said mine.

During deliberation it was observed by the committee that as per the Google image based on the co-ordinates provided by PP in surface map attached with mine plan the part of site falls in Maharashtra State. Thus committee decided that PP may be asked to provide correct co-ordinates of the site duly approved by the competent authority.

11. Case No. 2157/14 Shri Raghvendra Singh Kiledar, Owner, Bajar Chowk, Bhesdehi, Betul (MP)-460220 Prior Environment Clearance for approval of proposed Basalt Stone Quarry in an area of 0.70 ha. (Capacity 8550 Cum/Year) at Khasra No. 76/3 at Village-Pipariya, Tehsil-Bhesdehi, District-Betul

This is case of **Basalt Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 76/3 at Village-Pipariya, Tehsil-Bhesdehi, District-Betul (M.P.) 0.70 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.1282 dated: 10/09/2015, has reported that there is no more mine operating or proposed within 500 meters around the said mine.

The EMS and other submissions submitted by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -Aø

- Production of Basalt Stone as per mine plan with quantity not exceeding 8,550 Cum/Year
- 12. Case No. – 2175/2014 Shri Aviral Raghuwanshi, Project Manager, M/s Rajlaxmi Construction, New City Colony, A.B. Road, Guna (MP)-473001 Prior Environment Clearance for approval of proposed Basalt Stone & Murrum Quarry Lease Area – 1.80 ha., at Khasra No.-2/1, 2/2, 356/3,**

Capacity Basalt-38247 Cum/Year, Murram - 12769 Cum/Year, Village-Khamariya Dugaria, Tehsil-Narayanganj, District-Mandla (MP).

This is case of **Basalt Stone & Murram Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-2/1, 2/2, 356/3, Village-Khamariya Dugaria, Tehsil-Narayanganj, District-Mandla (M.P.) 1.80 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.977 dated: 10/10/2015, has reported that there is no more mine operating or proposed within 500 meters around the said mine.

During evaluation of documents it was observed that it is a case of TP where in one lease, two different areas were sanctioned which are not continuous and compact one. The committee is of opinion that lease granting authority may be requested to appraise rules under which they have sanctioned the lease.

13. Case No. – 2266/2014 Shri Parminder Singh, Niranjana Ward, Kareli, Narsinghpur (MP) Prior Environment Clearance for approval of proposed Basalt Stone Quarry in an area of 2.00 ha. at Khasra No.-128, Lease Period Ten Year at Village-Saleya Dube, Tehsil-Devri, District-Sagar (MP) (Quantity as per Mine Plan – 2850 Cum/Year)

This is case of **Basalt Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-128, at Village-Saleya Dube, Tehsil-Devri, District-Sagar (M.P.) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO.

Concerned Mining Officer vide letter no.116 dated: 24/2/2015, has reported that there is no more mine operating or proposed within 500 meters around the said mine.

During evaluation it was observed that a natural drain is in existence at a distance of 120 meters from QL area as per the Google image based on the co-ordinates provided by the PP.

On the basis of above committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

- Production of Basalt Stone Quarry as per mine plan with quantity not exceeding 2,850 Cum/Year.
- A natural drain is about 120 meters away from the site thus garland drain with settling tank of suitable capacity be provided all around the ML area.

14. Case No. 2494/2013 Shri Anupam Kumar Chaturvedi, Ward No. 5, Kali Dai Mohalla, Chandiya, Umariya (MP)-484660 Prior Environment Clearance for Metal Stone Quarry in an area of 2.00 ha. (15,000 cum/year) at Khasra No. – 91/1, Cap. – 15000 Cum/Year, Village-Raghopur, Tehsil-Chandiya, Dist-Umaria (MP)

This is case of **Metal Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 91/1 Village-Raghopur, Tehsil-Chandiya, Dist-Umaria (MP) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan and requisite information in the prescribed format duly verified by the Tehsildar and DFO.

During evaluation it was observed that as per the certificate issued by the DFO, Bandhavgarh National Park is within 10 kms of the QL area (a Notified PA) Clearance from NBWL is therefore needed. PP has submitted the copy of online application made for wild life clearance with proposal no. FP/MP/MIN/395/2015 and date of submission is 16/12/2015.

During evaluation it was observed that no maps are attached with the mine plan and also certificate of mining officer certifying the leases within 500 meters are not submitted by the PP. Thus the committee decided that PP may be asked to provide all the relevant maps of mine plan duly approved by the competent authority and certificate of mining officer certifying the leases within 500 meters.

15. Case No.- 2516/2015 Shri Anup Tiwari S/o Shri Shyam Sunder Tiwari, Guard Line, Damoh (M.P.)-470772 Stone Boulder Mine Lease Area - 2.250 ha., Capacity- 27,470 cum/year, at Vill.-Jujharpura, Th.-Bakswaha, Dist-Chhatarpur (M.P.)

This is a case of mining of *Basalt Stone Quarry*. The application was forwarded by SEIAA for appraisal. The proposed site is located Vill.-Jujharpura, Bakswaha, Dist-Chhatarpur(M.P.) in 2.250 ha., The project requires prior EC before commencement of any activity at site. PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar & Range Officer. Concerned Mining Officer vide letter no.1646 dated: 23/12/14 has reported that there are 09 more mines operating or proposed within 500 meters around the said mine and the total lease area is 13.712 Ha.

The case was presented in 207th. Meeting of SEAC dated 22/07/15 wherein it was observed that the certificate regarding information on forest has been issued by the Range Officer; the same has to be endorsed by the concerned DFO and submitted along with the production schedule for the left out lease period.

The case was discussed earlier in the 223rd SEAC meeting dated 15/09/2015 wherein Scrutiny of the case reveals that the PP has submitted the requisite information i.e. certificate of DFO. Based on the information submitted by the PP committee recommended the case for grant of prior EC.

SEIAA vide their letter no. 4206 dated 04/11/2015 has sent back the case for re-appraisal as site falls on the edge of the State Highway whereas as per the MMR 1996 (as amended up to 2013) the clear distance between the mining site and State Highway should not be less than 100 meters. In response to the above minutes of the SEIAA, PP has submitted a reply with revised co-ordinates which was placed before

the committee. After deliberations committee decided that since revised co-ordinates are submitted by the PP which is different from the co-ordinates mentioned in mine plan, PP may be asked to get them authenticated from the mining department.

PP vide letter dated 30/01/2016 has submitted the co-ordinates authenticated from the mining department (issued vide letter no. 304 dated 29/01/2016) which are different from the previous co-ordinates. As per the revised co-ordinates submitted by the PP it was observed based on the Google image that the QL area is approx. 90 meters away from the National Highway and approx 200 meters away from the water body.

The EMS and other submissions submitted by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :-A

- Production of Stone as per mine plan with quantity not exceeding 27,470 Cum/Year.
- A water body is about 200 meters away from the site thus garland drain with settling tank of suitable capacity be provided all around the ML area.
- Highway is about 90 meters away from the ML area thus a setback of 20 meters be left from the ML area excluding the 7.5 meters mandatory buffer zone.

16. Case No. 3749/15 Shri Mahesh Kumar Kothari, Station Road, Mandsaur (MP)-484001 Prior Environment Clearance for approval of Stone Quarry in an area of 2.00 ha. (10,830 cum/year) at Khasra no.-750, Vill.-Palewana, Tehsil-Malhargarh, District- Mandsaur (MP)

This is a case of mining of Stone Quarry. The application was forwarded by SEIAA for appraisal. The proposed site is located at Khasra no.-750, Vill.-Palewana, Tehsil-Malhargarh, District- Mandsaur (MP) in 2.0 ha., The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar & Range Officer. Concerned Mining Officer vide letter no.890 dated: 8/6/15 has reported

that there are 6 more mines operating or proposed within 500 meters around the said mine and the total lease area is 10.0 Ha.

As per the co-ordinates submitted by the PP it was observed based on the Google image that the QL area is approx. 10 meters away from the village road.

The EMS and other submissions submitted by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

- Production of Stone Quarry as per mine plan with quantity not exceeding 10,830 Cum/Year.
- Village road is approx. 10 meters away from the ML area thus a setback of 10 meters be left from the ML area excluding the 7.5 meters mandatory buffer zone.
