1. Case No.- 2519/2015 Shri Rameshwar Yadav, Vill.-Ramanna, Th.-Deori, Dist-Sagar (-M.P.)-470226 Stone Quarry Lease Area - 2.00 ha., Capacity- 18,000 cum/year at Khasra No. 5 at Vill.-Ramanna, Th.-Deori, Dist-Sagar (M.P.)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 5 at Vill.-Ramanna, Th.-Deori, Dist-Sagar (M.P.) 2.00 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1828 dated: 22/12/2015, has reported that there are 06 more mines operating or proposed within 500 meters around the said mine and total area 18.0 ha including this mine.

During scrutiny of documents it was found that certificate regarding distance from National Park/ Century and Eco-Sensitive Zone submitted by PP is issued by the Range Forest officer while while as per OM of SEIAA dated 03/08/15 such certificate is to be issued by Conservator of forest/ DFO. The PP was therefore asked to submit the same within 15 days time.

Concerned Mining Officer vide letter no.-280 dated: 15/4/2015, has reported that there are 01 more mines operating or proposed within 500 meters around the said mine and total area 3.30 ha including this mine.

On the basis of above committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure -A

- Production of Basalt Stone Quarry as per mine plan with quantity not exceeding 6,700 Cum/Year.
- A natural drain is about 300 meters away from the site thus garland drain with settling tank of suitable capacity be provided all around the ML area.

This is case of **Basalt Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-794, Vill.-Hatwakhas, Teh.-Sihawal, District-Sidhi (MP) 2.0 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-1459 dated: 08/12/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

During evaluation it was observed that as per the certificate issued by the DFO, Son ghariyal Abhayaran is 3.150 kms from the QL area (a Notified PA) Clearance from NBWL is therefore needed. However, as per the MoEF&CC Notification No. S.O. 141 (E) dated 15/01/2016 $\tilde{\text{G}}$ General Conditions are not applicable for project or activity of minor minerals of category B-2 (up to 25 ha of mining lease area). PP has submitted the copy of online application made for wild life clearance with proposal no. FP/MP/MIN/560/2015.

During evaluation of documents it was observed that as per the Google image based on the co-ordinated provided by the PP, it appears to be a virgin lease area. However in mine plan it is mentioned that lease was excavated for approx. 20,800 cum in last three years. The committee decided to call PP and RQP for clarification in upcoming meetings of SEAC with recent photographs of the excavated site.

- District Authority should record the deposition of sand in the lease area annually in the last week of September and maintain the records in RL (Reduce Level) Measurement Book. Accordingly authority may allow lease holder to excavate the replenished quantity of sand in the subsequent year.
- Evacuation of sand should not be allowed through the roads passing through the villages
- Heavy vehicles (Hywa) should not be allowed on Kachcha, narrow roads
- If causeway (Rapta) is required to be constructed for mining. It should be removed completely before rainy season every year.
- The river bank from where access ramps are made should be restored and access should be closed every year before rainy season.
- No diversion of active channel should be allowed for mining.
