PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no. 2207 dated: 02/12/2015 has reported that there are 05 more mines operating or proposed within 1000 meters around the said mine with total area of 47.920 ha including this mine.

The case was presented by the PP and their consultant and during presentation it was observed that concerned Mining Officer vides letter no.- 2207 dated: 02/12/2015 has reported that there are 05 more mines operating or proposed within 1000 meters around the said mine with total area of 47.920 ha including this mine. It being a case of cluster where the total area is > 25 ha. it was decided to consider this case as B-1 and committee recommended to issue standard TOR prescribed by MoEF&CC with following additional TORs:-

- 1. Detailed evacuation plan is to be discussed in the EIA report.
- 2. EIA/EMP is required to be prepared for entire cluster in order to cover all the possible externalities. The report should cover carrying capacity, transportation and other related issues for the cluster.
- 3. Photographs and maps depicting all the mines present in the cluster.
- 4. On a Google map, show all the mines in a cluster with all four co-ordinates of individual mines.
- 5. The date and duration of carrying out the base line data collection and monitoring be informed to the concerned Regional Officer of the M. P. Pollution Control Board.
- 6. Photographs of individual mine during EIA process with date.
- 7. Justify the production from each mine and also justify the duration when mining is possible.
- 8. If on the evacuation route there are human settlements justify how they will be protected or suggest alternate evacuation route.

- 9. Show on a map, where temporary storage facility of sand will be created along with environmental protection measures proposed for such storage facility.
- 10. Discuss and assess impacts of sand mining on pisciculture.
- 11. Discuss and assess impacts of sand mining on agricultural practices (such as growing of water melons etc) if taking place in the cluster area.
- 12. Discuss the measures that will be adopted for the bank erosion.
- 13. Indicate in EIA the structures such as bridges/barrages/dams close to individual leases in cluster and effects of mining on their structure stability with protection plan.
- 14. Provide the historical data of last 05 years about the sand already evacuated and the replenishment capacity of individual mine lease.
- 15. If a habitation is in close vicinity of ML area then possible impacts & mitigation measures be addressed in EIA.

(60,000 cum/year) at Khasra No.-326,</u> <u>Vill.-Neemkheda, Teh.-Shahpura, District-Jabalpur (MP)</u>

This is case of **Sand Quarry.** The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-326, Vill.-Neemkheda, Teh.-Shahpura, District-Jabalpur (MP) 22.07 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.---------- dated: ------- has reported that there is no more mines operating or proposed within 1000 meters around the said mine.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a monthøs time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

DISCUSSIONS ON QUERRY RESPONSES SUBMITTED BY PP AND FILES RECEIVED FROM SEIAA

This is case of **Bhadpura River Sand Mining**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. - 483, Vill.-Bhadpura, Teh.-Sahpura, District-Jabalpur (MP) 13.240 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer enclosing the combined NOC issued by collector certifying leases within 1000 meters radius around the site and requisite information in the prescribed format. Concerned Mining Officer vides letter no.-1960, dated: 15/10/15, has reported that there is no more mines operating or proposed within 1000 meters around the said mine. A railway line is passing through near the ML area which is approx 350 meters away.

The case was earlier discussed in the 243^{rd} SEAC meeting dated 07/12/15 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special condition in addition to the standard conditions at annexure $:B\alpha$

1. Production of Sand not exceeding 30,000 cum/year as per mine plan.

SEIAA vides their letter no. 12669/SEIAA/16 dated 29/03/2016 have forwarded the replenishment plan of the above lease.

The case was again discussed in the 16^{th} SEAC meeting dated 03/04/16 wherein the submissions made by PP were found satisfactory and acceptable and thus the committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure $\exists B\alpha$

- Production of Sand as per mine plan with quantity not exceeding 1,20,000 cum/year.
- District Authority should record the deposition of sand in the lease area at an interval of 100 meters annually in the last week of September and maintain the records in RL

(Reduce Level) Measurement Book. Accordingly authority may allow lease holder to excavate the replenished quantity of sand in the subsequent year.

- Evacuation of sand should not be allowed through the roads passing through the villages.
- Heavy vehicles (Hywa) should not be allowed on Kachcha, narrow roads.
- If causeway (Rapta) is required to be constructed for mining. It should be removed completely before rainy season every year.
- The river bank from where access ramps are made should be restored and access should be closed every year before rainy season.
- No diversion of active channel should be allowed for mining.

SEIAA vides their letter no. 934/SEIAA/16 dated 25/04/2016 has sent back the file to SEAC mentioning that

"After perusal of the recommendations of 16^{th} SEAC II meeting dated 03/04/2016, the earlier recommendation in the 243^{rd} SEAC meeting dated 07/12/2015 the production capacity was 30,000 cum/year as per mining plan. However, now the production capacity has been increased to 1,20,000 cum/year. SEAC should clarify the steep increase in the reported production capacity".

The above letter with case file was placed before the committee and scrutiny of the documents reveals that in this case the mine plan is approved for 1,20,000 cum/year and replenishment plan is also approved for 1,20,000 cum/year by the competent authority. PP has also made the application, EMP & presentation for the quantity of 1,20,000 cum/year. Committee after deliberations decided that the earlier recommendations made by in the 243rd SEAC meeting dated 07/12/2015 for 30,000 cum/year appears to be a typographical mistake as no reason is mentioned for reduction in the production quantity in the minutes and thus the recommendations made in the 16th SEAC II meeting dated 03/04/2016 for production capacity of 1,20,000 cum/year stands applicable .

15.Case No. - 3867/15 Shri Rohan Raghuvanshi S/o Shri Rajkumar Raghuvanshi R/o 233, Ward No. 15, Dayanand Vijay Puram, District-Shivpuri (MP)-473551. Prior Environment Clearance for approval of Sand Quarry in an area of 5.016 ha. (3,465 cum/year) at Khasra No. -390, 702, Vill.-Sohat, Tehsil-Shadora, District-Ashoknagar (MP)

This is case of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is at Khasra No. -390, 702, Vill.-Sohat, Tehsil-Shadora, District-

Ashoknagar (MP) 5.016 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-352, dated: 02/09/2015 has reported that there are no more mines operating or proposed within 1000 meters around the said mine.

The case was earlier presented in the 249^{th} SEAC meeting dated 14/12/0215 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure $\div B\alpha$

• Production of **Sand** as per mine plan with quantity not exceeding 3,465 cum/year.

SEIAA vides their letter no. 11910/SEIAA/16 dated 17/03/2016 have forwarded the replenishment plan of the above lease.

The case was again discussed in the 14^{th} SEAC meeting dated 22/03/16 wherein the submission made by PP were found satisfactory and acceptable and thus the committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure $\exists B \alpha$

- Production of Sand as per mine plan with quantity not exceeding 1,00,000 cum/year.
- District Authority should record the deposition of sand in the lease area at an interval of 50 meters annually in the last week of September and maintain the records in RL (Reduce Level) Measurement Book. Accordingly authority may allow lease holder to excavate the replenished quantity of sand in the subsequent year.
- Evacuation of sand should not be allowed through the roads passing through the villages.
- Heavy vehicles (Hywa) should not be allowed on Kachcha, narrow roads.
- If causeway (Rapta) is required to be constructed for mining. It should be removed completely before rainy season every year.
- The river bank from where access ramps are made should be restored and access should be closed every year before rainy season.
- No diversion of active channel should be allowed for mining.

• *Production of Sand as per mine plan with quantity not exceeding 3,465 cum/year.*

SEIAA vides their letter no. 11910/SEIAA/16 dated 17/03/2016 have forwarded the replenishment plan of the above lease.

The case was again discussed in the 14^{th} SEAC meeting dated 22/03/16 wherein the submission made by PP were found satisfactory and acceptable and thus the committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'B':

- Production of Sand as per mine plan with quantity not exceeding 1,00,000 cum/year.
- District Authority should record the deposition of sand in the lease area at an interval of 50 meters annually in the last week of September and maintain the records in RL (Reduce Level) Measurement Book. Accordingly authority may allow lease holder to excavate the replenished quantity of sand in the subsequent year.
- Evacuation of sand should not be allowed through the roads passing through the villages.
- Heavy vehicles (Hywa) should not be allowed on Kachcha, narrow roads.
- If causeway (Rapta) is required to be constructed for mining. It should be removed completely before rainy season every year.
- The river bank from where access ramps are made should be restored and access should be closed every year before rainy season.

"From the above recommendations it appears that SEAC has mentioned two production capacities i.e. 3465 cum/year and 1,00,000 cum/year. The case file may be sent to SEAC for clarification".

The above letter with case file was placed before the committee and scrutiny of the documents reveals that in this case the mine plan is approved for 3465 cum/year and replenishment plan is also approved for 3465 cum/year by the competent authority. PP has also made the application, EMP & presentation for the quantity of 3465 cum/year. Committee after deliberations decided that the earlier recommendations made in the 14th SEAC II meeting dated 22/03/2016 for production capacity of 1,00,000 cum/year is a typographical error and the production capacity should be read as 3465 cum/year as per the approved mine plan.

16.<u>Case No. – 2021/2014</u> Shri Lakhan Singh S/o Shri Arjun Singh, Jhangirpur Tehsil <u>Badnagar, Distt. Ujjain (M.P)</u> Sand Mine in an area of 5.960 ha. For Production <u>Capacity 87,360 cum/year at Khasra no.1, at Village-Malpura, Tehsil- Badnagar, Disst-</u><u>Ujjain (M.P)</u>

The case was earlier discussed in the 184th SEAC meeting dated 28/04/2015 wherein it is recorded that the case was discussed in the 176th meeting dated 26/02/2015 and recommended based on the presentation made by the PP. However, it was observed that the PP has not submitted a copy of letter from Mining Officer certifying the no. of mines and their lease area within 500 meters around the said mine. The same has not been submitted till dated. It was decided to ask the PP to submit the requisite information within 15 days. After which the case shall be returned to SEIAA for delisting assuming that the PP is not interested to continue the project.

The case was placed before the committee wherein it was observed that so far PP has not submitted the desired information and case is pending for a long time. The committee after deliberations decided that this case may be sent back to SEIAA for delisting as PP has not submitted the desired information and replenishment plan as per policy decision taken by SEIAA in its 284th meeting dated 23/01/2016.

This is a case of mining of sand. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located *at Khasra no.-650, at Vill.-Kheda Narela, Th.--Badod, Dist-Agar Malwa (M.P.)* in 12.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 136 dated 06/05/2015 has reported that there is one more mine operating / proposed within 1000 meters around the said mine and the total lease area is 20.7 Ha.

• It was observed that the proposed location is in River Kalisindh. The location as presented in Google image is not clear hence it was decided to verify the location and nearby landuse physically through the MPPCB.

This case was again placed for discussion as during scrutiny of document it was observed that so far PP has also not submitted the replenishment plan as per the decision of the SEIAA in 284th meeting dated 23/01/2016. The committee decided that the case may be sent back to SEIAA for replenishment plan as per the policy decision.

18. <u>Case No. – 2196/2014 Shri Bhupendra Singh Rao, GM, M/s Mine Corp India Pvt. Ltd.,</u> <u>14-A, Globus City, Kolar Road, Chuna Bhatti, Bhopal (MP)-462016 Sand Stone (Farshi</u> <u>Patthar) Quarry Lease Area – 3.950 ha., Capacity- 30000 Cu.mt./Year, at Khasra No. –</u> <u>210, 212, 214, Village-Sunnd, Tehsil-Raisen, District-Raisen (MP).</u>

This is a case of mining of Sand- stone (Farshi Patthar). The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located *at Khasra No. – 210, 212, 214, Village-Sunnd, Tehsil-Raisen, District-Raisen (MP)* in 3.950 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 865 dated 27/09/2014, that 09 mines are operating / proposed within 500 meter radius around the said mine the total lease area being 22.104 Ha. PP has reported that the pit formed after mining shall be developed into a water body.

The case was earlier discussed in the SEAC 168th SEAC meeting 11/01/2015 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions:

- 1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- 2. The mined out pits shall be developed into water body being appropriately fenced and with safe stairway.
- 3. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
- 4. Transportation of material shall be done in covered vehicles.
- 5. Necessary consents shall be obtained from MPPCB and the air pollution control measures have to be installed as per the recommendation of MPPCB.
- 6. Permission / NOC shall be obtained from Gram Panchayat for lifting water from the village resources and shall be furnished to MPPCB while obtaining necessary consents under the provisions of Air / Water consents.
- 7. Curtaining of site shall be done using appropriate media.
- 8. Production of Sand stone (Farshi Patthar) shall be as per the mining plan not exceeding 30,000 m³/Year and maximum average depth of pits shall not exceed12 meters.
- 9. The proposed plantation should be carried out along with the mining and PP would maintain the plants for five years including casualty replacement.
- 10. Transportation shall not be carried out through forest area.
- 11.PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
- 12. Appropriate activities shall be taken up for social up-liftment of the Region. Funds reserved towards the same shall be utilized through Gram Panchayat.
- 13. The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product mix in proposed mining unit shall require a fresh Environment Clearance.

This case was also discussed in SEIAA in their 202, 211 and 225 meetings and case was sent back to SEAC for re-appraisal vides their letter no. 11211/SEIAA/16 dated 11/02/2016.

Case was placed before the committee as PP vides their letter dated 12/04/2016 (inward no. 3759 dated 13/04/2016) has requested for the withdrawal of their project/cancellation of their application. The committee after deliberations decided that the case may be sent to SEIAA for its withdrawal on the basis of PPøs request.

19. <u>Case No. – 2624/2015 Shri Bhupendra Singh Rao, GM, M/s Mine Corp India Pvt. Ltd.,</u> <u>14-A, Globus City, Kolar Road, Chuna Bhatti, Bhopal (M.P.)-462016 Sand Stone</u> <u>Quarry Lease Area - 3.950 ha., Capacity - 75,300 cum/year, at Village-Sunnd, Teh.-</u> <u>Raisen, Distt.- Raisen (M.P.).</u>

This is case of Sand Stone mining. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Village-Sunnd, Teh.-Raisen, Distt.- Raisen (M.P.) **3.950 ha.** The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no. 728 dated: 29/7/15, has reported that there is 06 more mines operating or proposed within 500 meters around the said mine and total area 16.845 Ha.

The case was recommended in the 191^{st} . SEAC meeting dated 07/05/15 for grant of EC. But SEIAA in its 206^{th} . meeting dated 08/06/15 has observed that as per report of the mining officer, Raisen, a cluster of more than 25.00 ha is being formed in the area and thus case be considered as B-1 and accordingly TOR may be issued.

The case was placed in the 214th. meeting dated 20/08/15 for decision but from the available documents there was no clarity on cluster information. PP was therefore asked to submit a map of the area showing locations of various mines.

The case was discussd in the 223rd SEAC meeting dated 15/09/2015 wherein in response to query raised by SEAC, PP has submitted a reply on 09/09/15 enclosing a letter from mining officer issued on dated 29/07/15 stating that total area within 500 meters of the mine including this mine is 20.7950 ha. After deliberations and considering the views of SEIAA & report of Mining officer, committee decided to carryout site visit by a sub-committee to ascertain the environmental sensitivity issues for further decision.

The inspection report carriedout by the committee was discussed in the 252nd SEAC meeting dated 17/12/2015 wherein after deliberations, committee decided all the three mines are to be considered as B-1 category and EIA may be considered. However before TOR is issued for the individual sites, PP has to submit the precise co-ordinates of the ML area because as per the co-ordinates given for each site there is overlapping of area in two sites and in one case even the two sites have similar co-ordinates. The committee is off the view that PP may be asked to furnish co-ordinates for all the sites duly authenticated by the mining department for issuance of TORs.

Case was placed before the committee as PP vides their letter dated 22/03/2016 (inward no. 3651 dated 24/03/2016) has requested for the withdrawal of their project/cancellation of their application. The committee after deliberations decided that the case may be sent to SEIAA for its withdrawal on the basis of PPøs request.

This is case of Sand Stone mining. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Village-Sunnd, Teh.-Raisen, Distt.- Raisen (M.P.) **3.00 ha.** The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no. 729 dated: 29/7/15, has reported that there is 06 more mines operating or proposed within 500 meters around the said mine and total area 19.581 Ha including this mine.

The case was recommended in the 191st. SEAC meeting dated 07/05/15 for grant of EC. But SEIAA in its 206th. meeting dated 08/06/15 has observed that as per report of the mining officer, Raisen, a cluster of more than 25.00 ha is being formed in the area and thus case be considered as B-1 and accordingly TOR may be issued.

The case was placed in the 214th. meeting dated 20/08/15 for decision but from the available documents there was no clarity on cluster information. PP was therefore asked to submit a map of the area showing locations of various mines.

The case was discussd in the 223rd SEAC meeting dated 15/09/2015 wherein in response to query raised by SEAC, PP has submitted a reply on 09/09/15 enclosing a letter from mining officer issued on dated 29/07/15 stating that total area within 500 meters of the mine including this mine is 22.581 ha. After deliberations and considering the views of SEIAA & report of Mining officer, committee decided to carryout site visit by a sub-committee to ascertain the environmental sensitivity issues for further decision.

The inspection report carriedout by the committee was discussed in the 252nd SEAC meeting dated 17/12/2015 wherein after deliberations, committee decided all the three mines are to be considered as B-1 category and EIA may be considered. This is case of Sand Stone mining. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Village-Sunnd, Teh.-Raisen, Distt.-Raisen (M.P.) **3.237 ha.** The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no. 727 dated: 29/7/15, has reported that there is 08 more mines operating or proposed within 500 meters around the said mine and total area 18.867 Ha.

The case was recommended in the 191st. SEAC meeting dated 07/05/15 for grant of EC. But SEIAA in its 206th meeting dated 08/06/15 has observed that as per report of the mining officer, Raisen, a cluster of more than 25.00 ha is being formed in the area and thus case be considered as B-1 and accordingly TOR may be issued.

The case was placed in the 214th meeting dated 20/08/15 for decision but from the available documents there was no clarity on cluster information. PP was therefore asked to submit a map of the area showing locations of various mines.

The case was discussd in the 223rd SEAC meeting dated 15/09/2015 wherein in response to query raised by SEAC, PP has submitted a reply on 09/09/15 enclosing a letter from mining officer issued on dated 29/07/15 stating that total area within 500 meters of the mine including this mine is 22.581 ha. After deliberations and considering the views of SEIAA & report of Mining officer, committee decided to carryout site visit by a sub-committee to ascertain the environmental sensitivity issues for further decision.

The inspection report carriedout by the committee was discussed in the 252nd SEAC meeting dated 17/12/2015 wherein after deliberations, committee decided all the three mines are to be considered as B-1 category and EIA may be considered. However before TOR is issued for the individual sites, PP has to submit the precise co-ordinates of the ML area because as per the co-ordinates given for each site there is overlapping of area in two sites and in one case even the two sites have similar co-ordinates. The committee is off the view that PP may be asked to furnish co-ordinates for all the sites duly authenticated by the mining department for issuance of TORs.

Case was placed before the committee as PP vides their letter dated 22/03/2016 (inward no. 3650 dated 24/03/2016) has requested for the withdrawal of their project/cancellation of their application. The committee after deliberations decided that the case may be sent to SEIAA for its withdrawal on the basis of PPøs request.

Following standard conditions shall be applicable for the mining projects of minor mineral in addition to the specific conditions:

Annexure- 'A'

Standard conditions applicable to Stone/Murrum and Soil quarries:

- 1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- 2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
- 3. Transportation of material shall be done in covered vehicles.
- Necessary consents shall be obtained from MPPCB and the air/water pollution control measures have to be installed as per the recommendation of MPPCB.
- 5. Curtaining of site shall be done using appropriate media.
- 6. The proposed plantation should be carried out along with the mining @45 trees per hectare and PP would maintain the plants for five years including casualty replacement.
- 7. Transportation shall not be carried out through forest area.
- 8. Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.
- 9. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
- 10. PP should maintain a log book wherein daily details of water sprinkling and vehicle movement are recorded and in extream summer season hourly road wetting be done.
- 11. PP should also maintain a log book containing annual details of tree plantation and causality replacement.
- 12. The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product mix in proposed mining unit shall require a fresh Environment Clearance.

Annexure- 'B'

Standard conditions applicable for the sand Mine Quarries*

- 1. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- 2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
- 3. Plantation shall be carried out on the banks for stabilization of the banks above high flood level and a log book be maintained.
- 4. The mining activity shall be done manually.
- 5. Heavy vehicles shall not be allowed on the banks for loading of sand. PP should maintain a log book wherein daily details of water sprinkling and vehicle movement are recorded and in extream summer season hourly road wetting be done.
- 6. The sand shall be transported by small trolleys up to the main transport vehicle.
- 7. Transport vehicles will be covered with taurpoline to minimize dust/sand particle emissions.
- 8. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
- 9. No Mining shall be carried out during Monsoon season.
- 10. The depth of mining shall be restricted to 3m or water level, whichever is less.
- 11. No in-stream mining shall be allowed.
- 12. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
- 13. Established water conveyance channels should not be relocated, straightened, or modified.
- 14. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
- 15. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
- 16. PP shall take Socio-economic activities in the region through the 'Gram Panchayat'.
- 17. EC will be valid for mine lease period subject to a ceiling of 5 years.
