

Scrutiny and discussion on the responses could not be taken up due to shortage of time in the 126th SEAC meeting dated 10/04/2013. Hence it was decided by the committee unanimously that Sri AP. Srivastava, Member SEAC and the Member Secretary may hold a meeting on convenient date to scrutinize, discuss and recommend disposal of the responses received against queries raised by the committee during appraisal of these cases.

Accordingly, the sub-committee comprising of Shri R.K. Jain, Member Secretary SEAC and Shri A.P. Srivastava, Member SEAC met on 17th April 2013 in the office of MPPCB, Bhopal. Project wise observations and recommendations are summarized below:

The case was dealt in the 101st meeting dated 22/08/2012. TOR was recommended for the project. However in view of guidelines of SEIAA the project file was returned to SEIAA for re-screening the project. SEIAA has forwarded the project file for appraisal of the case in view of revised guidelines. The project as per the present guidelines apparently falls under B-2 category. Scrutiny of the case reveals that:

The maximum production has to be restricted to 28000 m³ / Year and the maximum average depth of all the pits should not exceed 7 meters at the end of 10 years subject to the following:

SEIAA has forwarded the project file for appraisal of the case in view of revised guidelines. Scrutiny of the case reveals that another stone mine of 1.5 ha has been allocated by the mining department within 250 meters from the proposed site. Thus the aggregate mining area in 250 meter radius shall be 5.5 ha. As per the guidelines of SEIAA, EIA studies have to be carried out for the complete area considering all existing / proposed mines in vicinity. Standard TORs' shall be applicable including Public Hearing.

1. Clear NOC from the competent authority of Forest department.
2. Status of private land acquisition to be furnished.
3. Activity wise budget break-up for CSR activities to be submitted.

4. Copy of approved mining Plan and mining lease to be submitted.
5. Executive Summary of the EIA/EMP to be submitted.
6. All monitoring reports in the original format as provided by the NABL approved laboratory.

PP has responded to the above queries. The EIA / EMP and other submissions made by the PP were found to be satisfactory and acceptable hence the case is **recommended** for grant of prior EC subject to the following special conditions:

1. Grant of prior EC will not give any right to the PP while acquiring the land from private owners. Private land will be acquired through the State land Authority following all existing Rules & Regulations in this regard and ensuring that the person in possession of private land is satisfied.
2. The murrum-waste being generated from the mining shall not be allowed to sell out and shall be used for land reclamation.
3. Plantation shall be taken up along with the other mining activities in consultation with the local forest authorities.
4. The PP shall maintain the village roads in the vicinity in consultation with Gram Panchayat.
5. Quality of the water accumulated in the pits shall be regularly monitored.
6. The Garland drains around the OBs' shall be connected to the settling tank of appropriate size.

3. Case no. 185/2008 - **Shri Vijay Gupta, M/s V. S. Mineral and Co. 38-A, Daya Nagar, Jabalpur (M.P) Sejha Limestone, Dolomite & Barytes Mine, Teh.-Sejha, Dist.-Katni. Mining Lease Area 10.21 ha. Prod. Cap. 5000 T/A TOR issued 12/09/08; Revised TOR issued 03/07/09.**

The EIA report was discussed in the 47th SEAC meeting dated 29/01/2010 whereby the committee has sought following information and details from the PP:

- Full details of the nearby habitation with exact distances from the lease boundary and population etc.
- Permission for mining from irrigation department has to be obtained in view of recommendation of public hearing panel and proximity to the irrigation reservoir.
- In compliance to the suggestions of public hearing panel, a Geo-hydrological study of the area has to be conducted and action plan to be submitted based on the recommendations of the studies.
- Declaration from the PP and the consultant regarding use of authentic data / facts /figures in the EIA /EMP to be furnished.
- Use of Solar energy for utilities has to be explored and implemented.
- Analyses report in original format to be submitted.

PP has responded to the above queries. The EIA / EMP and other submissions made by the PP were found to be satisfactory and acceptable hence the case is **recommended** for grant of prior EC subject to the following special conditions:

- Plantation shall be taken up along with the other mining activities in consultation with the local forest authorities.
- The PP shall maintain the village roads in the vicinity in consultation with Gram Panchayat.
- Quality of the water accumulated in the pits shall be regularly monitored.

- The Garland drains around the OBs' shall be connected to the settling tank of appropriate size.
- Total Production of *Limestone, Dolomite & Barytes* shall be 5000 T/A.
- Transportation shall not be carried out through forest area.
- PP shall take CSR activities in the region through the 'Gram Panchayat'.

4. Case no. 672/2012 - **Shri Prakash Sondhiya S/o Shri Ram Dulare Sondhiya, R/o Nai Basti, P.O. & Distt. Katni (M.P.) 483501 Bichhiya Laterite & Fire Clay Deposit KhasraNo. P 409 at Village – Bichhiya, Tehsil – Murwara, Distt. – Katni (M.P.) Lease area – 9. 084 ha. Capacity – 75,000 TPA**

PP has submitted a letter stating that the TOR for the project has been issued in name of Shri Ram Dulare Sondhiya father of Shri Prakash Sondhiya. Instead of Shri Prakash Sondhiya. PP has requested to make the amendment in name accordingly. After examining the case committee has accepted the request of PP for making necessary change in name.

5. Case No. 565/2010- **Smt Urmila Tripathi Candmari Road Dhawari Distt. Satna (M.P) For –TOR** Limestone & Laterite Mine 8.09 Ha at Village- Tihari, Tehsil- Rampur Baghelan Distt. Satna (M.P).

PP has requested for extension in validity of TOR by one year. PP also intend to enhance the production capacity from 5000 MT / Year to 50000 MT/ Year. From letter it appears that the PP has submitted revised application and other papers to SEIAA, the same have not yet been forwarded from SEIAA, hence committee decided to hold the case until original papers are received from SEIAA.

6. Case no. 574/2010 **Shri Somendra Singh & Shri Amar Singh Malti Mandir Ghoghar, P.O. & Distt. Rewa (M.P) Begoudi Limestone mine 8.09 Ha at village- Begoudi Tehsil- Amarpatan Dist- Satna (M.P), production capacity- 20,000 MTA Limestone & 10,000 TPA Reject stone. – For TOR [Env. Consultant- M/s Bhagwati Analab, Hyderabad.] ToR Issued letter No. 574 dt. 27/09/10**

TOR was issued for the project vide letter dated 27/09/2010. PP has requested an extension in validity of TOR by one year in light of MoEF Circular dated 22/03/2010. It was reported by the PP that Public Hearing for the project has already been conducted and a delay in submission of final EAI has been caused while submitting the papers sought by SEIAA.

Committee decided to allow an extension in the validity of TOR maximum by one year i.e. up to 26/09/2013 in accordance to the MoEF circular dated 22/03/2010. PP shall have to submit the final EIA / EMP within the extended period. No further extension shall be considered.

7. Case No. 579/2010 - **M/s Sandesh Developers & Builders, Plot No.- 1, Gopal Nagar, Nagpur (M.H.) 440022 - Manganese Ore Mine at Khasra No.- , Village – Kamthi, Tehsil – Lalbara, Distt. – Balaghat (M.P.) Lease Area – 17.558 ha. Capacity – 858 TPA Env. Consultant: M/s Creative Enviro Services, SR-4, Shriram Kunj, E-8, Bharat Nagar, Arera Colony, Bhopal ToR issued vide letter no 84 dt 26/02/11**

The EIA report of the project was presented in the 110th meeting dated 04/12/2012. After deliberations committee has asked the PP for submission of following information along with the supporting documents:

1. Details of Corporate Environmental Responsibility as per the MoEF O.M.
2. Details of private land procurement and compensation etc. so as to respond the public hearing issue.
3. Water quality has to be re-checked.
4. Analyses reports being carried out by NABL / EPA / MoEF approved laboratory to be submitted in original format.
5. Mine life to be reported considering the total deposits vis-à-vis annual production capacity.
6. Ultimate land-use plan at the end of mine life to be furnished along with the conceptual plan for the same.
7. Details of the proposed water reservoir (0.5 hectare) to be furnished along with the Conceptual plan of the same.
8. Plantation scheme with conceptual plan of the same to be furnished.
9. Water requirement for the project with source and permission from the concerned authority to be furnished.
10. Use of the mined out mineral (Manganese Ore) to be submitted.

PP has submitted response to above queries. The EIA, EMP and other submissions made by the PP were found to be satisfactory and acceptable. Thus the committee decided to recommend the case for grant of prior EC subject to the following special conditions:

1. Grant of prior EC will not give any right to the PP while acquiring the land from private owners. Private land will be acquired through the State land Authority following all existing Rules & Regulations in this regard and ensuring that the person in possession of private land is satisfied.
2. Plantation shall be taken up along with the other mining activities in consultation with the local forest authorities.
3. The PP shall maintain the village roads in the vicinity in consultation with Gram Panchayat.
4. Quality of the water accumulated in the pits shall be regularly monitored.
5. The Garland drains around the OBs' shall be connected to the settling tank of appropriate size.

8. Complaint: Case No. 1104/2013 **Shri Vijay Tiwari Deshbandhupura- Itarsi, Tehsil - Itarsi , Distt. – Hoshangabad (M.P.) 461111- Murum / Stone quarry at Khasra No. – 361/11, Village –Nagpurpur Kalan, Tehsil – Itarsi, Distt. – Hoshangabad (M.P.) Lease Area – 1.124 ha., Proposed Capacity – Murum - 1,000 m³/Year & Stone – 200 m³/Year. Lease period - 2 years.**

Complaint from a News Paper - 'Jan Samaalochana' has been forwarded by SEIAA. The concerned project has already been recommended by SEAC in its meeting dated 01/02/2013 and is with SEIAA for further consideration. The complaint mainly pertains to un-safe distances of the mining site from habitation, School, water –body and Aanganbadi. Also it has been pointed out that the mine pits are deep and filled with water.

In above context, committee is of the opinion that SEIAA may further like to take cognizance of the said complaint for necessary action in the matter. However, following may also be considered while scrutiny of the case at SEIAA:

- Local authorities must have confirmed the safe distances while allotment of the said mine.
- The maximum depth of mine-pit may be restricted to 0.5 meters from the existing ground level. This may be imposed as one of the conditions if project is approved by SEIAA for grant of prior EC.

9. Case No. – 820/2012 **M/s Naman Equipments & Construction (India) Pvt. Ltd. 115 Diamond Trade Centre, Diamond Colony, Indore (M.P.) " Nariman Point" of M/s Naman Equipments & Equipments & Construction (India) Pvt. Ltd. Khasra No. 101/2/1/1, 104/1, 104/2, 107/1, 107/2, 107/3, 107/4, 108/2, 119/2,117, 118/1, 118/2, 113, 114, 115, 121/1, 123/2/1, 101/1, 115/1, 97, 98, 101/2/2, 106, 119/1, 108/1, 120. Village – Pipliya, Tehsil& Distt.- Indore (M.P.) Total Land Area – 18,890.00 Sq.m., Total Built-up Area – 25,132.62 Sq.m**

The case was presented before the committee in the meeting dated --- after deliberations PP was asked to submit response to the following queries raised by the committee:

1. A letter from TNCP & Municipal Corporation to be furnished stating that the permissions issued by these departments have been transferred in name of the present proponent of the project.
2. An affidavit has to be provided stating that all rights have been transferred to M/s Naman Equipments & Construction (India) Pvt. Ltd
3. Memorandum of Article as Registered Private Company to be furnished.
4. Specification of MSW storage facility with provision to hold the MSW at least for 48 hours to be furnished.
5. Ground water recharging has been proposed in the project; in this context figures and calculations for net recharge / net drop-down to be furnished based on the hydro-geology of the region.
6. Car parking space has to be re-calculated comparing the norms of CPCB and State authority.
7. Water supply from ground as well as from Municipal Corporation has been opted in the project; in this context PP is required to submit permission from CGWA as well as from Indore Municipal Corporation along with the time line for completion of Narbada water scheme.
8. Locations of STP, MSW storage area and bins have to be relocated such that the transfer of wastes can be facilitated with minimum disturbance to the residents of the township.
9. Provision for play ground has to be explored and furnished.
10. Provision of corpus funds for O & M of STP and other environmental issues has to be made in the project.

Proponent's response received was scrutinized and following observations were made by the committee:

Responses to the queries at SN 1 & 2 have not been submitted up to the mark and responses to some of the queries are not clear. Hence it was decided to call the PP in the meeting scheduled for May 2013 to explain the response.

10. Case No. 1170/2013 (Qry. 120th SEAC Meeting dt. 27th Feb. 13) **Gyanjeet Sewa**

Mission Trust, Jabalpur through Shri Amandeep Khanna, Sukh Sagar Motors, Sukh Sagar Valley, Polipathar, Narmada Road, Jabalpur (M.P.) – 482001 Sukh Sagar Medical College and Hospital Owner of Land: Gyanjeet Sewa Mission Trust, Promoters : Gyanjeet Sewa Mission Trust, Jabalpur at Khasra No.- 1/2, 2/3, 3/3, 4, 5, 6, 7 and 8, Village – Chargawan, Jabalpur (M.P.) Total Land Area – 11.04 ha. , Total Built Up Area – 104685.65 sq. mt.

The case was presented before the committee in the 123rd meeting dated 12/03/2013 after deliberations PP was asked to submit response to the following queries raised by the committee:

1. The project developers are reported to be Gyajeet Sewa Mission Trust and Khanna Properties and Infrastructure 17, Naya bazar, Jabalpur (MP) and the land documents are in name of Khannas hence an agreement has to be made between the two proposed developers clearly mentioning the responsibilities to be shared by each of them pertaining to compliance of EC conditions and other environmental issues.
2. An affidavit has to be furnished stating that no construction activities have been initiated at site and that the same status shall be maintained till obtainment of prior EC for the project.
3. Copy of registration certificate issued by competent authority so as to support legal entity of the Gyajeet Sewa Mission Trust to be submitted.
4. Quantity, treatment and disposal of sewage water expected to generate from the complex to be reported.

It was decided to place the reply especially the papers pertaining to land and society before the full committee in presence of the Chairman for further decision in the matter.

11. Case No. – 1194/2013 – **M/s Balaji Infra Structure Company, Wardhman Towers, Russel Chowk, Napier Town, Jabalpur (M.P.) 482001 Group Housing Project Khasra No. – 151, 152, 155, 156, 157, 158, 159, 160 & 161, Village – Purva, Tehsil & Distt. – Jabalpur (M.P.) Total Plot Area = 11,517.35 m³, Proposed FAR= 22,999.3 m³, Built Up Area = 31,729.38 m³**

The case was presented before the committee in the meeting dated --- after deliberations PP was asked to submit response to the following queries raised by the committee:

- Two roads on either side of the core residential sector should have connectivity from between the residential blocks also through cross-roads. Provision of the same has to be made; stilt-parking area may be used for the same. Lay-out with above provisions has to be furnished.
- Shoot system has been planned for collection of MSW from individual flats; effective operation of the same has to be ensured by providing adequate ventilation and pumping arrangement to avoid accumulation and unhygienic conditions. The planned arrangement in this context to be furnished.
- Arrangement of wheel trolleys for every shoot system and adequate pathway has to be made for collection & transfer of MSW from the residential blocks- proposal with commitment to submit.
- Water supply for the project has been planned from the proposed water supply scheme of the Municipal Corporation; if for reasons the scheme of organized water supply is delayed what back-up arrangement is planned by the PP.

- Installation of bio-compost reactor for MSW has been planned for the project; this option appears to be less feasible as it shall require appointment of professional operators and industrial approach to effectively operate such a system, which may not be possible for the resident's society. Thus, MSW should be disposed off in to the designated land-fill site of the corporation, accordingly commitment and permission from Municipal Corporation to be furnished.
- The sludge from STP is proposed to be dried in the sludge-drying beds (SDB), PP failed to show the space for the SDB in the project. However, it is suggested that the STP sludge may be separated using centrifuge and the separated sludge can than be disposed off along with the MSW in to the land-fill site.
- Stacks to be provided with the DG-sets have to be depicted on the lay out map and furnished.
- Provisions for water storage for the proposed DG sets to be made and submitted.
- Plantation scheme with provisions of double row plantation along the project boundary has to be submitted.
- Out of two open areas reserved for gardens on e area may be reserved for play ground for the children, accordingly proposal to be submitted.

Proponent's response received was scrutinized and following observations were made by the committee:

Responses to the queries are neither clear nor self explanatory. Hence it was decided to call the PP in the meeting scheduled for May 2013 to explain the response.

12. Case No. – 439/2009 **M/s Sukhdeo Prasad Goenka, Goenka Bhawan, Station Road, Katni, Distt. – Katni (M.P.) – 483 501 For –EIA Presentation.** *Puniya Manganese Mine, Area - 8.00, Ha., Capacity. - 3430 TPA at Village- Puniya, Tehsil - Katangi, District - Balaghat (M.P.)*

After deliberations committee has asked the proponent to submit response to the following **queries** immediately for further action in the matter:

1. A fund reserved for CSR activities is inadequate. Also no budget has been provided for execution of EMP and environment monitoring program. The above has to be submitted with activity-wise break-up.
2. The public hearing proceedings reveals that there were objections from some participants; PP has failed to provide satisfactory response and clarification in the matter. Panel members have also not commented on the issue. Thus clarification on the same may be sought from the proponent as well from the Local Administration.

The response to the above queries was submitted by the PP and was scrutinized in the meeting. It was observed that the explanation given for point no. 2 is not yet clear. Presentation made by the PP before the committee in 122nd meeting dated 11/03/2013 revealed following:

Anantram and others- stated that they are doing farming on the said land since long. Previously about 60-70 years back it was in name of their ancestors but now their names have been dropped by the contractor. However farming is continue on the basis of Jot and Kabja which is their livelihood. Thus there was demand from them that lease should not be given for mining.

Dhaniram and others- stated that they are residing permanently at pawatri halka no 6 and

engaged in farming since ancestral period on khasara no. 485/1k, 485/2, 486/1k, 486/2, 487, 488, 489, 490, 491/1, 493, 494, 495/1, 496/1, 497, 498, 499, 465-467, 523/5. In the year 1977-78 they have been charged for encroachment also and penalized financially for three times. The said penalties were paid to the Govt.

Considering the same, Patta was demanded for the affected farmers, which has not been given till date. PP has not provided satisfactory response to the above objections. The same may be asked from the proponent.

These minutes shall be placed in the ensuing meeting of SEAC to be held during 7th & 8th May 2013.
