The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

This is a case of mining of stone bolder. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-22/1, 24, Village-Palasia, Tehsil-Anjad, District- Barwani (MP) in 2.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. - 5. Case No. - 697/2012 Executive Engineer WRD Div. Seoni, Distt.- Seoni (M.P.) Seoni Kachnamandi (Medium) irrigation project(Main Dam at Sathakala Teh-Barghat, Distt-Seoni. - Withdrawal of the application for EC. SEIAA letter no. 2524 dt. 04/12/2014**

Request of PP (vide E-in-C letter no. 2234 dated 10/11/2014) for withdrawal of their application filed before the SEIAA for prior EC was forwarded by SEIAA for further necessary action. It was observed that PP wish to withdraw their application seeking prior EC in light of MoEF Gazette Notification dated 25/06/2014. MoEF vide said notification has exempted irrigation project with proposed CCA of 2000 ha. This project comprises a CCA of 1980 Ha, which is less than the prescribed thresh-hold, hence committee decided to return the case to SEIAA recommending delisting of the project.

- 6. Case No. – 1941/2014 Shri Pradeep Singh, Byohari, Dist-Shahdol (MP) River Sand Quarry in an area of 9.800 ha. at Khasra No. – 247, Village-Barachh, Tehsil-Jaisinghnagar, District-Shahdol (MP) Capacity - 57780 Cubic mt. /Year.**

Case was discussed in the 159th meeting dated 01/12/2014. PP was asked to re-submit the application form-1 in view of changed production capacity. The same was submitted by the PP to SEIAA and forwarded to SEAC by the SEIAA vide letter No. 2764 dt. 23/12/14. It was decided to call the PP in coming meeting as per turn.

- 7. Case No. 1745/2014 Shri Nilesh Patel S/o Shri Arvind Patel R/o Goswami Tulsidas Marg, Near Dr. Adhikari- Sanawad, Tehsil – Badwah, Distt. – Khargone (M.P.) 45111 Morghadi Stone Quarry at Khasra No. – 323, 327, 321, 332, 336 and 319 Village- Morghadi, Tehsil – Punasa, Distt. – Khandwa (M.P.) Lease Area – 1.25 Ha., Lease Period – 10 Year , Capacity – 20,000 Cu.mt./Year.**

The case was recommended by SEAC in the 150th SEAC Meeting dt. 26/09/14. Subject to one of the following special conditions:

Before forwarding the case to SEIAA, MPPCB may ensure that violation w.r.t consented production capacity or any other consent conditions has not been committed by the PP in past.

It was submitted by the PP that it is a new mine yet to be opened hence consent from MPPCB has not been granted so far. Thus it was decided to forward the case to SEIAA as per the recommendations made in the meeting dated 26/09/2014.
