B. Policy Decision :

1. Quick disposal of online applications :

The issue was discussed in depth to expedite the disposal of new online applications at SEIAA level. It was decided that if few attachments are not uploaded with the online application even then application may be accepted by SEIAA office to avoid delay. Subsequently it was decided that PP should be specifically instructed to submit the lacking informations at SEAC office invariably otherwise his case shall not be appraised.

2. Acceptance of the case of Sand Mining having lease area less than 5 ha.

The case was discussed in the light of the order passed by NGT Central Bench, Bhopal on application No. 315/2014 and 324/2014 dated 11.09.2014 & 30.09.2014 respectively. It was noted that in this regard legal opinion was sought from Additional Advocate General Shri Prushendra Kaurav (SEIAA advocate for NGT). Consequent upon legal opinion provided by the SEIAA advocate it was decided that now onward the online application for Sand Mining having lease area less than 5 ha. should be accepted by SEIAA office, subject to final judgment in the matter to be given by the Principal Bench of NGT.






