- (5) In context of above, it was decided that the Prior EC may be transferred in the name of M/s ABC Associates, MIG-32, Bharhut Nagar, Satna, M.P. (Transferee) with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same validity period.

B. Discussion on Policy Issues :

(1) Clarification of policy about Marble/ Granite Projects.

It was noted that the SEAC in its 149th meeting dated 05.09.2014 have taken the decision under heading Discussion and decision taken on miscellaneous Issues at Para C, which is given hereunder.

"It was also brought to the notice of the committee that about 20 cases of Marble / Granite projects in lease area of less than 5 hectare have been scrutinized and TOR has been approved for these projects to carry out EIA / EMP. Marble and Granite although included in the schedule of minor mineral rules, these cannot be treated as B-2 cases hence TOR of all such cases which are kept on hold for clarification of policy may be issued."

In the context of above it was decided that the cases of Marble/ Granite for which TOR have already been approved shall be appraisal accordingly. The other cases which are on hold should also be considered under B-1 Category.


(2) Quick disposal of cases of Minor Minerals listed under temporary permit category.

The SEIAA office presented the status of the cases of temporary permit (Minor Mineral) pending for the decision. After detailed discussion following decisions have been taken


1. Wherein, PPs have himself requested for withdrawal of their cases, these cases have to be delisted and PP & Other concerned should be informed accordingly.

 - ii. Letter from the district Mining Officer regarding name, location/survey number and lease area of other operating mines within 500 mts (1.0 km. in case of sand mine) radius from the periphery of the proposed mine.
 - iii. Environmental Management Plan prepared by Registered Qualified Person (RQP).


It was also decided that if the PP does not submit the information by 15.12.2014, the case shall be summarily closed.
