(4) Above documents/information should be submitted by PP in SEIAA office latest by 15.10.2014.

- (4) In compliance of 158<sup>th</sup> SEIAA meeting's decision PP has submitted desired documents / information vide letter dtd 15.10.2014 received in SEIAA office on dtd 15.10.2014.
- (5) It was found that Collector, Raisen vide L.No. 673/Khanij/2013 dtd. 24.08.2013 has given consent (in principle) to sanction lease for 10 years.
- (6) It was noted that the production capacity mentioned in the approved mining plan is 60,000 cum/year.

PP the committee has recommended for grant of prior EC to the project subject to the 3 special conditions

- (2) It was noted that the PP has applied in Form-I for Prior Environmental Clearance of **Bichhia Laterite & Fire Clay Deposit Mine** (Opencast other than fully mechanized method) in an area of 12.13 ha. for production capacity 40,000 TPA at Khasra No. P409 at Village-Bichhia, Tehsil-Murwara, Dist-Katni (MP).
- (3) The case was discussed in depth and it was noted that the inter-state boundary, National Park/Sanctuary are not located within 10 Km. radius. Hence, the General Condition is not attracted.
- (4) It was noted that the distance of the mining site from forest boundary is 1.0 km (Conservator Forest, Katni, vide L.No. 6147 dtd 24.09.2013).
- (5) The proposed plantation program was examined and it was found that 22,130 plants to be planted in an area of 11.065 ha. and 2130 plants to be planted in 1.065 ha area of barrier zone. Plantation programme was found satisfactory.
