1. **Case No. 773 /2012** Prior Environmental Clearance for Expansion of Building Construction Project at Village Katara, Gram Panchayat Rapadiya, Tehsil Huzur, Distt. Bhopal (MP), total constructed area after completion of the project will be 144040.73 sqmt. Irrespective of the area being developed in phased manner by PP or the occupants of the plots" by M/s Asnani Builder & Developers Ltd. Through Visan Asnani and O.P. Kriplani, 17, Zone-II, M.P. Nagar, Bhopal (MP) - Owner of Land: M/s Asnani Builder & Developers Ltd. through Visan Asnani and Shri O.P. Kriplani, Developers: Amrit Homes Pvt.Ltd. & Amrit Colonizers Pvt. Ltd.
 - (1) The case was discussed in 165th SEIAA meeting dtd 10.10.14 and it is recorded that "(1)...(9)... (10) The case was discussed in depth and it is decided that :-
 - (i). A letter should be sent to PP informing that the view of the Authority is same as 125th SEIAA meeting dtd 09.04.13 and PP should seek prior Environmental Clearance.
 - (ii). The case should be return to SEAC for appraisal. PP should ensure presentation in SEAC for appraisal."
 - (2) Vide letter dtd 15.10.2014 received in SEIAA office on 16.10.2014 PP has again requested to reconsidered the case.
 - (3) The case was discussed in depth and it is decided that the view of Authority is same as in 165th SEIAA meeting dtd 10.10.14. PP should seek Prior Environmental Clearance under EIA Notification, 2006 and should ensure presentation in SEAC for appraisal. No further representation in this matter will be entertained. Accordingly, a letter should be sent to PP and CC should be endorsed to SEAC.

 - (1) Prior Environmental Clearance is accorded to the case in 159th SEIAA meeting dtd 11.09.2014 as per the recommendations of 145th SEAC meeting dtd 07.11.13 and EC letter issued vide no. 1561 dtd 28.10.14.
 - (2) PP vide letter dtd 26.11.14 received in SEIAA office on 04.12.14 has requested for amendment in conditions no. 13 under specific condition recommended by SEAC.
 - (3) The case was discussed in depth and it is decided to send a letter to SEAC along with the case file for their comments. A copy of letter should be endorsed to PP.

 - (1) The case was discussed in 157th SEIAA meeting dtd 26.08.14 and it is recorded that " (1)(3)..... (4) The case was discussed in depth and it is noted that in 135th, 144rd SEIAA meetings dated 04.06.13 & 23.08.13 respectively the case has

been summarily rejected and as per office memorandum 30.10.2012. SEIAA has no power to review the case once rejected. It was decided that a letter should be sent to MoEF, Gol for clarification regarding cases which are rejected / delisted / closed what procedure should be followed to re-open the case on submission of information by PP. Whether the same case is to be re-opened or PP has to apply afresh. If the cases are to be re-opened, maximum time limit for reopening the case needs to be specified."

- (2) PP vide letter dtd 05.12.14 received in SEIAA office on 06.12.14 has submitted the assurance letter for taking Municipal water supply as and when the water supply line comes in the said project area and the CGWA permission (dtd 29.08.12 which was submitted earlier) for abstraction of 411 m³ / day of ground water may be considered for grant of prior EC.
- (3) The case was discussed in depth and in view of clarification received from MoEF, Gol (vide letter dtd 24.11.2014 and office memorandum dtd 22.08.14) regarding relisting/ reopening of cases which are pending due to non submission of information. **It is decided that :-**

- a. **The case may be relisted.**
- b. **The project is not located in the Municipal Corporation limit hence the permission of CGWA for ground water extraction of (411 m³ / day) is accepted until the municipal water supply comes in the project area.**
- c. **A letter along with case file should be sent to SEAC to submit the report regarding present status of the project w.r.t status of municipal water supply and construction based on site visit. A copy of the letter should be endorsed to PP.**

- (1) The case was discussed in 146th SEIAA meeting dtd 12.09.2013 and it is recorded that " (1)....(2) ... (a) (i) (j) Application for EC was submitted by PP in the office of MPSEIAA on 04.03.2013.
- (i) After examining the facts in depth the Authority is of the view that inspite of the notice dt 09.10.2012 issued by MPPCB, PP applied for prior EC on 04.03.2013 and has constructed 23,539.18 sq mt (more than 20000 sq. m) area out of the total built up area of the 1,48,895.85 m² and is serious violation of the EIA Notification, 2006 hence **it is decided to reject the case outrightly for grant of prior EC as per Para 7 of the Memorandum No. J-11013/41/2006-IA.II (I) dtd 12.12.12 issued by the Ministry of Environment & Forests, Gol .**
- (ii) A letter should be sent to Secretary, GoMP, Housing and Environment giving the details of violation and office memorandum of MoEF, Gol J-11013/41/2006 IA II (I)dt. 12.12.2012 (Para 2) "to initiate credible action on the violation by invoking powers under section 19 of the Environment (Protection) Act, 1986 for taking necessary legal action under section 15 of the Act for the period for which the violation has taken place

and evidence provided to MoEF of the credible action taken." The details of legal action taken by the Secretary H&EN GoMP taken should be made available to the Authority by 31.10. 2013.

- (iii) The details of project proponent, a copy of commitment and Resolution (submitted by PP vide letter dt 03.05.2013 received in SEIAA office on 06.05.2013) passed in the meeting of the Board of Directors of M/s Satya Infrastructures Ltd. New Delhi held on 03.05.13 should be put on the website of MPSEIAA for information of all stake holders."

- (2) Vide letter dtd 19.10.13 received in SEIAA office on 21.10.13 has submitted that credible action has been initiated against the project and case has been filed by MPPCB in CJM, Indore, Court (32110 dtd 17.10.13). MS, MPPCB vide letter no. 95 dtd 01.09.14 has also informed that the credible action has been initiated against PP and requested to sent the case file to SEAC for appraisal.

- (3) The case was examined in depth and it is noted that :-

- (i). The PIL case was filed in NGT (case no. 155/2014 Paryavaran Avam Manav Adhikar Sanrakshan Samity V/s M/s Satya Infrastructure Ltd. & Others) regarding violation of EIA Notification, 2006 by PP. SEIAA is Respondent No. 3. In the aforesaid case Hon'ble NGT has given date of next hearing on 09.02.15.
- (ii). The W.P. No. 14043/2013 under Article 226 of Constitution of India with regard to requirement of EC has been filed in the Hon'ble High Court of Madhya Pradesh, Bench at Indore by PP Satya Infrastructure Pvt. Ltd., Indore against Union of India & others in which MP-SEIAA is respondent no. 3. The case is under hearing in the court and decision is awaited.
- (iii). **Since, the matter is sub-judice in Hon'ble NGT and High Court, the Authority decided not to examine such prayer of PP until the directives of Hon'ble NGT and High Court. Accordingly, PP may be informed. Copy of letter be endorsed to SEAC and MPPCB.**

- (1) The case was discussed in 157th SEIAA meeting dtd 26.08.14 and it is recorded that "(1)..... (2) As per decision taken in 146th SEIAA meeting letters (dtd.08.10.13.) were sent to Principal Secretary, GoMP, Housing and Environment for credible action for violation of EIA Notification, 2006 ; PP & all concerned for information of the decision.
- (3) PP vide letter no. nil dtd nil received in SEIAA office 05.11.13 submitted revised form-I and requested to consider the case for appraisal for prior EC. However, since MPSEIAA and SEAC were not in existence in state level, PP was informed (letter dtd. 18.11.13) and the application was returned in original.
- (4) PP vide letter dtd. 04.08.14 received in SEIAA office on 04.08.14 submitted representation along with Form-I, Form-IA and conceptual Plan with a request to review the decision of outright rejection of the case. (SEIAA meeting dtd. 12.09.13).

- (5) Meanwhile vide letter dtd. 02.11.13 Regional Officer MPPCB has informed that the legal case against PP has been filed on 01.11.13 in the court of Chief Judicial Magistrate Bhopal.
- (6) Vide letter dtd. 06.11.13 SEAC informed that the legal action has been initiated against the project of M/s Macker Real Ventures and requested SEIAA to send the original file for further necessary action.
- (7) The case was discussed in depth and it is noted that: - As per MoEF Gol, O.M. dtd. 12.12.12 & 27.06.13 in violation cases that has been outrightly rejected under the provision of para 7, it is not clear whether SEIAA has the power to review the case again on submission of application by PP. It is decided that a letter should be sent to MoEF, Gol to clarify the procedure to be followed in such cases and also guide about the appellate authority if any."

Case No. 835/12** - Prior Environmental Clearance for **Stone Quarry** in an area of 2.00 ha. for production capacity 12,500 cum/year (as SEAC recommendation) at Khasra No. 34 at **Village Chandrapura, Tehsil Chhatarpur, District Chhatarpur, MP** by Shri Rahul Budholiya, Village Chandrapura, Tehsil Chhatarpur, District Chhatarpur (MP)-471001.

- (1) After detailed discussion and perusal of the query response of 165th SEIAA meeting dated 10.10.2014 and recommendations of 146th SEAC meeting dtd. 08.11.2013, it was decided to grant Prior Environmental Clearance with slight modifications in the conditions imposed by SEAC.

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The average depth of the pit shall not exceed 6.0 m at the end of lease period.

- (2) Hence, Prior Environmental Clearance is granted for **Stone Quarry (Opencast manual method)** in an area of 2.00 ha. for production capacity 12,500 cum/year (as SEAC recommendation) at Khasra No. 34 at **Village Chandrapura, Tehsil Chhatarpur, District Chhatarpur, MP** for the **period of 10 years** by Shri Rahul Budholiya, Village Chandrapura, Tehsil Chhatarpur, District Chhatarpur (MP)-471001.
