



Scrutiny of the case reveals that the lease area in the allocation letter is just 1.020 ha, whereas the Mining Plan has been prepared for 1.619 ha. Most of the features of the plan are not matching with the lease area granted. It appears that the anomaly is result of copy & paste. The case is summarily rejected in view of above. It was decided by the committee that SEIAA may be requested to communicate the issue to Director Mining & Geology so as to discourage such practices by the RQPs."

- (iii). Municipal Solid Waste (MSW) generated (1.87 TPD) is proposed to be segregated into biodegradable and non-biodegradable components and collected in separate colored bins. To minimize littering and odors, waste will be stored in well designed containers/bins that will be located at strategic locations to minimize disturbance in traffic flow. Regarding NOC for MSW, PP has submitted copy of application (dtd 07.10.13) to Commissioner Nagar Nigam, Indore. **It is decided that the disposal of MSW should be integrated with Municipal Corporation and PP should submit clear NOC from Nagar Nigam, Indore for disposal of MSW in their trenching ground / landfill site.**
- (iv). The maximum height of the building is 12 m. PP has provided total road area 70360 sqmt. (37.10%) however road width has not been defined clearly. PP has submitted fire tender movement plan. **It is decided that PP should provide road width as per MPBVR 2012 rule no. 38 (4) Table 3.**


(4) The above information should be submitted by PP latest by 15.11.2014."

(2) In response to above query, reply submitted by PP (vide letter dtd 16.12.14 received in SEIAA office on 17.12.14 and presentation on 12.01.15) was examined in depth and it is noted that :-

- (i) PP clarified that the total land area as per approval of T & CP 191660 sqmt. Out of this area 2016.47 sqmt. will be utilize under Master Plan road widening and 43987 sqmt. area has been kept for future planning (commercial purpose). Hence, the net planning area for the project is 145656.53 sqmt. (14.565 ha) for which the case shall be considered for prior EC. **It is decided that PP should submit breakup of area details under the proposed project excluding the future planning area.**
- (ii) PP has submitted that an application has been submitted to Commissioner Nagar Nigam, Indore (vide letter dtd 07.10.13), for permission for supply of 379 KLD fresh water, for disposal of 135.5 KLD of extra treated waste water in the nearby Municipal sewer line and disposal of 1.87 TPD MSW. PP submitted that village

Lasudiyamori has been notified in the limits of Municipal Corporation, Indore. **It is decided that PP should submit clear NOC from Municipal Corporation, Indore for fresh water supply, disposal of extra treated water and MSW. PP should also submit layout plan showing nearest municipal sewer line connection.**

- (iii) PP has submitted that the maximum height is 12 m and has submitted layout showing road width as per MPBVR 2012 rule no. 38.
- (3) PP has submitted landscape layout showing plantation and green area 17441 sqmt. (11.98% of the net planning area). In the landscape plan it is observed that the peripheral plantation is in single row. **It is decided that plantation should be done in double row and as per the condition in 159th SEIAA meeting 11.09.14 (point no. 3 (vii)).**
- (4) PP should submit the above information latest by 15.03.2015.


D. Any other point

36. Authority observed that in many building cases of Indore, the NOC issued by Nagar Nigam, Indore for water supply, waste water discharge and MSW is vague. It is decided that a DO letter along with list of cases should be written to Collector, Indore to look into the matter for providing clear permission/ firm commitment for municipal water supply from Nagar Nigam, Indore specifying the quantity required by PP, NOC for discharge of extra treated waste water and NOC for disposal of MSW. A copy of this letter should be endorsed to Commissioner Nagar Nigam, Indore and PP.
