



1. **Case No. 2058/2014** - Prior Environmental Clearance for **Tatarpur Stone Quarry** in an area of 3.44 ha. for production capacity 1,50,000 cum/year at Khasra No. 680, 681, 682 at Village-Tatarpur, Tehsil-Bhander, Dist-Datia (M.P) by Shri Ashok Kumar Garg S/o Shri Surajbhan Garg, R/o Vill-Mubarikpur, Teh-Dera Basti, Dist-Mohali, Chandigarh-140507.

- (1) After detailed discussions and perusal of the recommendations of 166th SEAC meeting dtd. 09.01.2015, it was noted through Google Map view (as per coordinates submitted by PP) that some mining projects are already existing in the nearby area of the proposed mining site. In this context, it was decided to write to SEAC for conducting a site visit to assess the cumulative impact of the existing & proposed mining projects on nearby Human Settlement, Water Body, State Highway / National Highway and Forest area. **Copy of the letter should be endorsed to PP also.**

2. **Case No. 2059/2014**, Prior Environmental Clearance for **Stone Quarry** in an area of 2.306 ha for Production Capacity of 10000 cum/ year at Khasra no. 356/6, 356/3/2, 356/3/1 at **Village Brtola, Tehsil Pushprajgarh, District Anuppur, M. P.** by M/s Govind Construction, Shri Bhupendra Pal Singh Chabda Village Burhar, Tehsil Sohagpur, District Shahdol, M. P - 484001.

(1) After detailed discussions and perusal of the recommendations of 166th SEAC meeting dtd. 09.01.2015, it was noted that PP has not submitted the distance of forest boundary from the proposed mining site. In context of above it was decided to ask from the PP to submit the exact distance of the forest boundary from the proposed mining site. **The information should be made available at the earliest. Letter should be endorsed to the DFO, Anuppur also.**

3. **Case No. 2061/2014**, Prior Environmental Clearance for **Basalt Stone Boulder Quarry** in an area of 0.70 ha for Production Capacity of 7035 cum/ year at Khasra no. 218 at **Village Padriya, Tehsil Kundam, District Jabalpur, M. P.** by Smt Kirti Sharma W/o Shri Praveen Kumar Sharma, Near Kali Mandir, Ranjhi Tehsil Kundam, District Jabalpur, M. P - 483110.

(1) After detailed discussions and perusal of the recommendations of 166th SEAC meeting dtd. 09.01.2015, it was decided to grant Environmental Clearance with slight modifications of the conditions imposed by SEAC :

- (i). PP shall not start mining activity before execution of lease agreement.
- (ii). The average depth of the pit shall not exceed 6.0 m. at the end of lease period.
- (iii). Demarcation of the mining site should jointly be done by Mining Officer and concerned SDO, Forest. The cement pillars with proper numbering should be installed on the expense of PP. The possession of the site should only be given to the PP after joint inspection and ensuring that the pillars are at right place by Mining Officer & SDO Forest.

Hence, Prior Environmental Clearance is granted for **Basalt Stone Boulder Quarry** (manual/ semi mechanized Method) in an area of 0.70 ha. for production capacity of 7035 cum/year at Khasra No. 218 at **Village Padriya, Tehsil Kundam, District Jabalpur, MP** for the lease period by Smt Kirti Sharma W/o Shri Praveen Kumar Sharma, Near Kali Mandir, Ranjhi Tehsil Kundam, District Jabalpur, M. P - 483110.


4. **Case No. 2063/2014**, Prior Environmental Clearance for **Basalt Stone Quarry** in an area of 3.250 ha for Production Capacity of 39948 cum/ year at Khasra no. 234 at **Village Bargi, Tehsil Majholi, District Jabalpur, M. P.** by Shri Devendra Singh, New Ramnagar Adhartal, District Jabalpur, M. P.

(1) After detailed discussions and perusal of the recommendations of 166th SEAC meeting dtd. 09.01.2015, it was decided to grant Environmental Clearance with slight modifications of the conditions imposed by SEAC :

- (i). PP shall not start mining activity before execution of lease agreement.
- (ii). The average depth of the pit shall not exceed 6.0 m. at the end of lease period.

- (iii). Demarcation of the mining site should jointly be done by Mining Officer and concerned SDO, Forest. The cement pillars with proper numbering should be installed on the expense of PP. The possession of the site should only be given to the PP after joint inspection and ensuring that the pillars are at right place by Mining Officer & SDO Forest.

Hence, Prior Environmental Clearance is granted for **Basalt Stone Quarry** (manual/ semi mechanized Method) in an area of 3.250 ha. for production capacity of 39948 cum/year at Khasra No. 234 at **Village Bargi, Tehsil Majholi, District Jabalpur, MP** for the lease period of by Shri Devendra Singh, New Ramnagar Adhartal, District Jabalpur, M. P


5. **Case No. 2065/2014**, Prior Environmental Clearance for **Basalt Stone Boulder Quarry** in an area of 1.00 ha for Production Capacity of 4500 cum/ year at Khasra no. 581 at **Village Majhaniya, Tehsil Shajapur, District Shajapur, M. P.** by Shri Prem Singh Rajawat, S/o Shri Hajari Lal Rajawat, Village Majhaniya, Tehsil Shajapur, District Shajapur, M. P - 465001.


- (1) After detailed discussions and perusal of the recommendations of **166th SEAC meeting dtd. 09.01.2015**, it was noted through Google Map view (as per coordinates) that there is a settlement within 500m and other mines are also located in the vicinity of the proposed mine as per letter (vide no. 591 Dtd.09. 01.2015) from Mining Officer and as such the total area including the proposed mine exceeds 20.0 ha.


In context of above it was decided to write to SEAC for conducting a site visit to assess the cumulative impact of the existing & proposed mining projects on nearby Human Settlement, Water Body, State Highway / National Highway and Forest area. **The information should be made available at the earliest. Copy of the letter should be endorsed to PP also.**

6. **Case No. 665 /2012**: Prior Environmental Clearance for proposed SADA Special Area Development Authority, 12, city centre, Gwalior (M.P.) Township project total land area 805 ha. at Village- sojna,Tighra, Kaitha, Kulaith, Teh & Distt. Gwalior-M.P. by N.C.R. Special Area Development Authority (Counter Magnet) through Dr. M.P. Patel(CEO) 12, city centre, Gwalior (MP)-474001

- (1) The proposed is area Development project at Village- Sojna,Tighra, Kaitha, Kulaith, Teh & Distt. Gwalior-M.P. SADA has proposed to develop 18 Sectors. The proposed project includes residential (12 in area- 642 ha), Educational/Institutional (4 in an area-102 ha), public utility/semipublic (02 in area-54 ha) with convenient shopping centers/ commercial area (07 ha). The Proponent is N.C.R.Special Area Development Authority (Counter Magnet) through Dr. M.P. Patel (CEO) 12, city centre, Gwalior (MP).
- (2) As per the Site visit report of SEAC dtd. 07.04.13 the site has total area of 30,000 ha comprising of Govt. land (6500 ha), Private land (9000ha) and forest land (14,500 ha). Phase I of the project. As per the collector order dtd. 08.05.2000 & 31.08.2001 the land 944.172 ha & 2283.49 ha is allotted to SADA.
- (3) The total land area proposed by PP is 805 ha. The project comes under 8 (b) category (B1) of schedule of EIA Notification, 2006 as the total plot area is more than 50 ha & construction is more than 1,50,000 sqmt.

- (4) The case was discussed in SEAC meetings 88th dtd. 13.02.2012, 111th dtd. 05.12.2012, 124th dtd 13.03.2013, 148th dtd. 25.08.14 and 164th dtd. 07.01.15 and has recommended the project for grant of prior EC with 17 special conditions.
- (5) **The Authority decided that PP should be called for presentation on 26.02.2015.**
7. **Case No. - 697/2012** prior Environmental Clearance Executive Kachnamandi (Medium) irrigation project (Main Dam at Sathakala Teh-Barghat, Distt-Seoni by Engineer WRD Div. Seoni, Distt.- Seoni (M.P.)-1 (c) (Delist)
- (1) The application was submitted by PP in SEIAA office vide letter no. 1543 dtd 29.03.2013 received on 30.03.2012.
- (2) The case was registered and forwarded to SEAC for appraisal (letter no. 62/EPCo-SEIAA/12) on 18.04.2012.
- (3) The case was discussed in 94th SEAC meeting dtd 07.05.2012 and "it is recorded that "It was informed by the proponent that the department has dropped the projects at present, thus it may be kept on hold till further communication from the department. Committee decided to keep the case on hold till next meeting. If proponent does not respond before the next meeting the project may be returned to SEIAA."
- (4) PP (vide letter no.2234 dtd 10.11.14) has requested to withdraw the project.
- (5) The case was again discussed in 165th SEAC mtg. dtd. 08.01.15 and it is recorded that "Request of PP (vide E-In-C letter no. 2234 dated 10/11/2014) for withdrawal of their application filed before the SEIAA for prior EC was forwarded by SEIAA for further necessary action. It was observed that PP wish to withdraw their application seeking prior EC in light of MoEF Gazette Notification dated 25/06/2014. MoEF vide said notification has exempted irrigation project with proposed CCA upto 2000 ha. This project comprises a CCA of 1980 Ha, which is less than the prescribed thresh-hold, hence committee decided to return the case to SEIAA recommending delisting of the project."
- (6) The case was discussed in depth and **the Authority decided to accept the recommendation of 165th SEAC mtg. dtd. 08.01.15 and delist the case. PP and all concerned should be informed accordingly.**
8. **Case No. 497/2010**, Prior Environmental Clearance for High-rise multi storied residential project Khasra No.84/3/4Ka,91/2/1,89/1,84/3/4Kha,89/2,90,91/2/2 at village-Bicholi Mardana, Indore-M.P., total land area 26660 sqmt. (2.666 ha) and built up area 38038.12 sqmt. by M/s Milan Realities through Shri Ashish Modi, Director 2006 Oasis Trade centre, 20/22, Yeshwant Niwas Road, Indore-M.P.
- (1) The case was discussed in 157th SEIAA meeting dtd 26.08.2014 and 169th SEIAA meeting dtd 28.10.2014 and it is recorded that "(1) (2).... (3). The case was discussed in depth and it is noted that :-
- (i) The Authority decided to consider the case as per request of PP.
- (ii) The case was considered in SEAC meetings 45th dtd 27.01.2010, 49th dtd 23.02.2010, 76th dtd 07.01.2013, 84th dtd 09.11.2011 and recommended for EC subject to 37 special conditions.
- (iii) PP has submitted that construction of 17695 sqmt. has already been done as phase-I for which the building permission from Gram Panchayat and consent from MPPCB were issued to them.
- (iv) It is noted that in the minutes of SEAC meetings, any note of the construction activity that has been taken up and comments have not been included. **It is decided that the**

above information submitted by PP and the case file should be sent to SEAC for appraisal and recommendations."

- (2) SEAC Considered the case in 167th mtg.10.01.15 & it is recorded ".....After deliberations and scrutiny of the case, committee concluded that case was appraised by SEAC and no construction was revealed by the SEAC at that point of time thus, based on the merits and submissions the case was recommended for grant of EC without any comments on existing construction. However, now PP has completed a part of the proposed construction after obtaining due permissions from concerned authorities and green certification from IGBC, it may be considered as an expansion of the existing project."
- (3) **The Authority decided that PP should be called for presentation on 27.02.2015.**

9. **Case No. 2090/2014** Prior Environment Clearance for proposed S M Dye Chem Industries, capacity 550 MT/M at Village Meghnagar, Tehsil Jambua, District Dhar, MP area 6800 sqmt. by Mr. Manishbhai B. Shah, Partner, S.M. Dye Chem, Plot No. 240/3, GIDC Estate, Vatwa, Ahmedabad-382445


- (1) The application was submitted by PP in SEIAA office on 12.11.2014
- (2) The case was registered and forwarded to SEAC for appraisal (letter no. 2124/SEIAA/14) on 19.11.2014.
- (3) The case was discussed in 167th SEAC mtg. dtd. 10.01.15 and it is recorded that "Scrutiny of the project reveals several discrepancies in the submitted documents. Major discrepancies observed by the committee are as follows:
- Address of the location of proposed site is incorrect.
 - At many places in the PFR name of Gujrat Ind.Dev. Corporation (GIDC) has been mentioned, whereas the project relates to Madhya Pradesh.
 - Accreditation certificate from QCI could not be furnished by the consultant.


In view of above discrepancies committee asked the PP to re-submit the complete application and relevant documents to SEIAA. It was decided to return the case to SEIAA for further necessary action. "


- (4) **The Authority noted that as desired by SEAC, PP has resubmitted the application in SEIAA on 18.02.15. It is decided that the same may be forwarded to SEAC for appraisal.**

10. **Case no. 721/2012**, Prior Environmental Clearance for Commercial Complex Project at Khasra No. 538,539,540,541,542, 543/2, 547, village Bairagarh Chichli Kolar Road, Bhopal (MP) Plot area 35,100 Sq.m., Built up area - 83,651 Sq.mt by M/s Khaneja Properties Pvt. Ltd., through Mr. Ashok Kashyap (Sr. General Manager) 56-58, Community Centre, East of Kailash, New Delhi - 110065

- (1) The case was discussed in 98th SEAC meeting dtd 23.07.12. The committee recommended the case for grant of prior subject to 26 special conditions.
- (2) The case was discussed in SEIAA meetings 105th dtd 12.09.12, 114th dtd 06.12.12, 125th dtd 09.04.13, 135th dtd 04.06.13, 143rd dtd 16.08.13, 145th dtd 31.08.13, 161st dtd 16.09.14.
- (3) The case was discussed in depth and it is noted that :-
- (i). The construction work has been started by PP (105th SEIAA meeting). PP was asked to submit details of construction under taken (125th SEIAA meeting)

- (ii). A letter was sent to MS, MPPCB to direct RO to make a site visit and ascertain quantum of construction activities.
 - (iii). The site visit report submitted by RO, MPPCB was discussed in 161st SEIAA meeting and decision was taken for credible action as per MoEF, GoI OM dtd 12.12.12.
 - (4) MPPCB vide letter no. 435/Tech. dtd 19.01.15 received in SEIAA office 24.01.15 has informed that the case has been filed against PP under section 15 & 16 EP Act 1986 on 18.12.14 for the project commercial complex at village Baigarh Chichli, Kolar Road, Bhopal.
 - (5) **As per the request of the PP the presentation is rescheduled on 27.02.2015.**
- 11. Case No. 1306/2013** Prior Environmental Clearance for proposed "New York City" Residential & commercial project at Khasra No.969/1/3,970/2,970/3, 971/2, 972/1/2,973/2/1,975/3/1,973/1/3,975/1,974/1/2,975/2, Village Nihampur Mundi, Tehsil & Distt. Indore (MP) Total Land Area 52500.00 sq.mt. (5.25 ha) Total Builtup Area 45357.98 sqm by M/s Highway Infrastructure Pvt. Ltd., through Director, Anup Agrawal 57-FA, Scheme No. 94, Pipliyahana Junction, Ring Road, Indore (MP) email: hiplindore@gmail.com (Environment Consultant Insitu Enviorcare, Bhopal)
- (1) Application for Prior Environmental Clearance was submitted by PP (vide letter dtd 27.02.13) received in SEIAA office on 05.03.13
 - (2) The case was discussed in SEAC meetings 127th dtd 25.04.2013, 140th dtd 30.08.13 and 143rd dtd 29.10.13 and is recommended for Prior EC with four conditions.
 - (3) A complaint from Shri Sumit Mishra, Indore was received in SEIAA office dtd 11.07.13 which was forwarded to SEAC vide letter no. 1201 dtd 16.07.13.
 - (4) SEAC sub-committee visited the site to verify the facts about the complaint. The site visit revealed that the crusher is not operating at the proposed site and construction of more than 20000 m2 has been done at the site.
 - (5) The case was discussed in 158th SEIAA meeting dtd 04.09.14 and the Authority decided that since PP has done violation of EIA Notification 2006 hence credible action should be initiated As per MoEF, GoI, OM No. J-110131/41/2006-IA-II (I) dtd 12.12.2012 and OM dtd 27.06.2013
 - (6) PP vide letter dtd 15.01.15 and 23.01.15 received in SEIAA on 16.01.15 & 24.01.15 respectively submitted the 158th SEIAA meeting dtd 04.09.14 query reply and informed that MPPCB has filed a case against the project Newyork City as a violation of act in the Court of CJM, Indore . MPPCB, Bhopal vide letter no. 26 dtd 12.02.15 forwarded a copy of letter by Regional Officer, Indore (No. 118 dtd 08.01.15) intimating that credible action has been initiated against PP.
 - (7) **As per the request of the PP the presentation is rescheduled on 26.02.2015.**
