- (1) After detailed discussions and perusal of the recommendations of 172nd SEAC meeting dtd. 22.02.2015, it was noted through Google Map view (as per coordinates submitted by PP) that at the proposed site the sand deposition is very scanty and the SEAC has also recommended as following;

The case was considered in the 159th Meeting dated 01/12/2014. Whereby the Google map presented by the PP during the presentation reveals that the Mining Lease area allocated to the PP does not have adequate sand whereas, the considerably good sand deposits are visible in the land in proximity of the allotted lease area. It was decided get the factual report from the concerned Regional Officer MPPCB in the matter and verify the actual location of the lease area. Report from RO Singrauli was received. RO reported that no sand is observed at the proposed mine site hence the case may not be considered for EC. Accordingly, it was decided by the committee to return the case to SEIAA with recommendation for rejection of the application.

In the context of above it was decided to ask from the Collector to clarify about the availability of the sand at the site, as the PP has been asked for the execution of the agreement as per auction of the said sand mining project after obtaining Environmental Clearance vide your letter No 1554 dated 30.10.2014.

The information should be made available at the earliest. Copy of the letter should be endorsed to PP also.




