- (3) The case was discussed in SEAC meetings 176th dtd. 26.02.15 and is recommended for grant of prior EC subject to 12 special conditions.
- (4) The Authority decided that PP should be called for presentation on 27.04.2015.
- (2) The case was discussed in depth and it is note that:-
 - PP has submitted copy of Khasra Panchsala 2014-2015. As per Khasra Panchsala the land is the name of M/s Lake Land Builders and Developers, through Mr. Wasiq Hussain, (Partner).
 - (ii) The total water requirement is 502.8 KLD and fresh water requirement is 263.2 KLD. The total recycled water 240.60 KLD (131.6 KLD flushing + 33 KLD Horticulture, Landscape & fountain + 75.0 KLD cleaning). The source of water supply is Bhopal Municipal Corporation. PP has submitted letter (dtd. 13.10.14) from Nagar Nigam Bhopal for supply of water. It is decided that the entire demand of fresh water should be met through municipal supply and there should be no extraction of ground water.
 - (iii) The total waste water generation is 359.255 KLD. PP has provided sewage treatment plant of 375 KLD. The total treated waste water is 323.33 KLD. Out of this 240.60 KLD will be recycled (131.6 KLD flushing + 33 KLD Horticulture, Landscape & fountain + 75.0 KLD cleaning) and extra treated waste water 82.73 KLD is proposed to be disposed off to sewer line. PP has submitted letter (dtd. 20.03.14) from BMC regarding disposal of extra treated waste water in Municipal sewer line. It is decided that:
 - a. PP should ensure that the discharge of extra treated waste water (82.73 KLD) is linked with municipal sewer line.
 - b. The Authority of the view that the extra treated waste water is being generated in large quantities from the upcoming building construction projects. This water can be used in various secondary purposes like irrigation, construction activities etc. A letter should be sent to Commissioner Bhopal Municipal Corporation to explore the possibilities of using the extra treated waste water discharged from these colonies.
 - (iv). Approximately 1500 KG per day of Municipal Solid waste shall be generated. It is proposed to be segregated at source and collected in three coloured bins and disposed off at trenching site of BMC. PP has submitted letter dtd. 20.03.14 from Bhopal Municipal Corporation for disposal of solid waste. It is decided that PP should provide compactors for MSW and ensure linkage with Bhopal Municipal Corporation for final disposal of MSW.
 - (v). The maximum height of the building is 18 m. PP has provided road width 12 m; Front MOS 7.5 m and side / rear MOS 6.0 m. It is decided that PP should ensure road width, MOS and open spaces as per MP Bhumi Vikas Niyam 2012 rule 42 (1) for building up to 18 m height.

PP has proposed to provide Fire Extinguishers, Hose Reel, Wet Riser, Yard Hydrant, Automatic Sprinkler System (to be installed in entire building), Manually Operated Electric Fire Alarm Systems, Underground Static Water Storage Tank, Terrace Tank etc. as per NBC 2005. It is decided that as per MPBVR, 2012 rule 42 (3) PP should submit necessary drawings and details to the Authority (Nagar Nigam, Bhopal) incorporating all the fire fighting measures recommended in National Building Code part IV point no. 3.4.6.1. The occupancy permit shall be issued by Nagar Nigam only after ensuring that all fire fighting measures are physically in place.

- (7) It is decided that the case should be sent back to SEAC. The SEAC should submit the report on the basis of site visit ascertaing the construction already under taken and the present status of the project along with photographs.
