(1) After detailed discussion and perusal of the recommendations of 182nd SEAC meeting dtd. 28.03.2015, it was decided to grant Prior Environmental Clearance with slight modifications in the conditions imposed by SEAC:


- i. PP shall not start mining activity before execution of lease agreement.
- ii. The average depth of the pit shall not exceed 6.0 m. at the end of lease period.


Hence, Prior Environmental Clearance is granted for **Metal Stone & Murum Quarry** (Opencast Manual/ Semi Mechanized Method) in an area of 8.0 ha for production capacity of stone 1,00,000 cum/year & Murum 11073 cum/year **(as per SEAC)** at Khasra no. 12/2, Village Madhupallvi, Tehsil Sondawa, Distt Alirajpur(MP) **for the lease period** to M/s. - (1) The proposed project is building & construction Affordable Housing Scheme located at Khasra No. 4,7 & 8, Gram Barrai, Phase-I Near Katara Hills Tehsil & District Bhopal M.P. The total built-up area of 1,30,285 sq.m hence the project comes under 8 (a) category (B) of schedule of EIA Notification, 2006.
- (2) Application for Prior Environmental Clearance was submitted by PP received in SEIAA office 21.01.15
- (3) The case was registered and forwarded to SEAC for appraisal on 27.01.15.
- (4) The case was discussed in 173rd SEAC meeting dtd 23.02.2015 and recorded that "PP has reported that construction activity has already been initiated at the site after obtaining approval from the State Town & Country Planning Department. In view of the violation of the provisions of EIA Notification, credible action has to be initiated against the Project Proponent before considering the project for further appraisal. Hence the case was deferred till receipt of evidence pertaining to initiation of credible action against the PP by the concerned authority".
- (5) PP vide letter dtd. 01.05.15 has requested to exempt the affordable housing project from credible action as per MoEF, Gol, OM No. J-110131/41/2006-IA-II (I) dtd 12.12.2012


- (6) The case was discussed in depth and the Authority is of the view that from the content of the above letter, it is noteworthy the project has been designed on a low cost basis with limited budget to cater the needs of the economically weaker section. The stipulations of the MoEF&CC, OM dated 19.06.2013 for appraisal of building construction cases can't be fulfilled through the affordable housing scheme norms. There has been a mismatch on this count. A letter should be addressed to the Principal Secretary, Urban Development & Environment Department requesting him to take up this matter with the MoEF&CC, GoI.
- (7) PP is directed **to stop the construction activities with immediate effect** and should not undertake any kind of construction/development till a final decision in this regard is taken.

- (1) The proposed project area development project at village Tigriya Badshah and Bada Bangarda, Tehsil Hatod, Distt. Indore (MP). The project include Software Development Block (SDB)-4; Employee Care Center (ECC)-1; Food Court-02; Security Blocks – 02.
- (2) Approval of T & CP, Indore has been granted vide letter no.1558 dtd. 04.03.14. The total land area proposed by PP is 5,26,415.55 sq.m at Tigriya Badshah & Bada Bangarda, Tehsil Hatod, Distt. Indore (MP) The total built up area proposed by PP is 3,00,489.74 sq.m. The project comes under 8 (b) category (B) of schedule of EIA Notification 2006 because total land area is more than 50 ha. and built up area is more than 1,50,000 sq.m.
- (3) The case was discussed in SEAC meetings 150th dtd. 26.09.14 & 182nd dtd. 28.03.15 and is recommended for grant of prior EC subject to 04 special conditions.
- (4) The case was discussed in depth and it is noted that :-
 - (i) PP has submitted notarized copy of lease agreement dtd 29.10.2012 between Governor of Madhya Pradesh through Secretary of Department of Information & Technology and M/s Infosys Ltd. through Sr. Vice President Shri U. Ramdas Kamath for period 99 Years (From 29/10/2012 to 28/10/2111) for area of 52.643 ha (130.08 acres).
 - (ii) The total water requirement is 1559 KLD. The fresh water requirement is 653 KLD. The source of water supply is Municipal Corporation Indore. PP has submitted letter from Municipal Corporation Indore regarding commitment of water supply. **It is decided that PP should ensure that the entire water demand is met through Municipal Corporation, Indore and there is no extraction of ground water.**
 - (iii) The total waste water generation is 825 KLD. PP has provided sewage treatment plant of 1000 KLD. The total treated waste water is 784 KLD.

PP has proposed to recycle the entire quantity of waste water for flushing; DG set Cooling; HVAC Cooling & horticulture etc. **It is decided that PP should ensure zero discharge of treated waste water and linkage with municipal sewer line for discharge of treated waste water (if any).**

- (iv) Approximately 4263 kg per day of Municipal Solid waste generated is proposed to be segregated at source. PP has proposed solid waste from site will be collected on a daily basis and managed as per MSW Rule, through hired agency. **It is decided that PP should provide compactors for MSW and ensure linkage with Indore Municipal Corporation for final disposal of MSW.**


Hazardous waste (E-waste) generated 50 MT/annum which is proposed to be collected in to separate bins and sold to the CPCB recognized recyclers. **It is decided that PP should obtain authorization from MPPCB regarding Hazardous waste management.**

Approximately 0.5 kg/day Bio Medical waste will be generated which is proposed to be collected as per the Bio Medical waste handling and management rules and handed over to authorized agency. **It is decided that, Bio Medical Waste (Handling and management) rules should be followed strictly for the disposal of bio medical waste.**

- (v) As per T & CP approval the maximum height of the building is 45 m. PP has provided road width 75 m; Front MOS 45 m and side MOS 17.80 m/15.10 m and rear MOS 330.0 m. **It is decided that PP should ensure road width; MOS and Open spaces as per MPBVR 2012.**
- (vi) Regarding fire fighting PP has proposed to provide fire water storage tank, external and internal fire hydrant sprinkler system, wet riser and down comer system etc. as per NBC 2005. **It is decided that as per MPBVR, 2012 rule 42 (3) PP should submit necessary drawings and details to the Authority (Nagar Nigam, Indore) incorporating all the fire fighting measures recommended in National Building Code part – IV point no. 3.4.6.1. The occupancy permit shall be issued by Nagar Nigam only after ensuring that all fire fighting measures are physically in place.**
- (vii) PP has proposed Rain water harvesting through lakes and use of this harvested water for consumption and artificial recharge of ground water. **It is decided that PP should ensure rain water harvesting.**
- (viii) The total power requirement is 5599 KW or 5894 KVA. PP has also proposed power back up 4 DG Sets 2000 KVA. The source of power supply is MP Electricity Board. **It is decided that PP should ensure installation of photovoltaic cells (solar panels in total roof area) for lighting in common areas, LED light fixtures and energy efficient equipments.**
- (ix) As per MPBVR 2012 (rule no. 84) the requirement of car parking is 3316 ECS. PP has proposed to provide total car parking of 4544 ECS (surface 600 ECS, MLCP 3944 ECS & Two wheeler 660). **It is decided**

that PP should ensure car parking as per Rule no.84 Table Clause1(3) of MPBVR 2012.


(x) Out of the total project area (526414.55 sqmt.) an area of 316477.11 sqmt. (60.12%) is proposed to be developed as green area. The authority decided that PP should ensure three rows of plantation all along the periphery of the project area, parks, playground and avenue plantation along the roads. PP should ensure plantation of the trees of indigenous local varieties like Neem, Peepal, Kadam, Kachnaar etc. Every effort should be made to protect the existing trees on the plot.


(5) The Authority decided to accept the recommendations of 182nd SEAC meeting dtd. 28.03.15 with **04 special conditions and accord Environmental Clearance** to proposed project Infosys Campus at Super Corridor at Village Tigriya Badshah and Bada Bangarda, Tehsil Hatod, Distt. Indore (MP); Total Project Area 5,26,415.55 sq.m; built-up area 3,00,489.74 sq.m. by M/s Infosys Ltd. through Shri Ramdas Kamath, Senior. VP, Head Infrastructure & Security, Plot No.-44, Electronic City, Hosur Road, Bangalore -560100 **subject to all specific conditions imposed by SEIAA in its meetings.**


