

1. **Case No.1829/2014** Prior Environmental Clearance proposed Project Construction of "Residential Area Development under the scheme of Sardar Ballabh Bhai Patel Aawasiya Yojna MISROD Phase II, at Village Bawadia Kalan, Salliya and Misrod, Village, Tehsil Huzur, Distt. Bhopal (MP) Total Plot Area 230.27 Acres (931890 sqm) and excluding the canal of 10.60 acres (42899.1 sqm), the net planning area is 219.67 acres (888991.4 sqm) and Built up area of 4,76,801.04 sq.m (53.64%), by Shri S.K. Mishra, Executive Engineer, Bhopal Development Authority, Bhopal Pragati Bhawan, Press Complex, M.P. Nagar, Zone-1, Bhopal, (MP) 462011 Env. Consultant- Vidhya Consultancy, Hyderabad.

- (1) The case was discussed in 194th SEIAA meeting dtd 17.04.2015 and it is recorded that " 1. The proposed project is "Residential Area Development" under the scheme of Sardar Ballabh Bhai Patel Aawasiya Yojna MISROD Phase II, at Village- Bawadia Kalan and Salliya Village, Tehsil- Huzur , Distt.- Bhopal. (M.P). The project includes total plots 3549 (commercial plots 18, shop cum residential 184 and residential 3347).
2. As per the T & CP Bhopal (letter No.1028 dtd. 16.06.14.). The total land area is 93.191 ha. The total built up area proposed by PP is 4,76,801.04 sq.m. The project comes under 8 (b) category (B) of schedule of EIA Notification 2006 because total built up area is more than 1,50,000 sq.m.
3. The case was discussed in SEAC meetings 154th dtd. 10.11.14 & 182nd dtd. 28.03.15 and is recommended for grant of prior EC subject to 07 special conditions.
4. The Authority decided that PP should be called for presentation on 12.05.2015.

- (2) The case was discussed in depth and it is note that:-

- (i) Regarding land documents PP has submitted copy of Vigyapan, office of Bhopal Development Authority, Bhopal published vide no. /02 / BDA / 09 dtd 10.09.2009 Part 3 (1) in GoMP Gazette Notification for land area 17.771 ha in Bawadia Kalan, 33.63 ha in Misrod and 41.79 ha in Salliya village (total area 93.191 ha).
- (ii) The total water requirement is 2755 KLD. The source of water supply is Municipal Corporation Bhopal. PP has submitted letter from Municipal Corporation Bhopal dtd. 15.09.14 regarding water supply. It is decided that PP should ensure that the entire water demand is

met through Municipal Corporation, Bhopal and there is no extraction of ground water.


- (iii) The total waste water generation is 2203 KLD. PP has provided sewage treatment plant of 2280 KLD. The total treated waste water is 1982 KLD. Out of this 400 KLD water will be used for horticulture and remaining 1582 KLD is proposed to be discharged in sewer line. PP has submitted letter from Municipal Corporation Bhopal dtd. 20.03.15 regarding disposal of extra treated waste water. **It is decided that PP should ensure that the discharge of treated waste water (1582 KLD) is linked with municipal sewer line.**
- (iv) Approximately 8.6 tons/day of Municipal Solid waste shall be generated. It is proposed to be segregated at source and collected in three coloured bins and disposed off at trenching site of BMC. PP has submitted letter dtd. 25.02.15 from Bhopal Municipal Corporation for disposal of solid waste. **It is decided that PP should provide compactors for MSW and ensure linkage with Bhopal Municipal Corporation for final disposal of MSW.**


Bio Medical waste will be generated from dispensary which is proposed to be collected as per the Bio Medical waste handling and management rules and handed over to authorized agency. **It is decided that, Bio Medical Waste (Handling and management) rules should be followed strictly for the disposal of bio medical waste.**

The Hazardous waste used oil from DG set is proposed to be stored in HDPE drums and sold to authorized recyclers. **It is decided that PP should obtain authorization from MPPCB regarding hazardous waste disposal.**

- (v) PP has provided 24m width Separate entry and exist roads from 30m main master plan road and internal roads of 24m, 12m, 9m, 7.5m, 7m. **It is decided that PP should ensure road width; MOS and Open spaces as per MPBVR 2012.**
- (vi) Regarding fire fighting PP has proposed to provide Two dedicated Fire Fighting storage tanks with a total capacity of 4,40,000 Litres capacity to meet the needs of the requirements in emergency. **It is decided that PP should ensure:-**
- a) To provide fire fighting provision as per National Building Code (2005) and MPBVR, 2012 and ensure that all the fire fighting measures are physically in place.
 - b) To earmark the space for fire station arrangement in future.
- (vii) PP has proposed roof top rain water harvesting system for ground water recharging with 80 nos. of recharging pit. **It is decided that PP should ensure rain water harvesting.**
- (viii) The total power requirement is 18041 KVA. PP has also proposed DG Sets for power back up. The source of power supply is MPPGCL. **It is decided that PP should ensure installation of photovoltaic cells**

(solar panels) for lighting in common areas, LED light fixtures and energy efficient equipments.

- (ix) As per MPBVR 2012 for plotted residential development parking requirement shall be calculated on the basis of 1 car space for every 101 to 199 sq. m. built-up area. PP has proposed to provide 7000 sq.m.(15%) at common areas and approx. 243 no of ECS (@ 23 sq.m) and 311 no of Two wheelers (@ 4.5 sq.m) at open space .It is decided that PP should ensure car parking as per norms in MPBVR 2012.
- (x) Out of the total land (931890 sq.m.) an area of 89148.14 sq.m. (10.03%) is proposed to be developed as green area. The authority decided that:-
- i. PP should ensure plantation in 20% of the total plot area.
 - ii. Plantation should be done in two rows all along the periphery of the project area, along, avenue plantation along the roads with one tree per 100 sq. m. of the plot area. PP should ensure plantation of the trees of indigenous local varieties like Neem, Peepal, Kadam, Kachnaar etc along with ornamental varieties.
 - iii. PP should provide protection and buffer zone with double row plantation on both the sites and of the Kalisote canal passing through the site.
 - iv. Every effort should be made to protect the existing trees on the plot.
- (xi) PP should ensure to increase the area of community hall along with adequate parking facility.
- (xii) PP should ensure Regular water quality monitoring of the canal so as to ascertain the water quality as per CPCB norms for irrigation.
- (3) The Authority decided to accept the recommendations of 182nd SEAC meeting dtd. 28.03.15 with **07 special conditions and accord Environmental Clearance** to proposed project construction of "Residential Area Development under the scheme of Sardar Ballabh Bhai Patel Aawasiya Yojna MISROD Phase II, at Village- Bawadia Kalan, Salliya & Misrod, Tehsil- Huzur, Distt.- Bhopal. (M.P) Total Plot Area- 230.27 Acres (931890 sqm) and excluding the canal of 10.60 acres (42899.1 sqm), the net planning area is 219.67 acres (888991.4 sqm) and Built up area of 4,76,801.04 sq.m (53.64%), by Shri S.K. Mishra, Executive Engineer, Bhopal Development Authority, Bhopal Pragati Bhawan, Press Complex, M.P. Nagar, Zone-1, Bhopal, (M.P) – 462011 **subject to all specific conditions imposed by SEIAA in its meetings.**
