PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. PP has reported that the pit formed after mining shall be developed into a water body. It was not clear whether the crusher is proposed or not in the lease area. Concerned Mining Officer vide letter no.-316 dated -26-03-15 has reported that there is 01 more mine operating or proposed within 500 meters around the said mine and total lease area is 4.650 ha.

Scrutiny of the case reveals several discrepancies in the Mining Plan; the location of site, roads, mined out area etc do not match the geographical details when observed through Google image. It was concluded by the committee that the project can not be appraised on the basis of the information furnished by the PP in the Mining Plan it was therefore decided to refer the case back to SEIAA for rejection."

From the coordinates provided by the PP the site is very close to a Pucca structure and as per the recommendation of SEAC the case is hereby rejected. Copy to PP and all concerned should be accordingly.






