A. Policy Decision

Hon'ble National Green Tribunal, New Delhi Order dtd 07.07.2015 regarding violation cases involving credible action.

- (1) As per the provision of EIA Notification, 2006 the projects or activities falling under the schedule of the notification shall require prior environmental clearance from the concerned regulatory authority i.e. GoI MoEF & CC for category A projects and State Level SEIAA for category B projects.
- (2) Further, GOI, MoEF & CC issued office memorandum dtd 16.11.2010 for consideration of proposal involving violation of EPA, 1986 or EIA Notification, 2006.

- (3) In supersession to the above GoI, MoEF & CC issued office memorandum dtd 12.12.2012 and amendment 27.06.2013. As per the Office Memorandum the procedure to be followed while considering the proposals involving violation is as follows :-
- (i) As soon as the case of violation comes / brought to the notice, the veracity of the complaint is to be verified.
 - (ii) PP has to submit a formal resolution from the board of directors of the company to the authority to ensure that violations of EPA etc. will not be repeated within 60 days. In the mean time project will be delisted and if resolution is not submitted within 60 days the case should be closed.
 - (iii) PP should be directed to stop the construction / operations / productions / modernization / change in product mix and maintain the status quo until the required EC is obtained.
 - (iv) The respective state Govt. should be informed to initiate credible action against the Proponent on the violation by invoking powers under section 19 of EPA 1986 for taking necessary legal action under section 15 of the Act for the period for which violation has taken place as per the procedure prescribed.
 - (v) The details of Project Proponent, copy of commitment should to be displayed on website for information of all stakeholders.
 - (vi) Once the action as above has been taken the case should be appraised as per the merit of the case.
 - (vii) In cases of serious violation of the ministry reserved the right to outrightly reject such proposal and not consider the same not at all.
- (4) Regarding above GoI, MoEF & CC O.M. dtd. 12.12.12 and 27.06.13. Hon'ble NGT New Delhi in O.A.No. 37 of 2015 & O. A. No. 213 of 2014 has passed order in which it is recorded ".....1) We hold and declare the Office Memoranda dated 12th December, 2012 and 27th June, 2013 as ultra vires the provisions of the Act of 1986 and the Notification of 2006. They suffer from the infirmity of lack of inherent jurisdiction and authority. Resultantly, we quash both these Office Memoranda.
- 2) Consequently, the above Office Memoranda are held to be ineffective and we prohibit the MoEF and the SEIAA in the entire country from giving effect to these Office Memoranda in any manner, whatsoever....."

In view of above the Authority decides that:-

The proceedings of the violation cases involving credible action shall be kept in abeyance till such time that MoEF & CC comes up with a clarification on the afore mentioned NGT order. The intervening period shall not be counted for deemed EC and the recommendations as received from SEAC shall be stalled till the directions from MoEF & CC, GOI are received. As soon as the directives/clarification from MoEF & CC, GoI are received the proceedings/appraisal shall commence in the Authority and taking cognizance of the SEAC's recommendations.

 - (1) The case was discussed in 198th SEIAA meeting dated 11.05.2015 and it is recorded that "(1) (2) In response to above query, reply submitted by PP (vide letter dtd 30.04.15 & 05.05.15 received in SEIAA office on 02.05.15 & 06.05.15) was examined and it is noted that :-
 - (i). PP has submitted letter dtd 02.05.15 from Municipal Corporation, Bhopal regarding fresh water supply. **It is decided that the entire demand of fresh water should be met from Municipal supply and there should be no extraction of ground water.**
 - (ii). Letter (dtd. 17.04.15.) was sent to Executive Engineer, Water Resources Deptt. Bhopal for their opinion regarding the impacts due to proximity of the river & canal. The reply is awaited. **It is decided that a reminder letter should be sent to Executive Engineer, Water Resources Deptt. Bhopal.**
 - (iii). PP has submitted proposed Rain water harvesting plan with 05 nos of percolation wells along with layout. **It is decided that PP should ensure rain water harvesting.**
 - (iv). PP has submitted detail landscape plan with no. of trees. **It is decided that Plantation should be done in two rows all along the periphery of the project area, avenue plantation along the roads with one tree per 100 sq. m. of the plot area. PP should ensure plantation of the trees of indigenous local varieties like Neem, Peepal, Kadam, Kachnaar etc along with ornamental varieties.**
 - (3) **PP should submit the above information latest by 30.07.2015."**

- (2) In response to above query, reply submitted by Executive Engineer Water Resource Deptt. Bhopal Division, (vide letter dtd 10.07.2015 received in SEIAA office on 10.07.2015) was examined and it is noted that :-

- (i). WRD has informed that the proposed M/s Priyadarshani Unique Construction Housing Project is located near the Kaliyasot canal distributary M-1 and suggested following measures :-

- कलियासोत की एम-1 नहर हेतु विभाग द्वारा कुल 21 मीटर भूमि अर्जित की गई है जो नहर के मध्यम से दोनों ओर 10.50-10.50 मीटर है, का क्षेत्र खुला रखा जायेगा, जिस पर किसी प्रकार का निर्माण नहीं होगा।
- माईनर में किसी भी प्रकार का पानी नहीं छोड़ा जायेगा। जैसे कि सीवेज, सीवर वर्षा का पानी इत्यादि।
- कचरा, प्लास्टिक एवं अन्य किसी भी प्रकार की सामग्री नहर में न डाली जाये जिससे कि प्रदूषण एवं नहर प्रदूषित/प्रभावित हो।

PP vide letter dtd 14.07.2015 has submitted written commitment to follow the above conditions.

- (ii). The Authority decided that :-

- a. PP should ensure the above conditions given by EE, Water Resource Deptt. Bhopal Division.
- b. PP should leave 15 m wide buffer zone all along the canal boundary and plant at least three rows of trees in the buffer zone.
- c. Hon'ble NGT Central Zone Bench Bhopal in its order dated 30.03.2015 in the original application Nos. 135/2014(CZ) and 48/2014 (CZ), directed that along the river Kaliyasot construction activity within 200 m. shall be restricted and beyond 200 m. green land it would be open for the construction activity. Moreover no untreated sewage will be discharged into Kaliyasot river and PP has to install requisite STP. PP will have to adhere to the directives of NGT and modify the development and building permissions, if obtained. The respective departments should also be informed to modify the permissions accordingly.

After deliberation it was decided to send the mining plan back to Director, Geology & Mining for a further scrutiny and to approve the mining plan afresh. This has been a general complaint of the RQPs who are not attentive in preparing the mining plans and also lack of attentiveness at the Director's level while approving the mining plan. Copy to PP.
