

## Minutes of the 223<sup>rd</sup> Meeting of SEIAA dated 29.07.2015

The 223<sup>rd</sup> meeting of the State Level Environment Impact Assessment Authority was convened on 29.07.2015 at the Authority's Office in Environmental Planning and Co-Ordination Organization (EPCO), Paryavaran Parisar, Bhopal. ### A. Policy Decision :

#### 1. Acceptance of online applications after complete documents :

The authority has noted that to facilitate Project Proponents (PPs) and for quick disposal of the applications a policy decision was taken in 166<sup>th</sup> SEIAA meeting dated 13.10.2014, but it has been observed that PPs are not uploading the required documents during online submission of the application.


Presently the SEIAA office is accepting the online applications even if some documents are not uploaded and application is being registered after submission of the hard copy. The hard copy of the application alongwith incomplete attachments is being forwarded to the Secretary, SEAC with instruction to PP to submit the lacking informations at SEAC office invariably otherwise his case shall not be appraised.

It is noted that in the current procedure once the hard copy is submitted at SEIAA office and case is registered, the PP becomes non serious in submitting the lacking documents. Due to this practice, the appraisal at SEAC level gets delayed. Moreover sometimes though the cases are recommended by SEAC the requisite documents are not submitted by PP and SEIAA has to raise the query to submit the said information and as such this become a reason of further delay in disposal of the case.

**In the context of above the authority decided that now onward the SEIAA office will accept only those online applications which are complete in all respect and required documents have been uploaded and after submitting the hard copy of the same alongwith complete documents the case shall be registered & forwarded to SEAC.**



*".....It was decided that this is a case of violation and action should be taken as per MoEF, OM dated 12.12.2012 and 27.06.2013 regarding violation. The following action has been decided:*

- a) A letter to be written to the PP to submit a formal resolution passed by Board of Directors or the managing committee to insure that violation will not be repeated, as mentioned in para 5 (i) of the said OM dated 12.12.2012. The PP shall submit the resolution within 60 days from the date of issue of letter. In the mean time the case will be delisted.*
- b) A letter to be written to the State Government to initiate credible action on the violation by invoking powers under Section 19 of the Environment (Protection) Act 1986 for taking necessary legal action under Section 15 of the Act for the period for which the violation has taken place and evidence provided to MP-SEIAA of the credible action taken."*

PP has submitted a formal resolution passed by the Board of Directors accepting the violation. A letter to initiate credible action against the PP has already been written to Principal Secretary, Urban Development & Environment Department. However in the meanwhile, Hon'ble NGT in its order dtd. 07.07.2015 has quashed the MoEF & CC, OM dtd. 12.12.2012 and 27.06.2013 and as per the policy decision taken in 219<sup>th</sup> SEIAA dtd. 16.07.2015 the proceeding shall be kept in abeyance till the final directives of NGT/ MoEF & CC.
