- (2) After deliberations by PP the case was discussed in depth and it is noted that :-
- (i). The proposed project is multi storied "Corporate Commercial Office Block" at Village Khazrana, Tehsil & District Indore MP. The project includes the construction of Offices & Food Court.
 - (ii). As per the T & CP Indore (vide letter no.2274 dtd.29.04.08) the total land area is 8795.61 sq.m. the total land area proposed by PP for prior EC is 8739.66 sq.m. and total built up area is 45596.47 sq.m. The project comes under 8 (a) category (B) of schedule of EIA Notification, 2006 because total construction is between 20,000 sq mt. & 1, 50,000 sq mt. and plot area is less than 50 ha.
 - (iii). The case was discussed in SEAC meeting 203rd dtd. 03.07.15 and is recommended for grant EC subject to 04 special conditions.
 - (iv). As per Khasra Panchsala (2014-15) submitted by PP the land is in the name of Babylon Infrastructure Pvt. Ltd through Shri Aalok S/o Shri D. P. Bhandari.
 - (v). The total water requirement is 159 KLD and fresh water requirement is 73 KLD. The total recycled water 101 KLD (86 KLD Flushing +15 KLD Horticulture & Car Wash). The source of water supply is Indore Municipal Corporation. PP has submitted letter (dtd. 25.02.15) from Nagar Nigam Indore for supply of water. **It is decided that the entire demand of fresh water should be met from municipal supply and there should be no extraction of ground water.**
 - (vi). The total waste water generation is 143 KLD. PP has provided sewage treatment plant of 175 KLD. The available treated water is 123 KLD. PP has proposed to recycle 101 KLD (86 KLD Flushing +15 KLD Horticulture & Car Wash) and remaining 22 KLD treated waste water shall be discharged in municipal sewer line. PP has submitted letter (dtd. 25.02.15) from Nagar Nigam Indore for disposal of extra treated waste water. **It is decided that PP should ensure linkage with municipal sewer line for disposal of extra treated waste water.**
 - (vii). Approximately 483 Kg per day Municipal Solid waste shall be generated which is proposed to be segregated at source with three colour bins. PP has also proposed to use biodegradable waste for gardening purpose and non-biodegradable/non recyclable wastes shall be disposed to the common municipal waste landfill site. PP has submitted NOC from Indore Municipal Corporation letter (dtd. 08.04.15) for disposal of solid waste. **It is decided that PP should:-**
 - a. Provide compactors for MSW
 - b. Ensure three bin system for segregated collection of waste.
 - c. Ensure linkage with Indore Municipal Corporation for final disposal of MSW.



- (viii). The maximum height of the building is Basement + 42.5 mt (Total 10 floor). The Road width of MR-10 is 75m. PP has provided Width of main access road of 12 m; Front MOS 21.5 m and rear 12 m. **It is decided that PP should ensure road width; MOS and Open spaces as per MPBVR 2012 Rule 42 (2); table 5 for buildings height upto 45 m.**
- (ix). PP has proposed to provide underground Water Storage Tank, Terrace Tank, Internal Fire Hydrant System (Wet Riser System), External Hydrant, Automatic Sprinkler System, Fire Pump House, Portable Fire extinguishers etc. as per NBC 2005. **It is decided that as per MPBVR, 2012 rule 42 (3) PP should submit necessary drawings and details to the Authority (Nagar Nigam, Indore) incorporating all the fire fighting measures recommended in National Building Code part – IV point no. 3.4.6.1. The occupancy permit shall be issued by Nagar Nigam only after ensuring that all fire fighting measures are physically in place.**
- (x). PP has proposed to provide roof top rain water harvesting system with 2 nos. of recharging pits. **It is decided that PP should ensure the rain water harvesting. In addition PP should provide recharging trenches. The base of the trenches should be Kachha with pebbles.**
- (xi). The total power requirement is 6170 KW. PP has also proposed power back up 3 DG set of 1500 KVA. For energy conservation PP has proposed LED lights in common areas, solar water heater system etc. **It is decided that PP should ensure installation of photovoltaic cells (solar energy) for lighting in common areas, LED light fixtures, energy efficient double glazed glasses and other energy efficient equipments.**
- (xii). PP has proposed to provide parking for 506 cars and has earmarked 12186.23 sq.m. area for parking (Basement -1, 2 & 3 = 10486.23 sqmt. + Ground= 1700 sqmt.) for the same. **It is decided that PP should ensure the car parking for 506 ECS as proposed.**
- (xiii). Out of the total land (8739.66 sq m.) an area of 875 sq.m (10%) was proposed to be developed as green area with 30 nos. of trees such as Neem, Ashok, Arjun, Kusum, Siris and Satparni etc however in landscape plan majority of trees shown are of palm variety. As per SEAC meeting 203rd dtd. 03.07.15 it is recorded that "875 sq mt area as open for landscaping was proposed which is 10 % of the total plot area. The Committee has asked to increase the landscape area and row plantation all along the boundary and asked to submit the layout in this regard. PP has submitted the landscape layout with area of landscape enhanced to 14% (about 1286.90 sq mt)" **The Authority decided that PP should ensure :-**
- a) Plantation in 1286.90 sqmt. (14%) of the total plot area and plant saplings at least 3 years old. As proposed by PP the distance of 5 m between the two trees should be reduced to 3

m and the number of trees should be increased to at least 120 trees.


- b) Plantation should be done all along the periphery of the project area, avenue plantation along the roads. PP should ensure plantation of the trees of indigenous local varieties like Neem, Peepal, Kadam, Karanj, Kachnaar etc along with ornamental varieties.
 - c) Every effort should be made to protect the existing trees on the plot.
 - d) PP should take permission from the concerned Authority and ensure the maintenance of the green belt developed by Nagar Nigam in the front of the project building.
- (3) It is decided to accept the recommendations of 203rd **SEAC meeting dtd 03.07.15 with 04 special conditions and accord prior Environmental Clearance** to proposed Corporate Commercial Office Block at Khasra no. 28/1, 28/2/2, 28/2/3, 28/2/4, 28/2/5, 28/3/1, 28/3/2, 28/3/3, 28/3/4, Village Khazrana, Tehsil & District Indore MP, Total Land Area - 8739.66 sq m., Total Built Up Area - 45596.47 sq. m. by Shri Gurjeet singh Chhabra (Managing Director) Babylon Infrastructure Pvt. Ltd. 4th Floor, C-21 Mall A.B. Road, Indore (MP) - 462032 **subject to all specific conditions imposed by SEIAA in its meetings.**

- (1) The case was discussed in 222nd SEIAA meeting dtd 27.07.2015 and it is recorded that "After detailed discussion and perusal of the recommendations of 204th SEAC meeting dtd. 04.07.2015, PP should be invited for a detailed presentation."
- (2) After deliberations by PP the case was discussed in depth and it is noted that :-
 - (i). The proposed project is building construction of residential towers "Sagar Life Style" at Khasra No. 112/1/Kha, 112/1/3/1, 112/2/1/3/2, 108/4/1, Village - Misrod, Tehsil - Huzur, District-Bhopal (MP). The project includes the construction of 8 towers with 564 Multiunit (HIG-288, MIG-192, LIG-36 & EWS-48), Club house & shops (5-nos).
 - (ii). As per the T & CP Indore (vide letter no. 1467/LP-109/29/ NAGRANI /JIKA/ 2013, dtd 02.09.2013). The total land area is 2.955 ha.(29550.0 sq.m.) The total built up area proposed by PP is 58950 sq.m. The project comes under 8 (a) category (B) of schedule of EIA Notification, 2006 because total construction is between 20,000 sq mt. & 1, 50,000 sq mt. and plot area is less than 50 ha.



- (iii). The case was discussed in SEAC meetings 204th dtd. 04.07.15 and is recommended for grant EC subject to 05 special conditions.
- (iv). PP has submitted copy of Khasra Panchsala 2012-13. As per Khasra Panchsala the land is in the name of Shri Sudhir Kumar Agrawal. **It is decided that PP should submit notarized copy of partnership deed / joint venture agreement.**
- (v). The total water requirement is 383 KLD and fresh water requirement is 255 KLD. The total recycled water 143 KLD (128 KLD Flushing +15 KLD Horticulture). The source of water supply is Bhopal Municipal Corporation. PP has submitted letter (dtd. 30.03.15) from Nagar Nigam Bhopal for supply of water. **It is decided that the entire demand of fresh water should be met from municipal supply and there should be no extraction of ground water.**
- (vi). The total waste water generation is 345 KLD. PP has provided sewage treatment plant of 375 KLD. The total treated waste water is 311 KLD. Out of this 143 KLD is proposed to be recycled (128 KLD Flushing +15 KLD Horticulture) and remaining 168 KLD is proposed to be discharged in municipal sewer line. PP has submitted letter (dtd. 04.02.14) from Nagar Nigam Bhopal for disposal of extra treated waste water in to the nearby Nalla. **It is decided that PP should submit clear NOC from Nagar Nigam, Bhopal for disposal of extra treated waste water in the municipal sewer line.**
- (vii). The proposed site is in near vicinity to the existing canal of river Kaliyasoat. **It is decided that PP should ensure that a buffer of 10.5 m should be left from the centre of the canal.**
- (viii). Approximately 1574 kg per day of Municipal Solid waste shall be generated which is proposed to be segregated at source and Organic/Biodegradable waste will be handed over to local vendor for composting. Inorganic waste like plastic, packing material, metal shall be sold to recyclers/vendors for recycling. Final disposal is through Municipal Corporation Bhopal. PP has submitted NOC from Indore Municipal Corporation letter (dtd. 17.10.13) for disposal of solid waste. **It is decided that PP should:-**
 - a. Provide compactors for MSW
 - b. Ensure three bin system for segregated collection of waste.
 - c. Ensure linkage with Bhopal Municipal Corporation for final disposal of MSW.
- (ix). The maximum height of the building is 18.0 M + Podium Parking + Stilt. PP has proposed to provide width of main access 12 m; Front MOS 7.5 m and rear 6.0 m. **It is decided that PP should ensure road width; MOS and Open spaces as per MPBVR 2012 Rule 42 (1); table 4 for buildings height upto 18 m.**

- (x). PP has proposed to provide overhead tank. Landing valves with hose reels, External hydrant all around the building & yard, automatic sprinkler system Pumping arrangement system- Riser system with pressure pump, auto operation with pressure switch etc. as per NBC 2005. **It is decided that as per MPBVR, 2012 rule 42 (3) PP should submit necessary drawings and details to the Authority (Nagar Nigam, Bhopal) incorporating all the fire fighting measures recommended in National Building Code part – IV point no. 3.4.6.1. The occupancy permit shall be issued by Nagar Nigam only after ensuring that all fire fighting measures are physically in place.**
- (xi). PP has proposed to provide roof top rain water harvesting system with 09 nos. of recharging pits. **It is decided that PP should ensure the rain water harvesting. In addition, PP should provide recharging trenches. The base of the trenches should be Kachha with pebbles.**
- (xii). The total power requirement is 5000 KW/day. PP has proposed LED lights in the common areas, landscape areas, signages, entry gates and boundary walls etc. DG sets on auto cut and auto start controlled mechanism. **It is decided that PP should ensure installation of photovoltaic cells (solar energy) for lighting in common areas, LED light fixtures and other energy efficient equipments.**
- (xiii). PP has proposed to provide parking for 510 ECS (Podium-14657.51/30= 489ECS + Stilt – 628.57/30=21 ECS). **It is decided that PP should ensure the car parking for 510 ECS as proposed.**
- (xiv). Out of the total land (29550.0 sq.m.) an area of 2955.0 sq.m (10%) is proposed to be developed as green area. As per SEAC 204th meeting dtd.04.07.15 it is recorded that *"Total open space for landscape is proposed as 2955 sq mt which is as per T & CP. PP has informed that the inclusive of podium landscape, road side and boundary wall plantation, the area comes 5586 sq mt which is nearby 18% of the area"*. **It is decided that PP should ensure**
- Plantation in 5586 sqmt. (18%) of the total plot area and plant saplings at least 3 years old.
 - Plantation should be done in two rows all along the periphery of the project area, avenue plantation along the proposed 24 m wide master plan road. PP should ensure plantation of the trees of indigenous local varieties like Neem, Peepal, Kadam, Karanj, Kachnaar etc along with ornamental varieties.
 - Every effort should be made to protect the existing trees on the plot.
- (3) **PP should submit the above information latest 30.09.2015.**

(1) After detailed discussion and perusal of query response of 210th SEIAA meeting dtd. 22.06.2015 and recommendation of 194th SEAC meeting dtd. 31.05.2015, it was decided to grant Prior Environmental Clearance with slight modifications in the conditions imposed by SEAC.

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The average depth of the pit shall not exceed 3m at the end of lease period and not beyond that.
- (iii) A buffer zone of 7.5 m. should be kept towards the state highway.


