(1) The case was discussed in 227th in SEIAA meeting dtd 14.08.2015 and it is recorded that "(1)..... (2) ... In response to above query, reply submitted by PP (vide letter dtd 03.08.15 received in SEIAA on 03.08.15) was examined in depth and it is noted that:-


- (i). PP has submitted notarized copy of partnership deed.
- (ii). PP has submitted water balance chart. The total water requirement is 207 KLD and fresh water requirement is 114 KLD. Waste water generation is 184.3 KLD and has proposed two STPs of capacity is 200 KLD (100 KLD-2 nos.). The total treated waste water shall be 154 KLD out of this the recycled water is 119.2 KLD (93.2 KLD flushing + 26 KLD horticulture). The extra treated waste water 34.8 KLD is proposed to be discharge in municipal sewer line. PP has submitted Bhopal Municipal Corporation letter dtd 26.02.15 regarding extra treated waste water in municipal sewer line. **It is decided that:-**
 - a. PP should ensure linkage with municipal sewer line for disposal of extra treated waste water.
 - b. PP should ensure STP for 200 KLD and accordingly increase the budget.
- (iii). PP has submitted layout plan showing the required parking however the parking plan with details of area provided for parking in stilt, basement & open etc. have not been given. **It is decided that PP should submit parking plan with details areas earmarked for parking in the stilt and open area etc.**
- (iv). PP has submitted landscape plan with no. of trees (approx. 400) including two rows for front area periphery and single row for duplex. **The authority decided that PP should ensure:-**
 - a. Plantation in 5287.00 sqmt. (13.59%) of total plot area (3.919 ha) and plant 600 tree saplings at least 3 years old.
 - b. Plantation should be done in two rows all along the periphery of the project area except the row houses located along the boundary wall where one row of trees should be planted along the boundary of the project area, avenue plantation along the roads, play ground and other amenities area. PP should ensure plantation of big trees of indigenous local varieties like Neem, Peepal, Kadam, Karanj, Kachnaar etc along with ornamental varieties.


a. Every effort should be made to protect the existing trees on the plot.
(3) PP should submit the above information latest by 30.09.2015.


(2) In response to above query, reply submitted by PP (vide letter dtd 31.08.15 received in SEIAA on 01.09.15) was examined in depth and it is noted that:-

- (i). PP has submitted details of areas for parking and has provided parking space of 292 ECS (stilt 4350 sqmt. / 30 = 145 ECS ; Basement 2850 sqmt. / 35 = 81 ECS ; Open 1650 sqmt. / 25 = 66 ECS). **It is decided that PP should ensure the car parking for 292 ECS as proposed.**

(1) The case was discussed in 227th SEIAA meeting dtd 14.08.2015 & it is recorded that "(1)..... (2) In response to above query, reply submitted by PP vide letter dtd 05.08.15 received in SEIAA on 05.08.15) was examined in depth and it is noted that:-

- (i). PP has submitted Bhopal Municipal Corporation letter for supply of 400 KLD fresh water and take bulk connection from nearby overhead tank. **It is decided that the entire demand of fresh water should be met from municipal supply and there should be no extraction of ground water.**
- (ii). Regarding condition imposed by SEIAA for discharge of extra treated waste water in municipal sewer line PP has submitted that presently there is no sewer line in the area. Hence, whenever the sewer line is laid in the municipal area the discharge of treated waste water shall be linked with municipal corporation sewer line until then the treated waste water shall be discharged in the open drain as per the BMC letter dtd 15.05.15. **It is decided that PP should submit the NOC of Nagar Nigam, Bhopal in respect of proposed sewerage system plan at Katara Hills, Bhopal.**

(3) **The above information should be submitted latest by 30.09.2015."**

(6) The case was discussed in depth and it is noted that :-

- (i). The Industry is operating in an old Industrial area which was notified prior to 2006 hence public hearing is exempted as per MoEF & CC, Gol OM dtd 10.12.14.
- (ii). Member Secretary, MPPCB vide letter no. 1564 dtd 19.03.15 has informed that no legal notice has been issued to the Industry during 2001 to 31.08.2013 under EPA 1986 section 5, Water (Pollution Prevention & Control) Act 1974, Air (Pollution Prevention & Control) Act 1981.
- (iii). PP has submitted acknowledged copy of Compliance report submitted to Regional office, MoEF, Bhopal, however these are not certified. **It is decided that since the industry is in operation PP should submit compliance report of the prior EC conditions duly certified by, MoEF & CC, Gol Regional Office, Bhopal.**

(7) PP should submit the above information latest by 30.06.2015. A copy of this letter should be endorsed to Director, MoEF & CC, Gol Regional Office, Bhopal.

Committee found it difficult to fix up the responsibilities pertaining to post mining EMP for the proponents of these two mines, therefore it was decided to visit the area before taking final decision in the matter. However the presentation made by the PP and the submissions made thereby revealed that following information with supporting documents have to be submitted by the PP and the submissions made thereby revealed that following information with supporting documents have to be submitted by the PP:

- Distance of site from the nearest inter-state boundary has to be submitted with validation from responsible Government Authority.
- Map showing micro-level features in 2Km radius around the site.
- Location of OB area to be shown on conceptual plan.
- Details of CSR activities with budgetary provision to be submitted; a commitment has to be submitted that the funds shall be spent through Gram Panchayat.
- Plantation scheme with provision to complete the desired plantation in 33% of total lease area within a period of 08 years. Scheme should clearly indicate the species of plants to be planted. At least 2000 plants per Hectare should be planted.
- NOC from Gram Sabha for mining.
- Quantity of water required has to be submitted along with the source of the same. Capacity of the existing pits and the quantity of stored water in these pits has to be submitted as per the discussion in the meeting.
- NOC from Forest department in the prescribed format.
- Copy of mining lease and approved mining plan.
- Compliance of TOR."
