

After detailed discussion and perusal of the recommendation of 214th SEAC meeting dtd. 20.08.2015 :-

"PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar. Concerned Mining Officer vide letter no. 1997 dated: 22/12/14, has reported that there is no more mines operating or proposed within 500 meters around the said. After deliberations committee observed following discrepancies in the submissions.

- Mining Plan is lacking the provision of 7.5 meter mandatory buffer zone all around the periphery.
- Certificate from DFO in the prescribed format regarding distances of nearest forest boundary and the details of notified protected areas within 10 km from the project site has not been furnished.

Hence it was decided to return the case to SEIAA for delisting till submission of the above information / documents."

It is decided to delist the case on the above observation. The case will be relisted on submission of valid information and its review. Copy to PP and all concerned.

After detailed discussion and perusal of the recommendation of 214th SEAC meeting dtd. 20.08.2015 :-

"The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'A'.

1. Production of stone boulder shall be as per the approved mining plan not exceeding 10000 cum / Year.
2. Crusher shall not be allowed in the lease area.
3. DFO has reported the nearest forest boundary at 11 Km from the project site nevertheless information pertaining to notified protected areas has to be submitted to SEIAA in the prescribed format.
4. EC shall be valid only for two years as the temporary permit has been issued for 02 years only."


