

- (1) The case was discussed in 220th SEAC meeting dtd. 26.08.2015 and it was recorded that:-

During presentation and scrutiny of document reveals that there are several discrepancies in the information provided in Form-1/PFR and information provided by PP during presentation such as distances from Bhopal city, Airport etc. The issues of environmental sensitivity are also not addressed properly in Form-1. All the co-ordinates of the proposed site should be mentioned in the form-1/PFR to ascertain the precise location of site. Apparently, it also appears that the site is within the 10 Kms radius of Van Vihar, National Park (a Notified PA). However, in the Form-1 in the description of "environmental sensitive area within 15 kms radius" no such mention has been made. This information is vital for appraisal. PP is to mention exact distance of project site from the van vihar in the form-1. In view of above discrepancies, PP was asked to revise the Form-1 on the basis of factual information and resubmit it to SEIAA. The case is returned to SEIAA for delisting."

Since the PP has not submitted the factual information in Form-1 the case is hereby closed. PP should submit fresh Form-1 incorporating all such informations required for Prior EC as mentioned in the 220 SEAC meeting minutes. Copy to PP and all concerned.

After the perusal of 221st SEAC meeting minutes dtd. 27.08.2015 it is reported that :-

"As per site inspection report:- "This is a mine lease of Basalt Stone Quarry in an area of 2.560 ha. The site is approx. 1.00 Kms away from the Ujjain - Badnagar Highway and the mine is connected to this highway through a kachha village road and the distance is approx 750 meters. No water body seen in the nearby area except an old mined pit of about 20 meter depth which was having plenty of water at the time of inspection. Crushing operations are not proposed on this site. The topography of the site is hilly about 25 meters above the ground level and as stated by the mine owner, mining is proposed above the ground level. The main purpose of this visit was to verify the location of Primary School and habitation within 500 meters as stated by the tehsildar in his certificate. As per visual observations, primary school is about 600 meters away from the site and village Jalakhedi is further 750 meters away from

the site. The wind direction at the time of inspection was from west to east and the school and Jalakhedi village are in west direction. During site inspection, no other activities could be seen in and around the site and the site is suitably away from human settlements, water body, highway and forest area and thus no adverse effects envisaged due to this mining activity. However, PP can be asked to carryout extensive plantation near village road to avoid fugitive emission due to transportation of minerals". In view of above site visit, committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'A': Production of Stone not exceeding 1,50,000 m³/Year considering the area of pit, mineral reserves and balance lease period, the quantity has been reduced for safe and sustainable mining with depth restriction of 20 meters."




