





*As per the co-ordinate provided by the PP, the google image shows that the interstate boundary is about 3.4 Kms and the area is 5.7 ha., thus the project falls under the Category-A. The case is therefore sent back to SEIAA for necessary action."*

After detailed discussion, it was decided to accept the recommendation of SEAC. The case is hereby closed since the mining site falls within 5 kms. from the Inter-State boundary and area is more than 5 ha. Copy to PP and all concerned.

Collector, Sehore should get this verified and submit the information by 31.10.2015. Copy to PP and Mining Officer, Sehore.

*"PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 483 dated: 8/6/2015, has reported that there is no more mines operating or proposed within 1000 meters around the said mine.*


*During scrutiny of document and presentation by PP it was observed that mining lease is in the u/s of two bridges which are 122 meters and 150 meters away respectively. PP during presentation informed that this mining lease is on "Kali Sindh" river and the same has been mentioned in the "Drainage Details" of the mining plan but at the same time in Chapter -1 of mining plan in "Introduction" the name of the river is mentioned as "Bearma River". This clearly indicates that misleading information has been given in mine plan thus case is rejected and file is sent back to SEIAA."*

After detailed discussion and observing the site through google map, it is very close to human habitation and National Highway besides the above observation of SEAC. It is decided to accept the recommendations of SEAC. The case is hereby rejected. Copy to PP and all concerned.






