- (2) The proposed project is a Building & Construction Residential Development Project "Asteria" at Khasra No. – 2, 3, 5, 6, 7, 10, 13/1, 14/1, 29, Village - Pipelia Kasho, Teh.-Huzur, Distt.-Bhopal (M.P.). The project includes construction of total 412 Residential Unit (villas-332, LIG apartment 48 & E. W. S 32) & convenient shops.
- (3) As per the T & CP Bhopal (vide letter dtd 09.12.2013). The total land area is 7.52 ha (75160.71 sq.m). The total built up area proposed by PP is 43691.18 sq.m. The project comes under 8 (a) category (B) of schedule of EIA Notification, 2006 because total construction is between 20,000 sq.mt. & 1,50,000 sq mt. and plot area is less than 50 ha.
- (4) The case was discussed in SEAC meetings 196th dtd. 02.06.15, 203rd dtd. 03.07.15, 213th dtd. 08.08.15 & 221st dtd.27.08.15 and is recommended for grant of prior EC subject to 07 special conditions.
- (5) After deliberations by PP, the case was discussed in depth & it is noted that:
 - (i). PP has not submitted latest copy of Khasra Panchsala regarding land ownership. **PP should submit latest Khasra Panchsala for landownership.**
 - (ii). As per T & CP approved lay out a canal is existing towards south-east direction beyond 12m wide proposed approach road for the project site. PP informed that the canal is of non-functional nature. **It is decided to write a letter to EE, WRD, Bhopal to clarify the status of the canal. Copy to PP.**
 - (iii). The total water requirement is 193 KLD and fresh water requirement is 140 KLD. The total recycled water 77.4 KLD (53.3 KLD for flushing and 24.1 KLD for horticulture).The source of water supply is Ground water. PP has submitted a copy of application dtd 06.02.2015 to CGWA for abstraction of ground water. **It is decided that PP should submit NOC from CGWA / Municipal Corporation, Bhopal specifying the quantity of fresh water required for the project.**
 - (iv). The total waste water generation is 174 KLD. PP has provided sewage treatment plants of 200 KLD. The total treated waste water is 157 KLD, Out of this 77.0 KLD proposed to be recycled (53.0 KLD for flushing and 24.0 KLD for horticulture) and remaining 80 KLD proposed to discharge in municipal sewer line. PP has submitted copy of letter dtd 22.12.2014 from Municipal Corporation, Bhopal for disposal of extra treated waste water. **It is decided that PP should ensure linkage with municipal sewer line for disposal of waste water.**
 - (v). A Nalla traverses the northern side of the proposed site. **A green Buffer of 20 m should be created between the Nalla and the site and it should be ensured that no extra treated water is disposed off in the Nalla.**
 - (vi). Approximately 2.59 MT /day Municipal Solid waste shall be generated. The generated biodegradable and non biodegradable waste will be collected in twin Bin system within the campus and final disposal through Municipal Corporation Bhopal. The sewage sludge generated from STP will be disposed off in accordance with MSW Rules. PP has

submitted copy of letter dtd 15.12.2014 from Municipal Corporation, Bhopal for disposal of solid waste. **It is decided that PP should:-**

- a. **Provide compactors for MSW**
 - b. **Ensure three bin system for segregated collection of waste.**
 - c. **Ensure linkage with Bhopal Municipal Corporation for final disposal of MSW.**
- (vii). PP has proposed Hazardous waste & E- waste will be stored at separate place and handover to authorized dealers of CPCB. **It is decided that, (Management and Handling) Rules, 2011 should be followed strictly for the disposal of Hazardous waste & E-waste.**
- (viii). PP has proposed the maximum height of the building is 15m (s +4). PP has proposed 12 m, 7.5 m & 6 m wide internal roads. **It is decided that PP should ensure road width; MOS and Open spaces as per MPBVR 2012.**
- (ix). PP has proposed to provide External Fire Hydrant System, Wet Riser System, Portable Fire extinguisher, Sprinkler System, fire detector, fire water pumps & Fire Alarm system. etc. as per NBC 2005. **It is decided that as per MPBVR, 2012 rule 42 (3) PP should submit necessary drawings and details to the Authority (Nagar Nigam, Bhopal) incorporating all the fire fighting measures recommended in National Building Code part – IV point no. 3.4.6.1. The occupancy permit shall be issued by Nagar Nigam only after ensuring that all fire fighting measures are physically in place.**
- (x). PP has submitted roof top rain water harvesting system for ground water recharging and has proposed 07 no of recharging pits. **It is decided that PP should ensure the rain water harvesting. In addition, PP should provide recharging trenches. The base of the trenches should be Kachha with pebbles.**
- (xi). The total power requirement is 1460 KW(1825 KVA). The source of electricity is Madhya Pradesh Kshetra Vidyut Vitran Company Limited. PP has also provided power back up 1x100 KVA. For energy conservation, PP has proposed use of CFL & fluorescent lamps in the common areas; Use of solar lights in open areas and landscaped area; use of energy efficient appliances. **It is decided that PP should ensure installation of photovoltaic cells (solar energy) for lighting in common areas, LED light fixtures, and other energy efficient equipments.**
- (xii). PP has proposed to provide total **396 ECS** (Individual car parking for villas & LIG - 332 ECS; 10% visitors open - 33 ECS; EWS apartments stilt- 31ECS). **It is decided that PP should ensure to provide car parking as per MPBVR 2012.**
- (xiii). PP has proposed 12025.71 sq. m. (16% of the plot area) to be developed as green by planting 370 tall trees near nalla & 365 tall trees around periphery along with herbs & shrubs. **It is decided that:-**

- a. PP should maintain continuity of the green belt around periphery of the project.
- b. PP should ensure additional plantation to the 12025.71 sq. m. (16% of the plot area) as per the proposed landscape plan. At least 3 years old saplings should be planted.
- c. Plantation should be done in two rows all along the periphery of the project area. Avenue plantation along the roads with one tree per 100 sq. m. of the plot area. PP should ensure plantation of the trees of indigenous local varieties like Neem, Peepal, Kadam, Karanj, Kachnaar etc along with ornamental varieties.
- d. Every effort should be made to protect the existing trees on the plot.
- e. A revised plan showing green belt and other plantation should be submitted.


(xiv). Under CSR activities PP has proposed to provide rural sanitation, medical aid to charitable hospital and rural road construction & maintenance. **It is decided that PP should submit the specific CSR plan in consultation with district administration and Gram Panchayat of the nearby villages including budget for the same.**

(6) **PP should submit the above information latest by 15.11.2015.**



- (1) The case was discussed in 241st SEIAA meeting dtd. 22.09.2015 and it was recorded that "After detailed discussion and perusal of the recommendations of 218th SEAC meeting dtd. 24.08.2015, PP should be invited for a detailed presentation **as per MoEF, GoI Office Memorandum dtd 19.06.2013.**"
- (2) The proposed project is a Building & Construction Residential Development Project "Fortune Soumya Santoza" at Khasra No.-35, 40, 48, 49, P.H. NO:25, Village-Bagli, Tehsil-Huzur, District-Bhopal (MP).The project includes construction of total 140 Residential Unit (duplexes), 55 E. W. S. & convenient shops.

- (i). PP has submitted copy of Khasra Panchsala 2012-13 and joint venture agreement (dtd. 26.02.14). As per Khasra Panchsala the land ownership is not related with PP. **It is decided PP should submit latest Khasra Panchsala for clarification of land ownership.**
- (ii). The total water requirement is 216 KLD and fresh water requirement is 100 KLD. The total recycled water 116 KLD (46 KLD for flushing and 70 KLD for gardening). The source of water supply is Municipal Corporation, Bhopal. PP has submitted letter (dtd. 10.06.2015) from Municipal Corporation for supply of water 150 m³ / day. **It is decided that the entire demand of fresh water should be met from municipal supply and there should be no extraction of ground water.**
- (iii). The total waste water generation is 134 KLD. PP has provided sewage treatment plants of 160 KLD. The total treated waste water is 130 KLD, Out of this 116 KLD proposed to be recycled (46 KLD Flushing + 70 KLD Horticulture/Green area) and remaining 04 KLD (Non monsoon) & 74 KLD (Monsoon) proposed to discharge in municipal sewer line. PP has submitted letter dtd 22.12.14 from Nagar Nigam Bhopal for disposal of extra treated waste water. **It is decided that :-**
 - a. **PP should ensure zero discharge of waste water in the project area until the municipal sewer line is laid.**
 - b. A Nalla traverses the eastern side of the proposed site, which ultimately meets the confluence of River Betwa. **A green Buffer of 20 m should be created between the Nalla and the site and it should be ensured that no extra treated water is disposed off in the Nalla.**
 - c. **PP should ensure linkage with municipal sewer line for disposal of waste water whenever municipal sewer line is laid in the project area.**



(1) After detailed discussion and perusal of the query response of 182nd SEIAA meeting dtd. 24.02.2015 & recommendation of 166th SEAC meeting dtd. 09.01.2015 it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall not exceed 6.0 m. at the end of lease period and not beyond that.





In the light of above circulars and ordinance, renewal of earlier forest clearance is not required at this stage as the lease and the forest clearance are now renewed as per the provision made in the ordinance.


Since the case does not require forest clearance for the further period of lease and it will be co-terminous with the extended period of mining lease, the condition for obtaining forest clearance put down in earlier recommendation (155th meeting dated 11.11.2014) is withdrawn hereby and committee decided to recommend the case for grant of prior EC subject to the following special conditions:


1. Early stabilization of all new dumps to be taken up.
2. Re handling of dump should be taken carefully to avoid spillage towards agricultural field.

3. Back filling need to be started on concurrent basis as soon as mining resumes its operation.
 4. Proper slope and benches with retaining wall for the dumps is suggested to prevent spillage of waste to agricultural land.
 5. About 4.948 ha area proposed to be converted as water reservoir shall be developed with proper benches, fencing and aesthetics.
 6. The existing garland drains towards Banjar River have to be re-designed keeping in view the future exploitation. The dumps in this region shall be stabilized on priority.
 7. All suggestions made in the EMP have to be executed as essential conditions.*
- (5) PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (6) It was noted that the inter-state boundary, National Park/Sanctuary are not located within 10 Km. radius. Hence, the **General Condition is not attracted.**
- (7) It was noted that the mining plan is approved by the IBM (vide letter no. MP/Mandla/Dolo/MPLN/R-14/2013-14 dtd. 02.06.2014. As per mine plan the life of mine is 29 years.
