1. **Case No. 713/2012** Prior Environmental Clearance for Bulk Drugs - Change in Product mix and introduction of new products; Intermediates and API for total 66 products with production capacity of 2951 MTPA at Plot no. Q-1 to Q-4 Ghorongi Industrial Area, Village Malanpur, Teh - Gohad Distt.- Bhind (M.P.) by M/s Teva API India Limited through Shri S. Sunderganesh Authorized Signatory (Sr Director - Technical Operations), Plot No. Q1 to Q4, Malanpur Industrial Area, Malanpur, Distt. - Bhind (M.P.) - 477116 EIA Env.Consultant :Kadam Environmental Consultant Ahmedabad (Gujrat).

- (1) Earlier prior Environmental Clearance was granted by MP-SEIAA (case no. 16/2008) vide letter No. 307/EPCOSEIAA/09, dated 11.02.09 for 17 products with production capacity of 2977.22 MTPA. PP has now applied for Prior Environmental Clearance for change in products mix and introduction of new products totaling 66 products with production capacity of 2951 MTPA as follows :-

- (2) The proposed project is covered under 5 (f) category (B) of the schedule of EIA Notification issued by the Ministry of Environment & Forests vide S.O.1533 (E), dtd. 14.09.2006, hence is required to obtain prior EC.
- (3) There is no interstate boundary within 10 km and no National Park / Sanctuary within the 5 km of the project area hence the general conditions are not attracted.
- (4) The project is located in notified Industrial area Malanpur, District Bhind, hence as per GoI, MoEF OM dtd 10.12.14 Public hearing is exempted.
- (5) The case was discussed in SEAC meetings 98th dtd.23.07.12, 122nd dtd.11.03.13, 125th dtd. 09.04.13, 132nd dtd. 14.05.13, 143rd dtd. 29.10.13, 148th dtd. 25.08.14 and 170th dtd. 28.01.15.
- (6) The case was discussed in SEIAA meetings 138th dtd. 20.06.13, 155th dtd. 08.08.14, 190th dtd. 24.03.15 & 234th dtd 07.09.2015 and it is recorded that (1) The case was discussed in 190th SEIAA meeting dtd 24.03.2015 & it is recorded that " (1) (5) (6) The case was discussed in depth and it is noted that :-
 - (i). The Industry is operating in an old Industrial area which was notified prior to 2006 hence public hearing is exempted as per MoEF & CC, GoI OM dtd 10.12.14.
 - (ii). Member Secretary, MPPCB vide letter no. 1564 dtd 19.03.15 has informed that no legal notice has been issued to the Industry during 2001 to 31.08.2013 under EPA 1986 section 5, Water (Pollution Prevention & Control) Act 1974, Air (Pollution Prevention & Control) Act 1981.



- (iii). PP has submitted acknowledged copy of Compliance report submitted to Regional office, MoEF, Bhopal, however these are not certified. It is decided that since the industry is in operation PP should submit compliance report of the prior EC conditions duly certified by, MoEF & CC, GoI Regional Office, Bhopal.
- (6) PP should submit the above information latest by 30.06.2015. A copy of this letter should be endorsed to Director, MoEF & CC, GoI Regional Office, Bhopal.
- (2) In response to above query, reply submitted by PP (vide letter dtd 01.09.2015 received in SEIAA on 02.09.2015) was examined in depth and it is noted that :-
- (i). PP has submitted a copy of Compliance Report dtd 18.08.2015 prepared by MoEF & CC, RO, Western Region, Bhopal.
- (ii). The Authority decided that :-
- a. PP should be called for presentation.
- (7) PP should submit the budget details for item wise components / activities for environment management. PP should also clarify the points in which MoEF & CC has made a remark for non compliance of the conditions."
- (7) In response to above query, reply submitted by PP (vide letter dtd 01.09.15 received in SEIAA office on 02.09.15) was discussed in depth and it is noted that:-
- (i). PP has submitted compliance report of earlier prior EC certified by MoEF & CC Regional Office, Bhopal (dtd 18.08.2015). As per the report the implementation of environmental safeguards are found satisfactory and some compliance needs improvement which are in progress and has been advised to take care for conditions like environmental management, green belt development, capacity & treatment of ETP and submission of hazop study report. **It is decided that PP should ensure the implementation of the observations of MOEF & CC RO, Bhopal report dtd 18.08.2015.**
- (ii). The total land area of the project is 2,92,500.00 sq. m. (29.25 ha). PP has submitted attested copy of lease deed dtd 01.02.2008 for 30 years (01.02.2008 to 31.01.2038) for plot no. Q1 to Q4 Ghirongi Industrial Area, Village -Malanpur, Distt.- Bhind (M.P.) total plot area 2,92,500.00 sq. m with MPAKVN (Gwalior) Ltd. Gwalior through Managing Director.
- (iii).
- (iv). The total existing waste water generation is 408 KLD and after change in product mix it will be 640 KLD. PP has proposed augmentation of the existing effluent treatment Plant of 250 KLD capacity to 650 KLD capacities with following implementation schedule:-
- (a) 1st Phase – Production of 1150 MT/Annum – waste generated would be 250 KLD which can be treated in existing ETP
- (b) 2nd Phase – Production of 2951 MT/Annum – Effluent Treatment System would be augmented from 250 KLD to 650 KLD by providing additional treatment system of 400 KLD.
- PP has proposed "Zero effluent discharge" from the unit. The total treated waste water is 600 KLD and is proposed to be used in horticulture (470 KLD), Floor washing (30KLD) and Cooling Tower (100 KLD). The ETP sludge is proposed to be filter press and evaporated in Multiple Effect Evaporator (MEE). PP has also submitted copy of renewal of consents upto January 2016 issued by MPPCB; dtd. 08.05.15 under Water Act. **It is decided that PP should submit the details of use of 470 KLD of treated waste water in horticulture and proposed arrangement during rainy season.**

- (vii). PP has submitted copy of renewal of authorization letter (07.05.15) from MPPCB under hazardous waste rules for a period of five years with effect from 09.02.2015. It is decided that:-
- (a) As proposed above, PP should ensure disposal of hazardous waste regularly and there should be no dumping of these materials in the premises/outside.



- (b) PP should ensure handling, disposal and management of hazardous waste as per the related prescribed rules.
- (c) PP should obtain Renewal of authorization regularly from MPPCB for collection storage and disposal of hazardous waste (Management, handling & transboundary Movement) Rules 2008 and its amendments. Membership of the TSDF should be obtained for hazardous waste disposal.
- (d) Hazardous chemicals should be stored in sealed tanks, drums etc. Flame arrestors shall be provided on tanks. To avoid the spillage from processing unit, Industry shall provide fully mechanized filling and packaging operation unit.
- (e) PP should provide RCC layer and double layered HDPE lining for primary and secondary leachate collection.
- (f) PP should obtain NOC /approval from competent authority for health & safety measure, Onsite & Offsite disaster management, and Risk management plan before commencing the operation of the unit.
- (viii). For firefighting measure PP has proposed to provide fire extinguishers, hydrant system and fire. PP has also proposed Fire detection, heat detection, and alarm system to detect fire/heat/smoke in the vulnerable areas of the plant. **It is decided that PP should obtain fire NOC from the competent authority before commencing the operation of the unit.**
- (ix). PP has provided rooftop rainwater harvesting system with 5 nos. of recharging pits. **It is decided that PP should ensure the rain water harvesting and provide pits for ground water recharging.**
- (x). The total power requirement in operation phase shall be 15110 KW and DG set back-up 11nos. (3x1000 KVA each and 8x1250 KVA each). **It is decided that PP should ensure installation of photovoltaic cells (solar energy) for lighting in common areas, LED light fixtures and energy efficient equipments.**
- (xi). PP has proposed green belt area of 102375 sq.m. (35% of the total plot area). It is decided that PP should submit the detailed landscape plan/green belt development plan existing and proposed along with details of number and species of the trees already planted and proposed to be planted.
- (xii). Under CSR activities PP has submitted that donation of Rs. 5 lakh to Delhi Public School, Gwalior and eye checkup camp at Ghirongi has been done. **It is decided that PP should submit activity wise details of CSR plan along with increased budgetary provisions.(as per CSR norms) PP should identify the skill up-gradation training programs required for employing the local people in the proposed unit.**
- (B) **PP should submit above information latest by 30.10.15."**
- (2) In response to above query, reply submitted by PP (vide letter dtd 05.10.15 received in SEIAA office on 06.10.15) was discussed in depth and it is noted that:-
 - (i). Regarding extra treated waste water PP has submitted on the normal days 470 KLD of treated waste water (RO permeate) will be used for horticulture. During rainy season 395 KLD out of 470 KLD will be used for utilities (Cooling Tower, chilled water and boiler). Remaining 75 KLD will be stored in a tank and will be used for horticulture after the rain. **It is decided that :-**
 - a. PP should maintain zero discharge from the Industry as proposed.
 - b. Industrial effluent generation shall be completely evaporated with help of Evaporator so as to achieve zero discharge.
 - c. There shall be no industrial effluent discharge from the unit.

- (ii). PP has submitted plantation details with name of species including number of existing trees (10715) and proposed trees (15000) **It is decided that:-**
- (a) PP should ensure plantation as proposed in 102375 sq.m. (35% of the total plot area) and it should be as per the CPCB guidelines.
 - (b) Plantation in the project area of indigenous local varieties like Neem, Peepal, Kadam, Kachnaar etc.
 - (c) Every effort should be made to protect the existing trees on the plot.
- (iii). Under CSR activities PP has proposed drinking water facilities for Malanpur village, providing ambulance in case of emergency in local area, toilet facility to local villages Ghirongi and Malanpur, Scholarship for village brilliant students Malanpur, providing additional instrument for health centre, constructed additional rooms for existing school at village Ghirongi & Malanpur etc with budgetary provision of Rs. 100 lacs (1.00 crores).
- PP has also proposed plantation outside the factory in the industrial road, training and awareness program for health safety and organizing the health camps at village Malanpur & Ghirongi. **It is decided that:-**
- (a) PP should ensure the implementation of CSR activities to the extent of Rs. 100 lacs per annum on regular basis in consultation with the Gram Panchayat of the respective villages.

The Authority decided to accept the recommendations of 125th SEAC meeting dtd. 09.04.2013 with 04 special conditions and amendment conditions vide SEAC letter dtd 12.06.2013 including SEAC meetings 132nd dtd. 14.05.13, 143rd dtd. 29.10.13, 148th dtd. 25.08.14 and 170th dtd. 28.01.15 and accord Environmental Clearance to proposed Bulk Drugs - Change in Product mix and introduction of new products; Intermediates and API for total 66 products with production capacity of 2951 MTPA at Plot no. Q-1 to Q-4 Ghirongi Industrial Area, Village Malanpur, Teh - Gohad Distt.- Bhind (M.P.) by M/s Teva API India Limited through Shri S. Sunderganesh Authorized Signatory (Sr. Director - Technical Operations), Plot No. Q1 to Q4, Malanpur Industrial Area, Malanpur, Distt. - Bhind (M.P.) subject to **all specific conditions imposed by SEIAA in its meetings.**

Bhopal (M.P.) Total Land Area 97518.90 Sq.Mt., Plotted development with permissible Built Up Area - 81928.47 sq m. say 82000.00 sqmt.; Proposed Built up Area - 19680 Sqmt by M/s Koshalya Devi Builders and Developers through partner Shri Balwant Singh, 51, Premier House, Zone - II, M.P. Nagar, Bhopal (M.P.) 462011 (Developers), Owner of land: Shri Narendra Singh And Shri Santosh Singh.

Notification. Committee decided to return the case to SEIAA for taking necessary credible action and if need be, issue of directions for immediate suspension of construction at existing level, in light of the MoEF O.M. no J-110131/41/2006 – IA- II (I) dated 12/12/2012 and dated 27/06/2013 ."

- (ii). The Authority is of the view that it is undisputed that violation of EIA Notification 2006 has taken place. **It is decided that :-**

A. As per MoEF, GoI, OM No. J-110131/41/2006-IA-II (I) dtd 12.12.2012 and OM dtd 27.06.2013 PP should submit :-

- a. The date of starting the construction, details as to why the construction activities have been undertaken. How much construction has already been done? Whether the construction activities are still continuing? PP is directed to stop the construction activities with immediate effect and should not undertake any kind of construction/development until prior EC under EIA Notification 2006 is accorded. **PP should submit the information latest by 30.10.14.**
- b. The Proponent should submit the matter relating to the violation to the Board of Directors of its Company or to the Managing Committee / CEO of the Society, Trust, partnership / individually owned concern for consideration of its environment related policy / plan of action as also a **written commitment in the form of a formal resolution to be submitted within 60 days** to MP-SEIAA to ensure that violations will not be repeated. **It is decided that in the meantime, the project will be delisted.** In the eventuality of not having any response from the project proponent within the prescribed limit of 60 days, it will be presumed that it is no longer interested in pursuing the project **further and the project file will be closed**, where after the procedure will have to be initiated de novo by project proponent.


- (iii). A letter should be sent to Principal Secretary, GoMP UD & E Department, giving the details of violation to take action as per office memorandum of MoEF, GoI J-110131/41/2006 IA II (I)dt. 27.06.13 & 12.12.12 (Para 5 (ii)) "to initiate credible action on the violation by invoking powers under section 19 of the Environment (Protection) Act, 1986 for taking necessary legal action under section 15 of the Act for the period for which the violation has taken place and evidence provided to MoEF of the credible action taken." The details of legal action taken by the Principal Secretary, GoMP UD & E Department should be made available to the Authority by 15.12.14. A copy of letter be endorsed to PP.
- (iv). The details of project proponent, a copy of commitment and Resolution passed in the meeting of the Board of Directors of M/s Koshalya Devi Builders and Developers through partner Shri Balwant Singh should be put on the website of MPSEIAA for information of all stake holders."


- (2) In response to above query, reply submitted by PP (vide letter dtd 10.11.14 received in SEIAA office on 11.11.2014) was examined in depth and it is noted that :-


- (i) PP has submitted that after obtaining the permission from Municipal Corporation dtd 02.09.2009, the construction was started. Presently constructed area of unfinished houses is 7600 sqmt
- (ii) PP has submitted that a written commitment in the form of resolution passed by Board of Directors shall be submitted and that the violation shall not be repeated in future. However, till date written resolution has not been submitted by PP in SEIAA office.
- (iii) As per the decision in 159th SEIAA meeting letter (no. 1277 dtd 13.10.14) was sent to PS, UD & E Deptt. with CC to MPPCB to initiate credible legal action on the violation by PP.

- (3) **The Authority decided that :-**

- a. **A letter should be sent to MS, MPPCB to submit the details regarding legal action against PP. A copy of letter should be endorsed to PP.**

(2) In response to above query reply from MPPCB (vide letter no. 4915 dtd 01.09.15 received in SEIAA on 03.09.15) regarding legal action was examined and it is noted that:-

(i). In view of Hon'ble NGT order dated 07.07.2015 and as per the policy decision in the 219th SEIAA meeting dtd. 16.07.2015, regarding violation cases needing credible action, the proceedings of the above project has been kept in abeyance. PP should be informed accordingly.

(2) In response to above query, reply submitted by PP (vide letter dtd 14.05.15 received in SEIAA office on 14.05.15) was examined in depth and it is noted that :-

- (i). PP has submitted company registration documents and MoU between M/s Raj Homes Pvt. Ltd. and Vishnupuri Grih Nirman Sahkari Samiti. It is noted that the MOU is between Sahakari Samiti and Private Limited (Company). **It is decided that PP should submit the legal provisions under which MOU has been signed between the two. Also, Registrar Cooperative Societies M.P. may be asked to verify whether Cooperative Housing Society can enter into a joint venture with a Pvt.Ltd. Company.**
- (ii). PP has admitted typological error in Form-1 and has submitted that the total area for the scheme is 3.88 ha approved by T & CP and includes five plots. Out of these five plots EC is required only for three plots namely Raj Classic apartment, Business centre and Multiunit block.
- (iii). PP has also submitted details of block wise plot area, built-up area statement.
