



After detailed discussion and query response of 254<sup>th</sup> SEIAA meeting dtd. 30.10.2015 & recommendation of 229<sup>th</sup> SEAC meeting dtd. 01.10.2015, the mining plan submitted by PP was examined and it was found on Page 19 of Chapter 4 (4.0-Mining) that the production capacity for the first 5 years has been mentioned as 34721 T (about 6000 ton/year) and from Sixth year it is 5000 ton/year, where as in SEAC recommendation it is 10000 ton/year. We should get clear recommendation from SEAC as to how the calculation of 10000 ton/year has been arrived at.
