- (1) The case was discussed in SEAC meetings 220th dtd. 26.08.15 and is recommended for grant of prior EC subject to 06 special conditions.
- (2) The case was considered in SEIAA meetings 241st dtd. 22.09.2015 & 244th dtd. 29.09.2015. **As per 244th meeting PP should submit following information latest by 15.11.2015 :-**
 - (i) NOC from CGWA / Municipal Corporation, Indore specifying the quantity of fresh water required for the project.
 - (ii) NOC from Nagar Nigam Indore for disposal of extra treated waste water.
 - (iii) NOC from Nagar Nigam Indore Municipal Corporation for disposal of solid waste.
 - (iv) Detailed break up of built up area (stilt, basement & open) as per MPBVR 2012 for car parking calculation.
 - (v) Landscape plan showing the area of plantation with number of trees to be planted and running length around the periphery.
 - (vi) Specific CSR plan in consultation with district administration and Gram Panchayat of the nearby villages including budget for the same.
- (3) In response to above query, reply submitted by PP (vide letter dtd 19.10.2015 & 27.11.2015 received in SEIAA office on 21.10.2015 & 28.11.2015) was discussed in depth and it is noted that:-
 - (i) PP has submitted Collector, Indore permission (dtd. 16.10.2015) regarding withdrawal of ground water.
 - (ii) PP has submitted lease deed (dtd. 23.05.12). In which it is mentioned that ".....33. (iv). Lessee shall make its own sewerage treatment arrangement inside its premises and discharge the non-toxic effluent to the common drainage system to be provided by the appropriate local authority. The toxic effluent, if any, will be treated by Lessee at the source before discharge into sewerage system." **It is decided that :-**
 - (a) **PP should ensure implementation of drainage system / disposal of extra treated waste water as per lease deed dtd 23.05.2012.**
 - (iii) PP has submitted Gram Panchayat, Badiyakeema, Indore NOC (dtd.28.09.2015) regarding disposal of municipal solid waste. **It is decided that PP should ensure for proper collection of MSW at an appropriate place within the campus and dispose it off to the approved MSW disposal site of Nagar Nigam.**

- (i) PP has submitted the latest Khasra Panchsala 2014-2015 and it is in order.
 - (ii) PP has submitted Bhopal Municipal Corporation letter dtd 09.10.2015 regarding water supply. **It is decided that entire demand of water (400 KLD) should be met through Municipal Corporation, Bhopal there should be no extraction of ground water.**
 - (iii) PP has committed for the road construction worth of Rs. 1.25 crores for the nearby rural areas. PP has further committed to donate Rs. 25 lacks over three years for providing "Jaipur Foot" to physically challenged persons. **It is decided that the PP should consult the District administration for identification and implementation of these roads and organize camps for physically handicapped persons in the District. A copy should be forwarded to the Collector, Bhopal District and Commissioner, Municipal Corporation, Bhopal.**



After detailed discussions, perusal of the recommendations of **183rd SEAC meeting dtd 27.04.2015** and query response in 232nd SEIAA meeting dtd. 03.09.2015, PP has submitted a letter dtd. 16.11.2015 in which they have calculated the quantities to backfilled and the backfilling configuration. They have also given an undertaking that before commencement of the mining operation they would first create a buffer zone of 15 m. along with the adjoining lessee M/s S.N.S. Minerals Ltd.

it was decided to grant Prior Environmental Clearance subject to the above specific conditions and the conditions imposed in 206th SEIAA meeting dtd. 08.06.2015 along with the specific conditions imposed by SEAC.

Hence, Prior Environmental Clearance is granted for **Limestone mine** in an area of 16.288 ha for expansion in production capacity (4,00,000 MTPA) at khasra nos. 39/2, 39/3, 39/4, 39/5 at Village Bhatura, Tehsil Maihar, District Satna (M.P) **for the lease period** to Shri Jitendra Kumar Kushwaha, Adarsh Nagar Colony, P.O. & District Katni (MP) 483501, e-mail jkkushwaha2012@gmail.com, Mobile - 09425153719.
