1. **Case No. 70/2008**, Prior Environmental Clearance for **Limestone Mine** (Opencast Manual/Semi-Mechanised) in an area 10.741 ha for expansion in production capacity from 8089 TPA to 60,000 TPA, Khasra No. (Old) 649, 650, 651, 652, 653, 648, 646, 647, 656, 644, 657, 658/1, 660/1, 660/2, 659, 661 & 621 (Kahsra No. (New): 78 P, 79, 80 P, 83, 84, 85 P, 86 P, 87, 88 P, 89 P, 90,91, 92, 93, 94,95,96,97,98,99,100,122P,126) at Village - Bistara, Tehsil - Murwara, Distt. - Katni, M. P. by M/s Ismail & Sons, Mission Chowk, Katni (MP) - 483501.

- (1) SEAC in its 173rd meeting dtd. 23.02.2015 recommended the case for grant of prior EC with 05 special conditions.
- (2) The case was discussed in 194th SEIAA meeting dtd 23.02.2015 and it was recorded that

- i. "After detailed discussions and perusal of the recommendations of 173rd SEAC meeting dtd. 23.02.2015, it was noted that PP has not submitted the information about the distance of forest boundary from the mining site. It was also noted that the existing status of lease deed and litigation related with mining lease is not clear.
- ii. In this context it was decided to ask from the DFO, Katni to provide the distance of forest boundary from the mining site and also ask from the Collector, Katni to provide the status

of lease deed & litigation related with mining lease of PP. The information should be made available at the earliest. Copy of the letter should be endorsed to PP also."

- (3) Thereafter, the case was discussed in 262nd SEIAA meeting dtd 27.11.2015 and it was recorded that

"After detail discussion and query response of 194th SEIAA meeting dtd 23.02.2015, PP may be invited for presentation."

- (4) PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in details.
- (5) It was noted that the criteria of inter-state boundary is not applicable as mining site falls in Murwara Tehsil of District - Katni, National Park/Sanctuary is not located within 10 km radius. Hence, the **General Condition is not attracted**.
- (6) Mining plan is approved by the IBM (vide letter no. 5095 dtd. 25.09.2014).
- (7) The proposed plantation program was examined and it was found that **3250 trees** shall be planted in an area **3.629 ha** during the lease period.
- (8) It was noted that the water requirement is 12 KLD (08 KLD Dust Suppression+ 02 KLD Green Belt + 02 KLD Domestic Purpose), which shall be purchased from the nearby villages.
- (9) It was noted that the Public Hearing was held on 06.09.2015 at Mine Parisar, Village - Bistara, Tehsil - Murwara, Distt. - Katni (M.P.) under the Chairmanship of ADM, Katni. The issues raised during public hearing were of general nature and nothing adverse was found regarding degradation of the environment.
- (10) After detailed discussions and perusal of recommendations of 173rd SEAC meeting dtd. 23.02.2015, presentation made by the PP in SEIAA & SEAC, it was decided that:
- I. The PP shall demarcate a minimum buffer zone of 100 m on either side of the canal passing through the existing ML area in presence of Executive Engineer, Water Resource Department, Mining Officer, Katni & Revenue Officer, Katni.
 - II. The PP shall demarcate a minimum buffer zone of 250 m as "No Mining Zone" from the forest boundary in consultation with Forest, Revenue & Mining Departments and develop a green belt in the 100 m of the buffer zone inside the ML area.
 - III. Before commencing any mining activity fencing of the entire area shall be carried out.
 - IV. Pakka road shall be developed from ML area to the adjoining Highway and maintained by PP, so as to minimize the emission of particulate matters and reduce the air pollution in the surrounding area.
 - V. The PP shall carry out plantation at Village – Bistara in consultation with Gram Panchayat.
 - VI. The commitments made by the PP in the Hydrological study report, CSR activities and afforestation plan shall be implemented in content and spirit.

- VII. The entire plantation shall be carried out in the first year itself.
- VIII. Under CSR activity in addition to the proposed activities following activities should be added.
- a) Skill upgradation programme for the villagers of nearby villages.
 - b) Sanitation activities including construction of individual toilets in consultation with village Panchayat.
 - c) Installation of rainwater harvesting structure.
- IX. The appropriate budget provision shall be made for the CSR activities.

In the above context, PP shall submit the record of air & water consent from MPPCB, any other notices issued and legal action taken by the Board and also submit the copy of the Hydrological study report by 11.12.2015.

2. **Case No. 738/2012**, Prior Environmental Clearance for **Marble Mine** in an area 3.91 ha (Opencast Manual /Semi-Mechanised) for expansion in production capacity from 600 Cubic meters per year to 7,200 Cubic meters per year at Khasra No. 195, at Village – Chhapra, Tehsil- Bahoriband, Distt. – Katni (M.P.) by M/s Tejasvini Mines, Sh. K.P. Pathak, Attorney, 16, Sarafa Bazar, Jabalpur, Distt. – Jabalpur (M.P.) - 482001

- (1) SEAC in its 173rd meeting dtd. 23.02.2015 recommended the case for grant of prior EC with 05 special conditions.
- (2) The case was discussed in 194th SEIAA meeting dtd 23.02.2015 and it was recorded that


- i. "After detailed discussions and perusal of the recommendations of 173rd SEAC meeting dtd. 23.02.2015, it was noted through google map view that the total area of mining site could not be demarcated as PP has provided only two coordinates. In order to mark the total area all four coordinates are required.
- ii. It was also noted through google map view (as per coordinates submitted by PP) that the earthen dam and NH-7 is visible in the vicinity of the mining site.

In the above context it was decided to ask from the Mining Officer to provide all four coordinates of the mining site and exact distance of earthen dam and NH-7 from mining site. Copy of the letter should be endorsed to PP also.

It was also decided to ask from PP to obtain NOC from the Executive Engineer, Water Resource Department regarding impact of mining activities on earthen dam and the consent of National Highway Authority regarding the mining activities."

- (3) PP has submitted the following documents in response of the above query:
 - i. Coordinates of the ML area provided by the Office of the Collector, (Mining Division), Katni.
 - ii. NOC from the Executive Engineer, Water Resource Department regarding impact of mining activities on earthen dam.
 - iii. Consent of National Highway Authority regarding the mining activities.
- (4) PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in details.
- (5) It was noted that the criteria of inter-state boundary is not applicable as mining site falls in Bahoriband Tehsil of District - Katni, National Park/Sanctuary

- (6) Mining plan is approved by the IBM (vide letter no. 22596 dtd. 09.12.2014).
- (7) The proposed plantation program was examined and it was found that **1600 trees** shall be planted in an area **1.25 ha** during the lease period.
- (8) It was noted that the water requirement is 12 KLD (03 KLD - Dust Supression + 02 KLD - Green Belt + 02 KLD - Drinking+ 05 KLD - Wire Saw), which shall be purchased from the nearby villages.
- (9) It was noted that the Public Hearing was held on 15.10.14 at Mine Parisar, Village - Chapra, Tehsil- Bahoriband, Distt. – Katni (M.P.) under the Chairmanship of ADM, Katni. The issues raised during public hearing were of general nature and nothing adverse was found regarding degradation of the environment.
- (10) After detailed discussions and perusal of recommendations of 173rd SEAC meeting dtd. 23.02.2015, presentation made by the PP in SEIAA & SEAC, it **was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**
 - I. Before commencing any mining activity fencing of the entire area shall be carried out.
 - II. The height of the dump shall not exceed 6.0 m.
 - III. Under CSR activity in addition to the proposed activities following activities should be added.
 - a) Skill upgradation programme for the villagers of nearby villages.
 - b) Sanitation activities including construction of toilets with proper arrangement of water (i.e, Water tanks & Pumps) in the Schools of nearby villages, especially for the girl students in consultation with village Panchayat.
 - c) Installation of rainwater harvesting structure.
 - IV. The appropriate budget provision shall be made for the CSR activities.


