



"The EMS and other submissions made by the PP were found to be satisfactory but as per the co-ordinates submitted by the PP, the Google image indicated that mining lease area falls within the 5 K. M of interstate boundary. In such situation the committee recommends PP to obtain reconfirmation of distance from Mining lease Area to the Interstate Boundary from the Revenue Authority"

"PP has submitted response to the above queries and the same was placed before the committee for scrutiny and necessary comments. Scrutiny of the certificate submitted by the PP with reference to the above query reveals that certificate given by the Tehsildar dated 14/10/15 does not gives the exact distance from the interstate boundary. However, as per the co-ordinates given in mine plan, show that area falls within 5.00 kms of inter-state boundary. Hence it is a Cat-'A' case. The committee decided to send this case to SEIAA for onward necessary action."
