

- (ii) The depth of the pit shall not exceed 3m. or water level whichever is less.

After detailed discussion on the recommendations of 243rd SEAC meeting dtd. 07.12.2015, the Mining Plan has indicated the production capacity to be 40,000 cum/year. However, SEAC has recommended production capacity of 60,000 cum/year **as per Mining Plan**. The case may be returned to SEAC for giving reasons for enhanced capacity.

After detailed discussion on the recommendations of 243rd SEAC meeting dtd. 07.12.2015, it was reported that there are 04 mines with an area of 74.199 ha. within 1000m. from the said mine. According to SEIAA, OM of MoEF & CC does not differentiate between river sand mining and sand accumulated in agriculture field. Therefore, the case may be sent to SEAC for re-appraisal.

After detailed discussion on the recommendations of 243rd SEAC meeting dtd. 07.12.2015, It was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC. During the site visit of SEAC Members, there were reports of illegal mining close to the said area. The copy of complaint and the inspection note may be sent to the Collector, Satna for immediate action.


- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall not exceed 3m. at the end of lease period and not beyond that.

After detailed discussion on the recommendations of 243rd SEAC meeting dtd. 07.12.2015, it was reported that :-

1. Production of Stone not exceeding 18,000 cum/year as per mine plan.
2. In view of the fact that the proximal and distal end of the site is bounded by village road and seasonal drain (Nala), respectively, it is recommended to have at least 20 m setback from village metal road (as recommended by SEAC in case no. 3612) and a garland drain to protect seasonal drain at the back side of the ML area.

3. The area for set back from village road and garland drain should be in addition to 7.5 m area to be left all around the mine site
4. A barrier wall of 3 m height should also be provided towards road side as safety / protection measure.
5. After leaving 7.5m mandatory safe zone all around plus 20 m setback from road plus garland drain, the effective area for mining will also be reduced. Hence, the proposed production capacity (18,000 cum/year) should be reduced by about 20% (15,000 cum/year) for environmentally safe and sustainable mining.
6. Though crusher is not proposed in the lease area, but it should not be allowed in future too.
7. There should be controlled blasting avoiding deep-hole blasting.

From the above recommendation, the final production capacity is not clear. The case may be sent to SEAC for clarification.
