1. **Case No. 1938/2014** Prior Environment Clearance for approval of proposed project "Park Nav Uday Hospital & Medical College" at Village-Maharajpura, Tehsil & District- Gwalior (MP) Plot area: 1,00,320.00 sq.m. Built - up area: 1,01,880.0 sq.m. by Mr. Vijay Bhateja, Vice President, Nav Uday Educational & Charitable Society, 29-A, PKT-1, Sector-7, Dwarka, New Delhi-110075, E-mail – vijaybhateja@gmail.com, mob no. 09971089792, Environment Consultant Enkay Enviro Services Pvt. Ltd., Jaipur
- (1) The proposed project is for construction of Hospital & Medical College with 900 beds hospital at Village-Maharajpura, Tehsil & District- Gwalior (MP). The project includes construction of Hostel Rooms 292 nos., Nurses Hostel Rooms: 6 nos., Staff Quarters 90 Flats, Auditorium Capacity 1000.
  - (2) The total built up area proposed by PP is 1,01,880.0 sq.m. The project comes under 8 (a) category (B) of schedule of EIA Notification, 2006 because total construction is between 20,000 sqmt. & 1,50,000 sq mt. and plot area is less than 50 ha.
  - (3) The case was discussed in SEAC meetings 161<sup>st</sup> dtd. 22.12.14, 183<sup>rd</sup> dtd. 27.04.15, 208<sup>th</sup> 23.07.2015, & 244<sup>th</sup> dtd. 08.12.15 and is recommended for grant of prior EC subject to 14 special conditions.
  - (4) The case was considered in 273<sup>rd</sup> SEIAA meeting dtd 18.12.2015, and called for presentation.
  - (5) **After deliberation PP was asked to submit the following information:-**
    - (i) Latest Khasra Panchsala of the project and approved layout from the T & CP, Gwalior.
    - (ii) The water balance chart incorporating water generation, design of STP & ETP with capacity, treated waste water, recycle waste & extra treated waste water of the project.
    - (iii) NOC from CGWA regarding withdrawal of ground water.
    - (iv) Layout plan showing sewer line and disposal point of extra treated waste water in Municipal sewer line.
    - (v) Clear NOC from Indore Municipal Corporation for disposal of extra treated waste water in Municipal sewer line.
    - (vi) NOC from Municipal Corporation, Gwalior for disposal of MSW.
    - (vii) Mode of disposal of Bio-Medical Waste and commitment from incinerators regarding disposal of BMW/ Common Bio-Medical disposal and treatment facility.
    - (viii) Width of approach road of the project site.
    - (ix) The number of recharge pits to be constructed along with their location on the layout map.
    - (x) Details of solar energy units / plan location along with energy conservation measures.
    - (xi) Detailed of car parking calculation as per MPBVR 2012.


- (xii) Landscape plan including trees in two rows all along the periphery of the project area, avenue plantation on the road sides, open spaces and parks along with number of trees and species to be planted and budget for the same.
- (xiii) Detailed CSR Plan in consultation with District Administration.
- (xiv) Undertaking regarding demolish the existing structure and building permission for the same.
- (xv) Undertaking regarding no use of nuclear element.
- (xvi) NOC from Air force / Airport Authority.

(6) After submission of above information PP may call for revised presentation.

2. **Case No. 2492/2015** Prior Environment Clearance for expansion of Jaideep Ispat & Alloys Pvt. Ltd.-unit-II) at Plot No. 808 E, Sector -3 Village Pithampur, Tehsil & District Dhar (M.P). Land area- 36000 sq.m. Existing Capacity - TMT Bar (By Rolling Mill) 1,00,000 TPA Ingots/Billets (By Induction Furnace) - 75,000 TPA Proposed capacity - TMT Bar (By Rolling Mill)-2,50,000 TPA, Ingots/Billets (By Induction Furnace)- 2,25,000 TPA by Shri Pawan Singhania Jaideep Ispat & Alloys (P) Ltd. (-Unit-II) 103, Laxmi Tower first floor, 576 MG Road Indore (M.P) 452003, email: info@moirasariya.com Mob: 08889114200 Env. Consultant: CES Bhopal


- (1) The case was discussed in 191<sup>st</sup> SEAC dtd.07.05.15 & 244<sup>th</sup> dtd 08.12.15 and recommended for grant of prior EC subject to 06 special conditions.
- (2) The case was considered in 273<sup>rd</sup> SEIAA meeting dtd 18.12.2015, and called for presentation.
- (3) After deliberations by PP the case was discussed in depth & it is noted that:
  - (i) Earlier prior Environmental Clearance was granted by MP-SEIAA (case no. 473/2009) vide letter No. 348/EPCOSEIAA/10, dated 30.08.10 with production capacity of TMT Bar (By Rolling Mill) 1,00,000 TPA Ingots/Billets (By Induction Furnace)-75,000 TPA. PP has now applied for Prior Environmental Clearance for enhancement in production capacity of Ingots/ Billets – 75000TPA to 2, 25,000 TPA and TMT Bars 1, 00, 000, TPA to 2, 50,000 TPA. PP has submitted compliance report of earlier prior EC certified by MoEF &CC Regional Office, Bhopal (dtd. 19.11.2015). As per the report the implementation of environmental safeguards are found satisfactory and some compliance are in progress and has been advised to take care for conditions like environmental management, green belt development, control of emission / dust suppression and socio economic development of nearby area.
  - (ii) The proposed production capacity is more than 30,000 (using induction arc furnace) hence project is covered under 3 (a) category of the MoEF, GoI EIA Notification 2006 and its amendments.
  - (iii) There is no inter-state boundary within 05 km and no Wildlife Sanctuaries, National Parks, and Tiger Reserves within 05 km of the boundary hence, general conditions are not attracted.
  - (iv) The ToR was issued to PP by SEAC (dtd 15.06.2015) and EIA was submitted by PP (dtd 04.11.2015).

- (v) PP has submitted copy of registered lease deed dated 23.03.2009 between MD, Industrial Infrastructure Development Corporation (Indore) and Jaideep Ispat & Alloys Pvt. Ltd.-unit-II) an area of 36000 sq.m. for the period of 30 years (w.e.f. 23.03.2009 to 22.03.2039).
- (vi) The project is located in notified Industrial area Pithampur, District Dhar (M.P), hence as per GoI, MoEF OM dtd 10.12.14 Public hearing is exempted.
- (vii) The source of water supply for the project is MPAKVN (agreement dtd. 11.01.2010). The total water requirement for the existing unit is 315 KLD (domestic 15.0 KLD, Cooling water 300.0 KLD). After expansion the total water requirement will be 470 KLD (domestic 30.0 KLD, Cooling Rolling Mill/Softener 440 KLD).
- (viii) The water shall be required only for cooling and domestic purpose hence no industrial effluent shall be discharged. Thus the production process is zero discharge. The total waste water generation for the existing unit is 12.0 KLD (domestic 10.0 KLD, Cooling water 2.0 KLD). After expansion the total waste water generation will be 25.0 KLD (domestic 20.0 KLD, Cooling water – 5.0 KLD). PP has proposed STP for treatment of domestic waste. The wastewater from DM/Softener shall be collected in pond and used for gardening / dust suppression and slag cooling.
- (ix) The air emission expected from induction furnace & DG set (2x500 KVA). For control of air emission, PP has proposed canopy hood with swivel arrangement, cyclone separator, bag filter, ID fan, scrubber, blower and stacks(no.2) of 15m & 35 m height.
- (x) The solid waste generated from the process namely plant dust, mill scale, papers etc (5.0 TPA) shall be sold to local vendor. The Iron Slag (18000 TPA) generated from process will be reused in furnace and in civil work & bricks manufacturing. The spent resin from softener plant and spent oil from DG sets will be sold to MPPCB authorized vendors/agencies.
- (xi) PP has proposed roof top rain water harvesting (11,000 sq.m.) for recharging of ground water.
- (xii) PP has included disaster management plan, fire fighting provisions in the EIA report.
- (xiii) PP has submitted at present around 6000 sq.m. area has been developed as green belt by planting 2000 odd nos. of species. After expansion PP has proposed to plant approx 2000 nos of trees within the premises along with periphery of factory premises. The company will cover 12,000 sq. m. of land with green belt which is more than 33% area of total land.
- (xiv) Under CSR activities PP has proposed Infrastructure development through MPAKVN, health check-up camps, campaign against plastic in Indore, Tobacco etc. Fencing nearby Graveyard, Training to nearby tribal youth to provide them employment in the plan and construction of 4 nos. of toilet in village Bagdoom with budgetary provision of Rs. 9,70,000.



It is decided to accept the recommendations of 244<sup>th</sup> SEAC meeting dtd 08.12.2015 **with 06 special conditions and accord Prior Environmental Clearance** for expansion of Jaideep Ispat & Alloys Pvt. Ltd.-unit-II) at Plot No. 808 E, Sector -3 Village Pithampur, Tehsil & District Dhar (M.P). Land area- 36000 sq.m. Existing Capacity - TMT Bar (By Rolling Mill) 1,00,000 TPA Ingots/Billets (By Induction Furnace) - 75,000 TPA Proposed capacity - TMT Bar (By Rolling Mill)- 2,50,000 TPA, Ingots/Billets (By Induction Furnace)- 2,25,000 TPA by Shri Pawan Singhania Jaideep Ispat & Alloys (P) Ltd. (Unit-II) 103, Laxmi Tower first floor, 576 MG Road Indore (M.P) 452003 **subject to following specific conditions imposed by SEIAA :-**

- (1) PP should ensure the implementation of the observations of MOEF & CC, Western Region Office, Bhopal report dtd 19.11.2015.
- (2) The entire demand of fresh water should be met through AKVN, supply and there should be no extraction of ground water.
- (3) PP should ensure zero waste water discharge from the process.
- (4) PP should ensure air pollution control measure as proposed in EMP and should conduct regular monitoring of stack emissions and ambient air as per MPPCB / CPCB norms. For regular monitoring of air emission PP should installed ambient air monitoring stations.
- (5) PP should ensure the disposal of hazardous waste through authorized agencies and obtained consents from competent Authorities.
- (6) PP should ensure sludge used as manure after vermi-composting.
- (7) PP should ensure roof top rain water harvesting for ground water recharge.
- (8) PP should obtain NOC for fire and approval for onsite offsite emergency plan, health and safety plan from the Competent Authorities.
- (9) Under green area development PP should ensure :-
  - (a) Plant 2000 number of trees within and outside of the plant area as proposed.
  - (b) Plantation in two rows all along the periphery of the project area, and along the roads, subject to minimum of 33% of the total area of the project.
  - (c) Plantation of the trees of indigenous local varieties like Neem, Peepal, Kadam, Karnj, Kachnaar etc.
  - (d) Plantation should be completed within one year.
  - (e) Every effort should be made to protect the existing trees on the plot.
- (10) PP should ensure implementation of CSR activity in consultation with Collector, Dhar and ensure to submit one copy of the proposal in SEIAA.
- (11) PP has proposed 236 number of man power required after the expansion of the project. PP should ensure preference should be given to tribal people to fulfill the man power requirement.
- (12) PP should ensure all the raw material including scrap, coal, slag, sludge and oily waste shall be stored separately in designated place.






