2. **Case No. 2705/2015:** Prior Environmental Clearance for **Sand Quarry** (Opencast Manual Method) in an area 5.00 ha. for production capacity 147000 cum/year at Khasra No. 634 at Village-Saikheda, Teh-Gadarwara, Dist- Narsinghpur (MP) by M/s S.R. Traders, Shri Atul Goldal S/o Shri Kuldeep Goldal, 12, Metro Plaza, Bittal Market, Bhopal (M.P.) - 462016

After detailed discussion and recommendations of 249th SEAC meeting dtd. 14.12.2015, has reported :-

"The case was discussed earlier in the 210th SEAC meeting dated 25/07/2015 wherein scrutiny of the documents revealed that the Tehsildar in his report has commented on expected land degradation from the mining activities. However no clarification has been provided on this issue. Also it was reported by the PP that the evacuation road from the Mine site connecting to the main road is under dispute with the local residents. Thus, PP was asked to get clear comments from the revenue department on the above issues and submit the same within a month's time.

Tehsildar vide letter no. 2562 dated 09/11/2015 has submitted response to the above query which was placed before the committee. Committee after deliberations decided that Environmental Clearance at this site should not be considered based on the points raised by the Tehsildar which are of Environmental Sensitivity. Hence the case is not recommended for grant of EC."

SEIAA has observed that the point raised by Tehsildar in its report are of sensitive nature and therefore, Collector Narsinghpur & MP State Mining Corporation may be asked to elaborate and clarify the issues of Tehsildar report.

The committee gone through the contents of representation of PP and decided to send the case file back to SEIAA for withdrawal of the project as requested by the PP."



Regional Head should specifically clarify the depth of the mined out area and the pit depth to be excavated. Copy to PP.

".....The case was presented by the PP and their consultant and it was observed that there is an elevation of 10 meter and site is a hillock. It was observed that since the shape of mine is awkward thus for safe and sustainable mining quantity may be restricted to 30,000 cum/year"

SEAC in its recommendation has indicated the production capacity to be 40000 cum/year whereas in the above content it has restricted upto 30000cum/year. It was decided to return the case to SEAC.

SEIAA has decided to return the case to SEAC for appraisal as per the directives of Hon'ble NGT.

PP has represented in his letter dtd. 08.08.2015 that the pit depth should have been 6m. The case was reverted to SEAC and they have reported as :-

"SEIAA vide their letter no. 7564 dated 10/11/2015 has sent back the case for appraisal based on the points submitted by the PP. On examination of the file it was observed that it was case of "Stone" mining while during recommendation it is mentioned as "Sand".


Thus committee decided that typographical error stands corrected and recommendations may be read as follows:- "Recommended for grant of prior EC subject to the following special condition in addition to the standard conditions - at annexure 'A':

1. Production of Stone as per mine plan with quantity not exceeding 13,000 cum/year."

It is now decided to issue Revised EC with the same production capacity of 13000 cum/year with a maximum pit depth of 6m.

They should also measure the distances of the two roads near the proposed mining site. He should submit the Panchnama and the location map showing the above distances. Copy to PP.
