7. **Case No. 2196/2014** - Prior Environmental Clearance for Sandstone (Farshy Patter) Mine in an area of 3.950 ha. for production capacity 30,000 cum/year at Khasra Nos. 210, 212, 214 at Village-Sunnd, Tehsil-Raisen, Dist-Raisen (MP) by Shri Bhupendra Singh Rao, GM, M/s Mine Corp India Pvt. After detailed discussion on the recommendations of 168th SEAC meeting dtd 11.01.2015 it was reported that :-

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. It was reported by the concerned Mining Officer of mining department vide letter no. 865 dated 27/09/2014, that 09 mines are operating / proposed within 500 meter radius around the said mine the total lease area being 22.104 Ha. PP has reported that the pit formed after mining shall be developed into a water body.

This case was discussed in 202nd SEIAA meeting dtd 25.05.2015, 211th SEIAA meeting dtd 23.06.2015 and 225th SEIAA meeting dtd 11.08.2015. Director Geology and Mining has reported that in 500 m periphery there are total 9 mines with a lease area 24.604 ha including the existing proposed mine. The case may be returned to SEAC for reappraisal on the ground that there is a difference of the information provided earlier by the Mining Officer, Raisen and the latest information submitted by Director, Geology and Mining.

There is no provision of extending the EC on the grounds submitted by the PP and therefore he is directed to submit fresh EC application after extension of lease period by the granting Authority.

After detailed discussion and recommendations of 255th SEAC meeting dtd. 02.01.2016, it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC.

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall not exceed 6m. at the end of lease period and not beyond that.
- (iii) Before commencing the mining activity, site demarcation should be done leaving 100m. from the Pakka Road as a "no mining zone" and 100 m from the bank of the river. 




