A. POLICY DECISIONS IN RESPONSE TO THE DIRECTIVES OF HON'BLE NGT IN THEIR ORDER DATED 06.01.2016

Hon'ble NGT in their order in Appeal No. 53/2015 dtd. 06.01.2016 has directed SEIAA as follows :-

"In the reply that has been submitted on behalf of the MP SEIAA it has been submitted that based upon the Office Memorandum dated 24.12.2013 issued by the MoEF, the SEIAA has considered the Applications taking into account the annual replenishment of the sand in the leased areas also. It has however been submitted that independently of what has been provided by way of information by the Project Proponent which in turn has been obtained from the Director Geology and Mines, and no independent appraisal has been carried out by SEIAA itself. We feel that under the scheme of appraisal, of SEAC needs to carry out the appraisal of all available material and data and not merely what has been provided by the Director Geology and Mines. Since this has not been done so far, we would direct that in each of these cases this needs to be reviewed by SEAC. At the same time, fresh Applications which are pending and are under consideration shall be dealt with in accordance with the above.


It has also come to light that under the specific conditions of the EC, particularly condition No. 2 which reads as follows: "The depth of the pit shall not exceed 3 meters or water level whichever is less."


In Himmat Singh's case, the Principal Bench NGT, in paragraph 13 it has been categorically stated in point no. 2 as follows: "The surface water level is referred to in office memorandum dated 24.12.2014 would be a normal water level prevalent in the lean season."

Having recorded the above statement of the MoEF officials, it has been directed that to that extent the office memorandum dated 24.12.2013 is explained and clarified and dealt by the in MoEF in accordance with law.

We however find that in the EC, the aforesaid clarification which was required to be made in terms of Himmat Singh's case, was not mentioned in condition No. 2 of the EC. SEIAA therefore, needs to and in so far as the EC which have already been granted under this clarification in the light of Himmat Singh's case and in all pending matters wherever EC is granted, this clarification would be put in place."

- i. In response to the above directives, all cases pertaining to Sand Mining, the mining plan to be submitted by Director, Geology & Mining should include details about annual replenishment of sand in the leased area and the normal water level prevalent in the lean season. The cases recommended by SEAC and under process in SEIAA will be considered only after the revised mining plan duly incorporating the additional chapters as directed above by the Hon'ble NGT is submitted by the PP and duly approved by the competent authority. The cases will be reappraised by SEAC on the basis of revised mining plan and in accordance with the directives of the Hon'ble NGT.
- ii. Copy of the Hon'ble NGT order in Appeal No. 53/2015 dtd. 06.01.2016 should be sent to SEAC for compliance in the cases being dealt at their level.

- iii. All cases of sand mining needs to be reviewed as per the directives of the Hon'ble NGT. A working mechanism has to be developed in consultation with SEAC. A meeting in this regard should be convened.






As per the above observation, on receipt of the EIA report, the case alongwith the file be sent back to SEAC for appraisal.

issued by the mining officer is of 1000 meter radius while it should be for 500 meter radius for stone query leases. Thus PP was asked to submit revised certificate mining officer within 15 days for further appraisal of the project.

PP has submitted the response to the above queries vides letter dated 17/12/15 attaching details of mines within 500 meters issued by the mining officer vide letter no. 1545 dated 26/11/2015 which was placed before the committee. After deliberations committee observed that there are 02 more mines operating or proposed within 500 meters around the said mine with total area of 07.202 ha including this mine. As per Tehsildar's certificate issued vides letter no. 114 dated 20/03/2015, the Chhattisgarh State Boundary is at 04 Kms distance. As the interstate boundary is 5.00 ha, it is category-A case. The committee recommended that the case may be sent back to SEIAA.

As per the Notification issued by MoEF&CC on 15.01.2016 Para 7 (k) the general condition shall not apply on Mining of Minor Minerals of category B2 (upto 25 ha. of mining lease area). In the light of the Notification the case may be returned to SEAC for re-appraisal.
