

After detailed discussion and recommendations of 256th SEAC meeting dtd. 02.01.2016, it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC.

- PP shall not start mining activity before execution of lease agreement.
- The depth of the pit shall not exceed 6m. at the end of lease period and not beyond that.



After detailed discussion and recommendations of 256th SEAC meeting dtd. 03.01.2016, it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC :-

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall not exceed 6m. at the end of lease period and not beyond that.
- (iii) Before commencing the mining activity, site demarcation should be done leaving 50 m. from the Nala as a "no mining zone". The demarcation should be done by the Revenue Officials in the presence of Mining Officer, Sagar.

The case was discussed in 256th SEAC meeting dated 03.01.2016 and it was reported that :-

"PP has submitted the revised EMP vide inward letter dated 30/12/2015 and the same was placed before the committee. On examination of the EMP it was observed that it's the same EMP which was presented by the PP in the 239th SEAC meeting dated 04/11/2015 and PP has not addressed the raised issues. Committee decided to reject this case as PP has not submitted the desired information."

PP has submitted a representation that in the revised EMP, modifications / additions were made. The case may be returned to SEAC for consideration of representation, if found relevant. Copy to PP.

Since the case pertains to sand mining and Hon'ble NGT (CZ) vide order dated 06.01.2016 has directed to appraise sand mining cases keeping in view the rate of annual replenishment. PP is hereby directed to resubmit the revised Mining Plan incorporating the replenishment data and water level during lean season.
