- (v) No dumps shall be permitted in the forest area.

Hence, Prior Environmental Clearance is granted for **Stone Mine** (Opencast Manual /Semi- Mechanized Method) in an area of 2.428 ha for production capacity of 41093 m³/year at Khasra no. 516 at Village – Akola, Tehsil - Kirnapur, District-Balaghat (MP) **for the lease period to** Shri Samrat Singh Saraswar S/o Shri Ashok Kumar Singh Saraswar, Samrat Singh, Circuit House Road, Balaghat (MP) - 481001.
