1. **Case No. – 2667/2015** Prior Environment Clearance for **Bila Granite Quarry (Opencast Semi Mechanized Method)** in an area of 4.973 ha., for production capacity of 10,000 cum/year at khasra no. 458/1/10 at Vill.-Bila, Teh.-Rajnagar, District-Chhatarpur (MP) by M/s Khajuraho Stone (India) Pvt. Ltd., through Shri Nitish Arjaria, 6th Km., Sagar Road, Dhadari, P.O. & District-Chhatarpur (M.P.)-471001.

After detailed discussion and recommendations of 232nd SEAC meeting dtd. 28.10.2015, it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC.

- PP shall not start mining activity before execution of lease agreement.
- The depth of the pit as per approved mining plan.
- Lease area shall be completely fenced.
- Plantation in three rows shall be done in 7.5m periphery of the mining lease area in the first year and 5800 trees to be planted in 2.873 ha with the end of lease period.
- Water to be lifted from nearby river and one tube well shall be drilled in first year to meet out water requirement for dust suppression, afforestation and domestic purpose.
- Garland Drain with appropriate settling tank and toe wall shall be developed all around the over burden dump.

- (vii) Grass to be planted on overburden dump for stabilisation.
- (viii) A road of approx. 2 km length to be developed by PP from mining site to Bila-Rajnagar.
- (ix) PP shall apply appropriate remedial measures to mitigate air, water and noise pollution.

Hence, Prior Environmental Clearance is granted for **Bila Granite Quarry (Opencast Semi Mechanized Method)** in an area of 4.973 ha., for production capacity of 10,000 cum/year at khasra no. 458/1/10 at Vill.-Bila, Teh.-Rajnagar, District-Chhatarpur (MP) **for the lease period to M/s Khajuraho Stone (India) Pvt. Ltd., through Shri Nitish Arjaria, 6th Km., Sagar Road, Dhadari, P.O. & District-Chhatarpur (M.P.)-471001.**

2. **Case No. – 723/2012** Prior Environment Clearance for **Lalpur Limestone Mine** (Opencast other than fully Mechanised Method) in an area of 17.471 ha., for production capacity of 0.20 MTPA (0.125 MTPA limestone & 0.075 MTPA reject stone) at khasra no. **(as per lease deed)** at Vill.-Lalpur, Teh.-Raghuraj nagar, District-Satna (MP) by Shri Kamendra Singh, Vill.-Lalpur, Post Siding, District-Satna (M.P.)-485001.

- (1) SEAC in its 249th meeting dtd. 14.12.2015 recommended the case for grant of prior EC with 13 special conditions.
- (2) The case was discussed in 279th SEIAA meeting dtd 08.01.2016 and it was recorded that

"After perusal of recommendations of 249th SEAC meeting dtd. 14.12.2015, it was decided to call PP for presentation."

- (3) Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in details.
- (4) It was noted that National Park/Sanctuary is not located within 10 km radius. Hence, the **General Condition is not attracted.**
- (5) Mining plan is approved by the IBM (vide letter no. MP /Satna /Limestone /M.Sch -67/ 14-15 dtd. 06.04.2015).
- (6) The proposed plantation program was examined and it was found that **19,600 trees** shall be planted in an area of **9.871 ha** with the end of lease period.
- (7) It was noted that the water requirement is 20 KLD (13 KLD for Dust Suppression+ 4.0 KLD for Green Belt + 3.0 for KLD Drinking), which shall be met from dug wells and tube wells.
- (8) It was noted that the Public Hearing was held on 19.06.2015 at Mining Parisar, Vill.-Lalpur, Teh.-Raghuraj nagar, District-Satna (M.P.) under the Chairmanship of Collector, Satna. The issues raised during public hearing were of general nature and nothing adverse was found regarding degradation of the environment.

- (9) After detailed discussions and perusal of recommendations of 249th SEAC meeting dtd. 14.12.2015, presentation made by the PP in SEIAA & SEAC, it **was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**
- (i) In western direction 50 m to be left as no mining zone from road towards the mining lease.
 - (ii) PP will construct a toe wall of 2 m height all around the overburden dumps to arrest flow of silt.
 - (iii) Plantation of grass shall be done on overburden dumps after mixing black cotton soil for their stabilization.
 - (iv) In view of transport of trucks with heavy load, PP will supplement fund under CSR activity to the concerned agency for strengthen and maintenance of the road.
 - (v) To control dust pollution during mining and transportation of the minerals water spray to be done 8 hourly and at least twice a day by adopting adequate mechanism for dust suppression.
 - (vi) A separate establishment with people facility of toilet, drinking water , First –aid, rest room etc. to be provide within lease area for ladies, children, visitors, doctors, etc.



(Opencast other than fully Mechanised Method) for Production Capacity of 0.20 MTPA (0.125 MTPA limestone & 0.075 MTPA reject stone) at Khasra Nos. **(as per lease deed)** at Vill.-Lalpur, Teh.-Raghuraj nagar, District-Satna (MP) by Shri Kamendra Singh, Vill.-Lalpur, Post Siding, District-Satna (M.P.)-485001.

3. **Case No. 3835/2015: Prior Environmental Clearance for Stone Quarry (Opencast Semi-Mechanized Method)** in an area of 2.00 ha. for production capacity of 25000 cum/year at Khasra No. 814/2 at Village-Bhilwaria, Tehsil-Shajapur, District-Shajapur (M.P.) by Shri Rakhab Chand Jain R/o Village-Agar Malwa, Tehsil & District-Agar Malwa (MP)-465001.

After detailed discussion of query response in 277th SEIAA meeting dtd. 06.01.2016 and recommendation of 248th SEAC meeting dtd. 12.12.2015, it was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall be as per the Approved Mining Plan.
- (iii) Before commencing the mining activity, site demarcation should be done leaving 100m. from National Highway and 50m. from the Village Road on west side as a "no mining zone". The demarcation should be done by the Revenue Officials in the presence of Mining Officer, Shajapur.
- (iv) No crusher shall be allowed within 500 m. from the road.

- (i) PP shall not start mining activity before execution of lease agreement.



After detailed discussion of query response in 247th SEIAA meeting dtd. 07.10.2015 and recommendation of 256th SEAC meeting dtd. 03.01.2016, RO, MPPCB has reported after the site visit that the local inhabitants have not given any complaint against the project and the local panchayat has also given a consent in this regard. It was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC


- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall be as per the Approved Mining Plan.
